SUBJECT : Reeder, Florence University.

1. The Ministry of Public Instruction has proposed for the Rectorship of Florence University, Professor Piero Calamandrei, professor there of administrative and civil law. He was the Rector during the gleam of hope until to 25 July 1943. I am not certain whether this name was given you before you went away or not.

2. Professor Calamandrei is now in Rome but is ready to come. I do not wish to send him, however, until there is function^a cause for his going.

3. The Directive giving the Universities to this subcommission has been amended, until the only power retained by the subcommission from the SCAG of the Army group and the Regional Commissioner is that of consenting to the Pro Rector. Fuller instructions will shortly be on the way to you in the form of a new directive from the Executive Commissioner, but meantime you may be advised that competence to appoint this candidate is yours (unless other arrangements have been made by the 8th Army, of which I have not been informed.) I hope he will be made Pro Rector and may shortly be required for the job.

1. On 6 October, File PE/139, the Provincial Commissioner of Pistoia addressed a letter to the Minister of Education stating that "in consultation with the proper authorities" he had named Prof. Stanghellini, Arturo, Provveditore in Pistoia and asked the Minister for approval.

2. Was this done in consultation with you or without your knowledge? (Just when the Provincial Commissioner considers the proper authorities in such a case is not clear.)

3. No confirmation by the Minister is necessary for an appointment made by a Provincial Commissioner on recommendation of the Education Officer in EC Territory.

4. If there is a misunderstanding about this matter I shall be glad to ask the Chief Commissioner to write to the SOAG Fifth Army to clarify procedures. Before doing so, I need the facts of the case.
