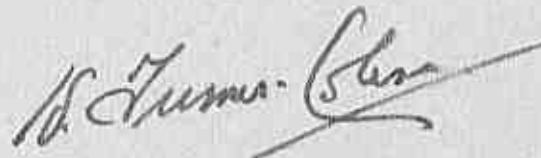

Subject: Grande Magistero Mauriziano

To : Director
Education Sub-Commission

1. The situation at the Grande Magistero Mauriziano is as follows:
 - a. Prof. Domenico Lanza was dismissed by the Republican Fascist Government 21 February 1944 and Dr. Donna was named Commissario of the Institution and remained in this position until 25 April 1945.
 - b. Dr. Donna was replaced by Dr. Coggiola who remained in the position until 25 May.
 - c. Dr. Lanza presented his case to the Provincial legal officer, Lt. Sabatini who ordered him reinstated without referring the case to this office or the Provveditorato.
 - d. Lt. Sabatini is temporarily out of the City and I have not been able to discuss this with him.
 - e. Prof. Lanza says that everything is now quite satisfactory.
 - f. The Provveditore says that since it is strictly a private school, he has only concerned himself with examinations.
2. Unless I find there are additional factors involved, I shall let the situation remain as it now exists.

Rome, 9 June 1945

Dear Admiral,

I have been told that a man who ~~does~~ not have all the requisites necessary for such a charge has been appointed to replace the commissioner appointed in Turin for the Grande Magistero Mauriziano.

Besides, the appointment has been made without the knowledge of the central authorities of the Grande Magistero which thus finds itself divided in two. The above mentioned authorities therefore suggest that it would be advisable to put back in this post the former director general of the Ordine Mauriziano, Cav. Gr. Gr. Domenico Lanza (Turin - via Pastrengo, 15) formerly dismissed by the republican fascists.

Knowing Mr. Lanza - he never belonged to the fascist party, his probity is above suspicion and his attitude of opposition never changed - I am most happy to submit his candidature to you, asking you to see whether it would be possible for him to be given back his charge.

SUBJECT : Pro-Rector, University of Torino.

TO : Regional Commissioner,
Piemonte Region
(Att: Regional Education Officer).

1. The Minister of Public Instruction submitted previously a list of suggestions for Pro-Rector of the University of Torino which was duly forwarded to you.

2. He now informs us that Prof. Alfredo Corti, whose name was among those suggested, has reached Rome from France and is available to go to Torino immediately on call. Corti is professor of comparative anatomy at the University of Torino, was sent away for political reasons (i.e., antifascism) and has been fighting in the ranks of the Partisans. He requests reinstatement as soon as possible.

3. The Minister feels that both for political reasons and because of his energy, Prof. Corti is by far the best candidate for the Pro-Rectorship.

4. Unless you have positive reasons for appointing another candidate, I suggest that you make Corti pro-rector of the University of Torino.

5. Please inform me of whatever action you take.
