PROCEDURE FOR HANDLING SCHEDAS

1. Examine schedas and on basis of data therein, note, in upper right hand corner, "suspended" or "confirmed", with date and initials of officer making decision. Write any pertinent comments on back.

2. In the case of persons confirmed, prepare two copies of the defascistization cards, (a) for the Provveditore, (b) for your file.

3. In the case of persons suspended, prepare three copies of defascistization cards, (a) for the Provveditore, (b) for your file, (c) for the Education Subcommittee.

4. All copies of defascistization cards will be arranged with the following break down:

I. Suspended A,B,C,D, etc., by individual provinces

1. Personnel of Provveditorato -- arranged alphabetically
2. Presidi.
3. Inspectors.
4. Directors.
5. Teachers.
6. Others.

II. Confirmed.

Same break down and arrangement

5. For all persons suspended, prepare a letter of suspension (6 copies) for the signature of the Provincial Commissioner, including in the one letter a list of all those suspended on a given date. Distribute as follows:

- a) Provincial Commissioner's file;
- b) Education Office file;
- c) to Prefect;
- d) to Intendenza finanza;
- e) Inspector or Preside concerned

f) Provveditore's file.

c,d,a,f) Provveditore agli Studi for distribution.

6. Provveditore will write individual letters of suspension to each person suspended.

7. Schedas will be submitted to Public Safety Officer for comment or approval.

8. When schedas are returned by Public Safety Officer, file, in Regional Education Office, alphabetically, regardless of category or province, but separately for approved and suspended personnel.

Si ignora se detto provvedimento sia dovuto a precisa disposizione del Ministero della Pubblica Istruzione, ma quant'anche fosse, sembra inopportuno che i suddetti insegnanti siano senz'altro privati dei loro assegni, anche in considerazione che se alcuni di essi venissero riassunti in qualità di supplenti percepirebbero un trattamento economico irrisorio essendo titolari di cattedre che comportano un numero limitatissimo di ore di lezione (come accade per gli insegnanti di scienze naturali presso Istituti Classici con nove ore di insegnamento settimanali).

Per questi motivi propongo che ai suddetti insegnanti sia conservato il trattamento economico di ruolo analogamente a quanto si pratica per il personale provvisoriamente sospeso avente in corso accertamenti per opurazione.

1. The matter of replacing the irregularly appointed preside of the R. Istituto Tecnico Industriale "Locatelli" in Udine, Ing. Salvatore Lo Curto, and his predecessor, the suspended preside, Ing. Gastone Conti, has been taken up with the Minister of Public Instruction.
2. The Minister definitely approves the invalidation of the prefect's appointment of Ing. Salvatore Lo Curto and says he should go back to his proper post, Cividale del Friuli.
3. The Minister recommends that if Gastone Conti cannot be returned to his post (which of course he cannot unless cleared by the epuration committee under G.O. 35) you proceed with the appointment of Ing. Carlo Gaggia.

SUBJECT : Teachers of Bolzano and Belluno.

23 June, 1945

TO : Regional Education Officer,
Venetian Region.

Reference: RXXI/ED/8.10 of 17 June.

1. Probably my letter of a few days ago has cleared up your problem regarding the teachers of Bolzano and Belluno. But lest it still leaves some doubt in your mind, let me answer specifically the questions in your last weekly report.
2. Teachers di ruolo removed by the Fascist Republican Government after June 1944 are to be returned to their normal posts. Incaricati appointed in the interim naturally will have to step aside. As far as I know, the Fascist Republicans held no concorsi for making teachers di ruolo; no all appointments must have been as incaricati. If you have knowledge of a Fascist Republican concorso and will send me exact information, I shall take steps toward having it annulled, or give you a ruling in regard to it - but I doubt there having been one.
3. Appointments by the GIN naturally have no legal status. Appointments or confirmations by GIN can only be as incaricati. A teacher incaricato has no rights to a post for which there is a teacher di ruolo.
4. The excess teachers in Trento should be returned to their normal sedi. The expulsions from Bolzano and Belluno by the Germans have no legal validity, and should be annulled.

1. During the early part of the week this office got the epuration committee of the University of Padova going in full swing. The committee has been chosen to represent all parties equally and so far everyone seems satisfied although the church has brought up the argument of Prof. Marquesi's being a communist. I intend the University to open for the 4th of July and am speeding it up with that objective in mind although Marquesi thinks that it will take at least until the end of July.

2. Bolzano and Belluno are the children of the region that are causing us the most trouble. Like Peck's Bad Boy they just won't let us be. I am awaiting instructions from Rome as to the procedures to follow in these German-speaking provinces. The question is acute. Many Italian professors and teachers had been sent away when the Germans took these provinces over and the constant stream of these professors into my office daily is causing me worry for lack of appropriate answers. I have told them that we are waiting for orders from Rome as to policy. To cite an example of just what I mean I would like to describe the case of a certain ex-President of an art school in Belluno. When the Germans took over the province they dismissed him and the Fascist Italian government sent him to work at the Ministry which was located in Padova. After the break-through of the allies this man returned to Belluno and discovered that the C.L.N. had placed another professor in his position. The Provveditore agrees with this man that he should be reinstated and now things will have to be straightened out with the C.L.N.

3. In Trento the question at hand is the excess amount of personnel available to the Provveditore. When the Germans expelled the Italian school teachers from the provinces of Bolzano and Belluno, they sent many of these teachers into the province of

Trento. The provveditore cannot assimilate them into his province with facility.

4. With the exceptions of the above mentioned problems everything in the region is going along nicely. Our English classes for civilian employees of this HQ have opened successfully and are going in full furor. The students are all very eager and it looks as if the project will be a successful one. The Brigadier is very much pleased. Our paper "The Lion of Venice" should be in circulation by the beginning of next week.
