Reference KWIII/B/1/3/98 of 14 June.

1. Authorisation for use of Allied paper for elementary school text books is only given for books to be used in 1945-6.
2. Text books for use in the elementary schools in 1945-6 must be approved by the Elementary Text Book Commission at the Ministry of Public Instruction and must conform to the new program for elementary schools.
3. Approvals by the Text Book Commission in Toscana were for books to be used in 1944-5, and are not valid for 1945-6/
4. Publishers should send sample copies or manuscripts to the Ministry of Public Instruction for approval by the Minister's Text Book Commission.
5. Any allotment of paper will have to wait until the books have been approved by the Minister's Commission.

6. This office warmly recommends that authorization be granted for the printing of the books as indicated above and asks to be authorized to release the 67 rolls of white Offset Paper necessary for their production.
