Ref. letter RVIII/69/A/44 of 18 Dec 44 re Protection of Ruined Monuments. In this letter the Regional Commissioner, Toscana Region refers to incidents reported to him by MFAA officer Toscana Region on 13 Dec. 44 (RVIII/31/MFAA/9.4) and in part reported to SCAO AMG 5 Army in monthly report of MFAA officer 30 Nov 44 (207/9), - on the basis of a report submitted 25 Nov 44 by the Superintendent of Monuments for Pisa.

Since these communications by the MFAA officers were addressed to the Regional Commission Toscana Region in the one case, and to the SCAO AMG 5 Army in the other, and only copies sent to this office, this Section was awaiting action by the parties to whom the reports were made before taking action itself.

In view of the letter of the Regional Commissioner Toscana Region RVIII/69/A/44 to HQ, AC above referred to it would seem that action is now necessary from HQ, AC.

The facts reported and to be acted on are as follows:

- a) On 24 Nov 44 negro troops entered the ruined church of S. Paolo Ripa d'Arno on which an "Off-Limits" sign signed by General Clark had been posted and where Italian laborers were doing repair jobs for the Superintendency of Monuments and took by force considerable material necessary for the reroofing of the church. They scoffed at the sign and beat up the Italian laborers performing their duties.
- b) About the same time negro troops of the 838 Engineering organisation demolished all that remained of the house of Giuseppe Mazzini and most of the convent of S. Antonio, and wished to take the church as well, to provide rubble for Pisa airfield. The Provincial Commissioner, AME Pisa, refused permission and the church was spared.

It would appear from the above that these matters be brought to the attention of PBS, - which heretofore have been of greatest assistance to MFAA in helping to do proper repairs in the Pisa Region, - and that some disciplinary action be taken in case a) above.

TO : Commanding General, PBS.

1. It is desired to draw your attention to the following incidents concerning ancient monuments in PISA, which have been reported to this Commission.

a. The MPAA Officer with AMG, TOSCANA Region has reported that on 24 Nov negro troops entered the ruined church of S. Paolo Ripa d'Arno (Piazza S. Paolo Ripa d'Arno; see A on plan attached), on which an Off-Limits sign carrying the signature of General Clark had been posted, and where Italian labourers directed by the Superintendent of Monuments were engaged in effecting repairs. These negro soldiers scoffed at the sign, beat up the Italian labourers, and removed by force a considerable amount of material necessary for the re-roofing of the church.

b. The same Officer reported that at about the same time negro troops of the 878 Engineering Unit demolished all that remained of the house of Giuseppe Mazzini (or Museo Mazziniano - Via Mazzini; see B on plan attached) and most of the Convent of S. Antonio (S. end of Via Mazzini; see C on plan attached). They were with difficulty restrained by the Provincial Commissioner of the Allied Military Government from demolishing the church as well. These negro troops were in search of rubble for use in connection with the reconstruction of an air-field at PISA.

2. You have in the past been extremely cooperative in assisting the protection of ancient monuments and fine arts. Your assistance is again asked in order that recurrences of this sort may be avoided.

3. Therefore it is requested:

- a. that PBS investigate these two incidents;
- b. that the persons involved be disciplined;
- c. that the Commanding General issue instructions to PBS units that AMG notices for the protection of monuments of historical, cultural or artistic significance will be obeyed.

Antonio (S. end of Via Mazzini; see C on plan attached). They were with difficulty restrained by the Provincial Commissioner of the Allied Military Government from demolishing the church as well. These negro troops were in search of rubble for use in connection with the reconstruction of an airfield at PISA.

2. You have in the past been extremely cooperative in assisting the protection of ancient monuments and fine arts. Your assistance is again asked in order that recurrences of this sort may be avoided.

3. Therefore it is requested:

- a. that PES investigate these two incidents;
- b. that the persons involved be disciplined;
- c. that the Commanding General issue instructions to PES units that AMG notices for the protection of monuments of historical, cultural or artistic significance will be obeyed.

SUBJECT: Report of Investigation of Ruined Monuments, Pisa.

TO : Commanding Officer, Army Air Force Engineer Command,  
MTC (Prov), APO 528.

1. Herewith is a report of investigation concerning ruined monuments at Pisa, Italy on or about 24 November 1944 involving the 838th Engineer Aviation Battalion.

2. Facts:

a. Attached letter, including Certificate of 1st Lt Alonzo C. De Costa, marked Inclosure 1, from Headquarters Allied Commission, Ref: 20084/2/A/MFAA, points out three complaints in the Pisa area as follows:

- (1) Negro troops removed material from the ruined church of San Paolo Ripa d'Arno. (See A on attached plan of Inclosure 1)
- (2) That the 838th Engineer Aviation Battalion demolished all that remained of the house of Giuseppe Mazzini. (See B on attached plan)
- (3) That the 838th Engineer Aviation Battalion was with difficulty restrained by the Provincial Commissioner of Allied Military Government from demolishing the church and convent of San Antonio. (See C on attached plan)

3. Finding:

a. No evidence can be found that the 838th Engineer Aviation Battalion troops entered the San Paolo Ripa d'Arno church to obtain material of any sort. See Exhibit A on policy of operations of 838th Engineer Aviation Battalion in the Pisa area. It is pointed out that a large number of colored troops are stationed in and around Pisa, Italy.

b. The house of Giuseppe Mazzini which had been previously demolished was used by the 838th Engineer Aviation Battalion for rubble since there was no marking on the buildings to show that it was of any historical importance or a monument of any sort. See Exhibits B, C and D from citizens of Pisa regarding the lack of markings on the buildings.


c. The statement that the 838th Engineer Aviation Battalion was with difficulty restrained from demolishing the church and convent of San Antonio can not be substantiated since the officer in charge of securing rubble in Pisa contacted Lt Colonel Walters of Allied Military Government, Pisa to determine if the rubble of the church could be used. See Exhibit E of Lt Colonel Walters' and Exhibit F of Captain Kesselbacher of the 838th Engineer Aviation Battalion.

4. Recommendations:

a. That no action be initiated against the 838th Engineer Aviation Battalion since the action taken by them in securing rubble in Pisa was in good order and proper steps were taken to safeguard the monuments of Pisa.

b. That units of this Command be advised again to safeguard Italian monuments and when in doubt to contact local Allied Military Government officers for release when rubble is desired.

c. That this investigation be returned thru channels to Headquarters Allied Commission for handling thru the claims section for any action they desire concerning the house of Giuseppe Mazzini which was in a demolished condition and used by the 838th Engineer Aviation Battalion for rubble since it was unmarked.



There were two other residences next to it and these were also demolished by bombs. At no time before the debris was removed did I see any kind of a sign on the Museo Mazziniano stating that it was a historical monument and was not to be touched. I swear that the above statements are the truth.



On or about 18 November 1944, I accompanied First Lieutenant Alonzo C. Decosta, Company "A" 838th Engineer Aviation Battalion, to the headquarters of the Allied Military Government in Pisa, Italy. We went to ask whether it would be permissible to haul rubble away from the site of a destroyed church at Q099645 (Italy 1:25000, Sheet 104-II S.E. Pisa). We talked to the Commanding Officer, Lieutenant Colonel Walters, and after explaining what we wanted and the poor condition of the buildings, Colonel Walters said that he would appreciate it if we did not remove rubble from any churches no matter how badly damaged, since a claim might be entered by the Italians if we did. We agreed at that time not to remove anything from the site and to the best of my knowledge nothing was removed.

It had been the policy in the 838th Engineer Aviation Battalion not to use rubble from any buildings, regardless of type, if the buildings could be repaired. This policy was explained by me to Lieutenant Decosta at the beginning of the job and to the best of my knowledge it was followed through out the work.

SUBJECT: Protection of Ruined Monuments, Etc.

TO : Commanding General, 121.

1. It is desired to draw your attention to the following incidents concerning ancient monuments in Italy, which have been reported to this Commission:

The 121st Officer with AMB, UMBRIA Region has reported that on 24 Nov negro troops entered the ruined church of S. Paolo Ripa d'Arno (Piazza S. Paolo Ripa d'Arno; see A on plan attached), on which an Offiziante sign carrying the signature of General Clark had been posted, and three Italian labourers directed by the Superintendent of Monuments were engaged in effecting repairs. These negro soldiers scoffed at the sign, beat up the Italian labourers, and removed by force a considerable amount of material necessary for the restoring of the church.

The same Officer reported that at about the same time negro troops of the 638 Engineering Unit demolished all that remained of the houses of Giuseppe Masini (for Museo Masini - Via Masini; see B on plan attached) and most of the Court of S. Antonio (S. off. of Via Masini; see C on plan attached). They were with difficulty restrained by the Provincial Commissioner of the Allied Military Government from demolishing the church as well. These negro troops were in search of rubble for use in connection with the reconstruction of an airfield at 121.

2. You have in the past been extremely cooperative in assisting the protection of ancient monuments and fine arts. Your assistance is again asked in order that occurrences of this sort may be avoided.

3. Therefore it is requested:

a. that PBS investigate these two incidents;

b. that the persons involved be disciplined;

c. that the Commanding General issue instructions to PBS units that no notice for the protection of monuments of historical, cultural or artistic significance will be

The NEPA Officer with AMB, BORDONE Region has reported that on 24 May negro troops entered the ruined church of S. Paolo Ripa d'Arno (Via S. Paolo Ripa d'Arno; see plan attached), on which an Official's sign carrying the signature of General Clark had been posted, and where Italian labourers directed by the Superintendent of Monuments were engaged in effecting repairs. The same Officer reported that at about the same time negro troops of the 838 Engineering Unit demolished all that remained of the house of Giuseppe Masini (or Museo Masiniano - Via Masini; see plan attached) and most of the Convent of S. Antonio (i.e. all of Via Masini; see plan attached). They were with difficulty restrained by the Provincial Commissioner of the Allied Military Government from demolishing the church as well. These negro troops were in search of rubble for use in connection with the reconstruction of an airfield at PISA.

2. You have in the past been extremely cooperative in assisting the protection of ancient monuments and fine arts. Your assistance is again asked in order that recurrence of this sort may be avoided.

3. Therefore it is requested:

- a. that you investigate these two incidents;
- b. that the persons involved be disciplined;
- c. that the Commanding General issue instructions to his units that all notices for the protection of monuments of historical, cultural or artistic significance will be obeyed.

Antonio, and wished to take the church as well, all to provide rubble for Pisa airfield. Provincial Commissioner, AMG Pisa, refused permission, and the church was spared.

2. Superintendent of Monuments, Pisa, stated in letter to Provincial Commissioner, and to undersigned, dated 25 Nov 44, that on the preceding day Negro troops entered the great church of S. Paolo a Ripa d'Arno and took by force considerable material, chiefly beams, necessary for the re-roofing of the church, beating up the Italian laborers. Copy of report attached.

3. It is believed that a solution of this problem would be found in the issuing of a directive by PDS forbidding interference with any monumental structure, particularly when repair work has already started. It is also suggested that PDS provide WFAA Officer with notices signed by authority of Commanding General, PDS, to be affixed at once to such structures, protecting them from any interference without knowledge and approval of WFAA Officer.
