SUBJECT: Captain G. R. Pinsent, 322046; GL (B)

TO : CSO, CA Section.

This officer served as a Monuments and Fine Arts officer in Italy from June 1944 to 30 September, during which time he worked in Lazio, in Florence City, and finally as Regional Fine Arts Officer in Emilia and Lombardia. Despite his age (62) and spells of ill-health, he was extremely active in all these appointments, covering wide territories in all weathers and conditions. In Florence he did exceptional work in connection with the clearance of the destroyed areas and with the problems of billeting and requisition, both of which difficult problems he handled with great tact and ability. His work, here and subsequently in Emilia and Lombardia, was characterized by the maximum of efficiency and the minimum of fuss. He handled difficult problems of Italian personnel with great diplomacy and got first-class results out of a very awkward team. There is no officer in this Subcommission who has done more consistently first-class work.

I have been closely connected with Captain Pinsent's work throughout; and I wish to put this appreciation of his work on record in the hope that an opportunity may arise to secure for it some recognition.

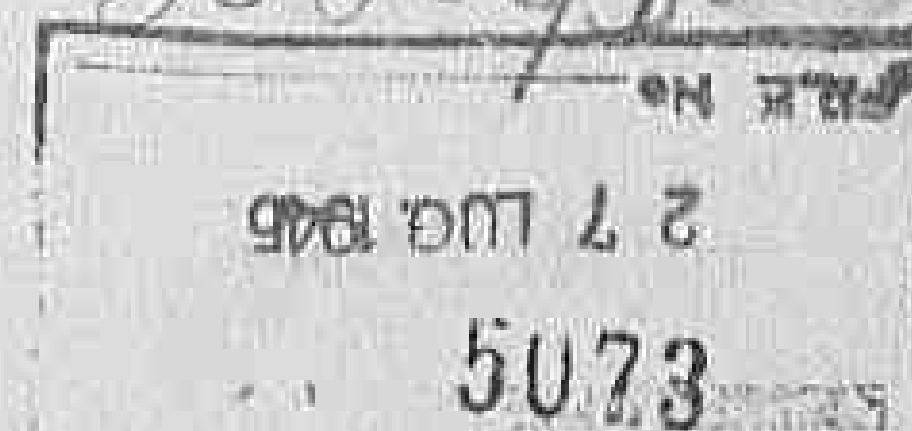

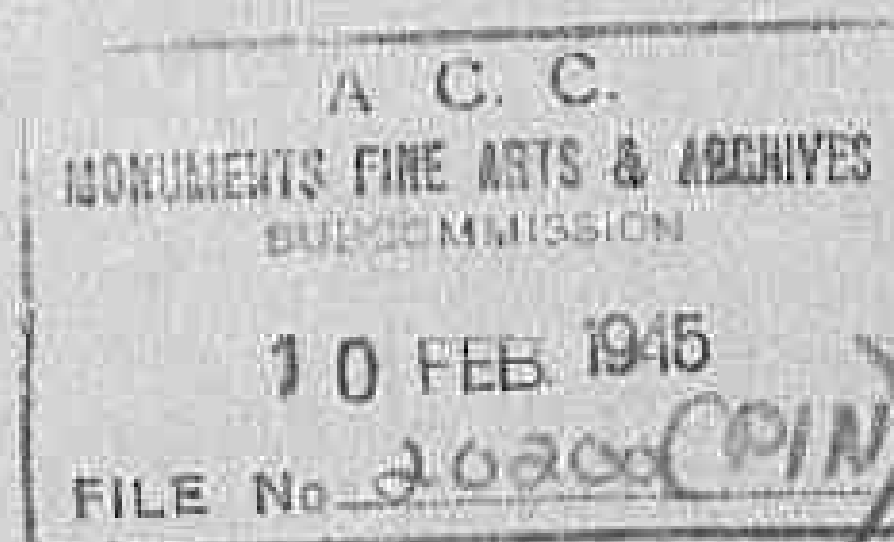
