You will recollect that if I had elected to return to England in April 1944 I should have got my Majority, but I preferred to stay with you and I don't regret it.

It is for these reasons that I am asking you or John to be good enough to adopt a suggestion made by yourself, which is to approach the Regional Commissioner confidentially in writing on the matter, giving if you are so disposed your support to favourable consideration on my behalf, or again to see Colonel Jones.

Liguria. Why this new assignment. I am so happy here and there is at least two months work to be done in this area which would be better accomplished with an Advisor on the spot than without one. I am hot on the treasures buried under rubble both of the National Museum and the Crypt of the Duomo and 61 Area, who are very cooperative so far, have just requisitioned for me the Palazzo Ferretti for their exhibit (if their condition allows) as well as other works of art to the troops and civilians. Area has even ^(ive) a ~~quantity~~ of their Headquarters in the Palazzo ex-Littorio for the

collection, storage and classification of material recovered from the Museum. Also there is a frightful problem of protecting the historical town or what remains of it (vide my February report) from the bulldozer and its human counterpart. Finally work outside Ancona and the fact that I must give a look over in Perugia and Terni cannot be ignored.

Surely there had already been assigned an Advisor for Liguria and isn't there one available from Tuscany? I couldn't possibly leave this Region yet, unless of course you insist.

My dear Colonel

I am so glad you have had a good trip and heartiest congratulations on your promotion. I really am completely recovered and feel fighting fit but not fit to fight.

Basil Marriott has also returned from sickness after a period of convalescence in the Gigli Villa. He feels much better.

We both are terrified at the news of your robust energy and so here are a few problems for you:

Abruzzi-Photographs. The sets which you have got - and which I did not see - were intended for Sheldon Pennoyer. Chierici brought the negatives and they were printed in Rome. Perhaps Sheldon would like all three sets. If not I should like one. As for the titles I suggest they be sent back to Chierici for the purpose and titled under particulars given by Sheldon.

Gradara Castle. I talked to Ernest about Signora Natale, the so-called owner of Gradara Castle near Pesaro, but in reality a "custodian" on Pacini's payroll, whose husband, a diplomat, is a cousin of Prime Minister Bonomi's private secretary. I am informed she is back in Rome. Her address can be given by the Director of the Belle Arti. It would save me a headache if she were told that so long as Gradara remains North of the Rear Army Control Line, she must not return to it. The Castle is State Property and there is no necessity for her to be there. Even when it comes under A.M.G. she should not return without the knowledge and permission of the Sub-Commission. At present Quetura, Rome, give her passes solicited by Bonomi's Secretary and these appear to be accepted by our people here. **1267**

Dear Dad

1. A word of warning to you, arising out of your recent reports and out of a meeting held here last week with the acting Director-General of Belle Arti.

2. The Italian central authorities are quite rightly worried lest expensive repair-projects should be undertaken without proper justification. A case in point is the authorization for the spending of a very large sum on the Cathedral at Messina without the safeguard of competent local advice and control. You will recall that the Director was very reluctant to allow you to interfere in that particular case and sure enough it is now being used (with justice) in criticism of the Sub-Commission.

3. We have agreed therefore that no major repair projects shall be undertaken without the added advice of the local Superintendent, or if he is not available, of the central Direction-General (through this HQ). This does not of course apply to urgent first-aid where time does not permit reference. In particular beware of designing clerics and at least get the Superintendent to take responsibility.

4. In the case of Foggia a closer perusal of my personal reports would have led you to a very different assessment of the relative value of monuments in that city:

a. The Chiesa del Calvario is important and has been subject of previous reports. Please refer to these.

b. S. Pasquale is of very secondary importance and I doubt if the Belle Arti will approve.

c. The Cathedral. Agreed that the roof should be repaired before the winter in view of the fire-damage; the pleas of the bishop are of no relevance to the problem and you must confine yourself to the assessment of monumental damage. Said

5. Please temper enthusiasm with discretion and meanwhile I shall be glad to hear:

- a. that you have contacted your superintendents
- b. advance word of any major projects, so that I can obtain comment.

6. I will see about Barberi.

Dear Sir,
Mr. John Swartz's days on your staff and advice as to write to you and ask whether you could possibly help to save some archaeological material which is in danger of being destroyed.

Before the war I have been excavating in Apulia, in the area of Manno-dera between Peschici and Vieste, on Monte Sargano, Prov. di Foggia. The excavation to which I have turned season work is not finished, but has already given valuable results, as it is the only one in which bronzes weapons and personal ornaments, as well as Apulian painted pottery have been found in a datable context. It covers the time from about 800 to 500 B.C. I am afraid that the excavation might be totally destroyed by treasure hunters in the mistaken idea that they might find gold or precious stones. Excavated reports about our finds has already arisen on Monte Sargano whilst I was still there. They will have given among the very poor and backward population. Excavations undertaken by them would, of course, ruin the site.

I was invited to make these excavations on behalf of the University of Rome by Prof. Ugoellini - Via Del Mellini 3, Roma-Montemare. He has my outstanding knowledge not only of Apulia but also of the whole of Italy's Adriatic coast.

I hope you will excuse my writing to you and ask for help concerning archaeological material when you may be engaged in much more urgent work.

Dear Major

I expect the communication which you have received about me from Perry have rather confused you as to my situation. I hope this letter delivered by Perry will clarify the situation. I am now out of hospital in Catania and have returned to Palermo to take Perry's place pending the receipt of new orders for my dispatch to England. Apart from being ordered "light duty" by the Doctor, I am fit at present for travel. A telegram has been sent from Region I telling A.C.C. Headquarters that I am out of hospital & asking for further instructions on being sent back to the U.K., and I have explained the situation to Lt. Colonel Hancock. When Perry delivers this letter to you, it is requested that you explain the above facts to the Officer in charge of G1, Lieut. Colonel Purgold.

It is quite true I did offer to stay on in Sicily if Higher Authority approved because ~~as~~ I wanted to see the end of this job; ~~max~~ As however the Italian Government has taken over, it would appear that the job here will automatically fizzle out judging by the contents of the Circular 1238 of the Italian Government dated 21st February 1944. As for reasons of health I am now fit for travel. If it is decided that no one is to replace me on my departure, I should be glad to have instructions as to the disposal of files.
