TO : Col. L.D. Densmore

1. Message from Liguria (Col. Jordan) intimated that by arrangement by Col. Densmore and Col. Hancock on 30 November Major Fischer remains in Liguria.

2. Orders were for Major Fischer to proceed immediately to Trieste where the Labour Officer strength is now reduced to one Lieutenant.

3. Major Albright had left Trieste some weeks ago, Captain Belsten was sent on 45 days leave to USA on 28 November without prior consultation with Labour Sub-Commission. AMB Venezia Giulia now considers the Labour representation, which at one time was strong, as now inadequate and Labour Sub-Commission agrees. The concentration of Labour work at Milan gave an opportunity of strengthening Venezia Giulia by sending Major Fischer. Labour Sub-Commission hopes you agree that he would be more useful in Trieste than in Genoa. There are no other officers available for Trieste.

3. Major Albright and Captain Bailey are being withdrawn for redeployment in accordance with the requirements of the American Army authorities.

4. To bring up the strength, Major Solduna (Br.) will report in about 10 days' time on his return from leave, when the strength will consist of 2 American Officers and 1 British Officer.

5. After considerable discussion between G-1 and Labour Sub-Commission both parties are agreed that these assignments are the best possible that can be made having regard to the necessity of appointing officers experienced in labour matters and having regard to available resources.

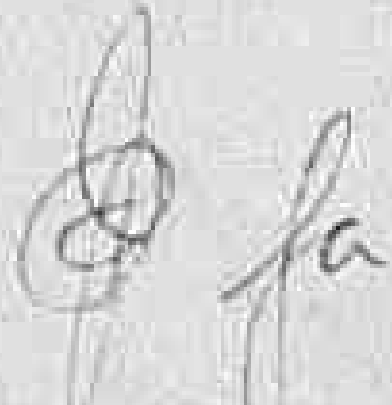
