SUBJECT: Promotions.

TO : G-1 (American)

1. A short time ago this Sub-Commission forwarded to you certain data reference T/S Alvaro B. Pirani (31359457) which was requested as a basis for possible promotion.

2. It is the desire of this Sub-Commission to earnestly support the promotion of this enlisted man.

3. T/S Pirani was assigned to this Sub-Commission in November 1943 for work in the Chief Clerk's office. Since September 1944 he has served as Chief Clerk in complete charge of a staff which at one time comprised as many as eighteen (18) Italian civilian employees. The office of the chief Clerk has been operated under his sole supervision since that time. The work of this office includes responsibility for the efficient handling, registration and filing of all incoming and outgoing documents, the proper maintenance of files and records, the supervision of a typist pool and a translators pool, the preparation of the Italian civilian payroll and the giving of assistance and information to persons making inquiries by telephone and in person. In addition, the Chief Clerk has the responsibility of security among Italian civilian employees with respect to the handling of classified documents. He has also assumed the responsibility of executing the necessary travel and assignment orders and the provision of transportation for members of the Sub-Commission. He has also acted as an interpreter and translator for officers of the Sub-Commission.

4. In the performance of his duties T/S Pirani has performed outstanding work in revising the filing system of this Sub-Commission and the development of an efficient and accurate registration system and in the training of Italian civilian personnel with particular respect to military needs and **2846** procedures.

5. T/S Pirani has performed the duties assigned to him with extraordinary patience, thoroughness and efficiency. He has demonstrated unusual resourcefulness in taking prompt action when appropriate occasions arose. He has served this Sub-Commission very usefully in maintaining excellent liaison with other organizations with which this Sub-Commission has had to deal.

6. His value to this Sub-Commission has been particularly enhanced

by reason of the turnover among officers of this headquarters during the past year. In assisting new officers he has proved invaluable by reason of his accurate knowledge of the work performed by the Sub-Commission and his ability to render historical background whenever necessary.

7. The enlisted man previously assigned to the position of Chief Clerk held the grade of sergeant.

8. It is strongly recommended that his promotion be favorably acted upon.

TO : Economic Section
Attention: Lt. Col. J. Bruce Thompson

1. This is in reference to Captain D. L. Botham (n), who until recently has been serving as Regional Labor Officer for the Southern Region, is currently earmarked for Austria but not as yet posted to 22 C.A. Unit, and who is now serving the AMG on T.D. assignment in Sicilia.

2. There is no Senior British Officer available in the Labor Sub-Commission who is empowered to make any recommendation for the outstanding performance of any British Officer. This Sub-Commission has been informed that such action should be taken by the Senior British Officer in the Economic Section based upon a recommendation from the Labor Sub-Commission.

3. The Labor Sub-Commission recommends that Captain Botham be promoted to the rank of a Major for the following reasons:

(a) Captain Botham joined the Labor Sub-Commission on 7 March 1944 and after a period of training in Headquarters was assigned to Region II. He became the Staff Labor Officer in Southern Region on or about 22 August 1944 where he has rendered outstanding performance.

(b) Part of Captain Botham's duty in Southern Region was to concern himself with the labor problems of the Allied Force Units in Mori, Taranto and Naples. When control of the territory passed to the Italian Government, with its consequent relaxation of restrictions over wage increases, Captain Botham was faced with the problem of attempting to keep Allied Forces wage scales and private industrial wages in balance so as not to react unfavorably to the Armed Forces. Being thoroughly familiar with control procedures which had been placed in operation by the Sub-Commission, Captain Botham, through his exercise of firm judgment and tact succeeded in executing a number of agreements in private industry which did much to not only keep private wages in balance with those being paid by the Allied Forces, but also resulted in the maintenance of labor peace in many industries which were vital to the continuance of the war effort. His reports on these various negotiations were always lucid and complete.

4. The Senior American Officer in this Sub-Commission would, without any hesitation, grade the work of Captain Botham as superior on all counts if he were grading him according to the United States Army rating schedule. He has proven himself to be a leader and a forceful staff adviser. He likes good organization and insists upon all the work coming under his direction being conducted in an orderly fashion. He is friendly and well liked by all of his associates.

5. If additional information is needed in support of this recommendation, in order to hasten Captain Botham's promotion to the rank of Major, this Sub-Commission will be only too glad to supply it.

SUBJECT: Information concerning the promotion
of Captain Alfred L. Dorf.TO : Director, Labour Sub-Commission
Headquarters Allied Commission.

There herewith follows a brief review of my military history.

1. I received my Commission of 2nd Lieutenant M.C. in the Officers Reserve Corps, United States Army in July 1937. Fulfilling my obligation to the service excellently and establishing therefore a worthy record, obtainable at Washington D.C. I participated in the First Defense Maneuvers in July 1940 held at New York.

2. In November, 1940, I was ordered to active duty, reporting on 15 December, 1940 for duty at Indiantown Gap, Pa., with the rank of 1st Lieut.. At that time, I held a certificate of capacity for Captain and credited with most of the No. 50 series, Correspondence Course for the rank of Major.

3. Some of the ~~positions~~ which I have held in the Army were Post Utility (Engineer) Officer; Ass't Q.M. Property and Supply Officer; Ass't Reclamation and Salvage Officer; Trial Judge Advocate and Defense Counsel; Ass't Adjutant; Personnel Processing Officer; Ass't Ordnance Officer; Motor Maintenance Officer; Ass't Quartermaster; Ass't (G-4) Director of Supply; Battalion Commander; Company (Officer) Commander and Ship Commander. In all of these assignments, calling for higher rank and grade, I have performed efficiently and most satisfactorily. I have carried the full burden of responsibility and have been given command and leadership because of demonstrated capabilities, ability, and experience. My record will definitely show that my work has always been most satisfactory by its high ratings of superior, excellent, etc...

4. Soon after the usual trial, observation and determination period, (January, 1941) my superior and commanding officers recommended my promotion to Captaincy. However, due to the constant changes in War Dept. and Corps. (Service Command) Areas did not receive the said Captaincy promotion until 1 February, 1942.

5. Beginning about July, 1942, my superior officers initiated several recommendations for my promotion to Major. These requests were made to fill appropriate vacancies and accord me the rank and position I was so ably and efficiently performing. Attached hereto are the available copies of a few recommendations. The replies to these several requests were indorsed, No Allotments, new Tables of Organization, Revised Functional Charts and Schedules, and the old familiar Frozen promotions.

6. In the further hope of getting any promotion, my superior and commanding officers (in 1942-45) assigned, reassigned and transferred me from one branch of Service to another (Q.M.C. to Ord. Dept., to Adj. Gen., etc.), but to no avail. The reasons given then, was "no vacancies", due to change of policy and influx of over aged officers. My Commanding officer then sent me to C. and G.S. School, which required the highest possible entrance prerequisites, in the further hope of obtaining my promotion, but again without success.

7. I have attended and satisfactorily passed and graduated the best Army Service and Graduate Schools, as follows:

- a. Quartermaster School, Schykill Arsenal, Philadelphia, Pa., June, 1941;
- b. Robabird Q.M.C. (Ordnance Dept.) Motor Transport School, Baltimore, Md., January, 1942;
- c. Command and General Staff School, Fort Leavenworth, Kan., September, 1942;
- d. Counter Intelligence Corps, Advanced School, Chicago, Ill., May, 1943;

and, had I received my Majority, as so often earned, would no doubt have added the Army and Navy Staff College.

8. In early March, 1943, Headquarters 3rd (Corps Area) Service Command, Baltimore, Md., in a cablegram (Copy attached) requested my Commanding Officer to furnish two ranking Captains that were eligible for promotion and capable of performing special work at the then new and coming Displacement Station, Shensong, Pa. I was selected as the ranking Captain ^{Q.M.C.} ~~Q.M.C.~~ the

one most eligible for promotion and thusly, transferred to Shengen, Pa. on 15 March, 1943.

9. After the required month's trial period recommendations were made and accordingly were forwarded to the Commanding Officer for approval. However, before the Commander could indorse and send it on to Service Command Headquarters for processing, I was ordered by War Department to attend the Advanced Intelligence School at Chicago. Since it was understood (at that time) that I would not return to my proper station the Commander did not forward the approved papers (expressing no desire to grant a promotion to anyone formerly of his staff. Upon my return to Shengen from the C.I.C. School (July, 1943), a new Commanding Officer was installed who "froze" all promotions, notwithstanding the several recommendations (copies attached) and requests in my favour.

10. After 3 years of excellent and continuous army service (about August 1st 1943) I was declared surplus at Shengen, Pa., under a new Table of Organization. I then became a "replacement" officer and hence not eligible for promotion (until permanently assigned). About September 2, 1943, I was shipped overseas to the ATOMSA (then MATOUSA) Area, and a tour of all replacement centers and depots in North Africa, Sicily and Italy began. After applying and resupplying to all and sundry for work and assignments (about February, 1944) I received temporary assignments with Special Military Police; 6723rd Q.M. Trucking Group, with action at Ansio and other places; G-4 P.B.S.; and J.A. P.B.S.

11. A short review of my civilian activities are related.

I am a lawyer, admitted (1930) to practice as a member of the District of Columbia Bar, North Carolina Bar, Virginia Bar, the several Federal Courts and of the United States Supreme Court. A graduate of National University, Washington, D.C. with the degrees of LLB, LLM, and MPL. I am credited with several years post graduate collegiate work in Economics, Accounting, Languages and Labor Law done at Catholic University, American University and other colleges in Washington, D.C. A member of the District of Columbia Bar Association and the American Bar Association. I have been employed as Assistant Executive Officer and Personnel Advisor by at least two large corporations (United Realty Corp. N.Y. (1925) and Sears Roebuck Home Constr. Div. (1926) Wash.D.C.) in matters of personnel, administration and building management. I have been employed as Attorney in the Solicitor's Office, U.S.

Dept. of Agriculture, Washington, D.C. (1933) with the trial and investigation of numerous cases involving enforcement of Federal laws throughout the United States. I have been in the private practice of general law and for several years General Legal Counsel of the Agriculture Dept. Credit Union (Banking) and the Dept. of Agriculture's Welfare Association (Social Insurance) in Washington, D.C. I enjoy an enviable reputation in the field of law where I have been exceedingly active up to and including my active commissioned service. I have had wide and generous experience in matters concerning labour and management both in the academic and professional fields.

12. In early April, 1944, I was finally and permanently assigned to Headquarters, Allied Control Commission, Labor Sub-Commission. Recommended by Stevens to HQ. A.C.C. because of the highly specialised and diversified professional qualifications. I became eligible for promotion on July 1944, and a recommendation for my promotion was forwarded with endorsement of approval and was then, as oft repeated, greeted with "Frozen promotions". Then began a series of resubmissions of requests, which more than met all the prerequisites and requirements. Amongst these recommendations were endorsements of Brig. General O'Dwyer, Colonel Adams and Col. Dennisore. As late as 8 November, 1944 I was given a definite reply that my name would be submitted to the Promotion Board. To this date, six months have passed, no open facedifilous excuses have been made, several promotion lists have been published and still no promotion.

13. It is definitely more than consequences, coincidences, mischance or being a forgotten soldier to be bypassed in rank by junior officers, who have served under me; passed by enlisted men who have served under me, and have all of my fellow and associate officers receive promotions, some officers to the extent of receiving two promotions. I am not a laggard, brawd, drunkard, 'snafu' character, or have I been court martialed. I have been recommended for the Legion of Merit (copy attached) which, like promotion and other things in the Army, I never received. Can find countless unsolicited letters commending highly of my work but it would only tend to clutter up this brief review.

14. I have been in grade of Captain for more than thirty nine (39) months, all in time of war. As related, I have held high and most responsible positions with Superior and Excellent ratings. I have more than unconditionally met all of the qualifications and prerequisites for promotion. I have served honorably faithfully during all of my four and half (4 1/2) years of active military duty.
