1. Reference LSC/222 of 24th July 1945.
2. It is understood that the general question of the rates of wages payable to railway workers, and also the question of the grant of an "anticipo" to the workers in Bari pending the solution of the problem of the authorization of a Liberation bonus, was considered at the meetings of the Council of Ministers held in Rome on Friday and Saturday last, the 27th and 28th July 1945.
3. It was resolved that full consideration of these matters cannot be accorded until such time as a new Minister of the Treasury was appointed.
4. The position at Bari is that the strike which was threatened to take place on the 17th July was averted, but a further strike is now scheduled to take place on the 15th August if no remedial action is taken by the Government in the meantime.

1. With reference to your Tn.A/F/68/44 of 24 July, and telephonic conversation this afternoon.

2. It has been ascertained from the Joint Secretary of the CGIL that that organization has been in communication with the President of the Camera del Lavoro in Bari.

3. It now appears that the problem assumes two aspects:

(a) The general question of the increase in wage rates of railway employees throughout Italy, and

(b) The demand of the Bari workers for a liberation bonus similar to that awarded to workers in Northern Italy.

4. The Joint Secretary of the CGIL agrees that (a) above is a national question and can only be dealt with on national lines. In regard to (b), he is pressing the Minister of Transport La Malfa to endeavor to arrange for the granting of an immediate anticipo of 2,000 lire pending consideration of the question of the award of a liberation bonus.

5. These points are to be considered at the meeting of the Council of Ministers to be held on Friday, 27 July 1945.

6. In the meantime the President of the Camera del Lavoro in Bari has assured the Joint Secretary of the CGIL that he will use every endeavor to avert a strike in view of the foregoing arrangements, and will keep in constant touch, reporting by cable or telephone as is necessary on any developments in the situation.

2. The General Headquarters of the Labourers' Unions, contacted in the matter, will try to do its best to avoid the strike.
3. As to the economic increases asked for by the Bari Compartimento personnel, the question can be examined later on, as this matter concerns ALL the Government employees.

The following report concerns the trouble of personnel in Bari Compartimento.

1. On 16 July 1945 a telephone call from Capo Compartimento at Bari reported that the operating personnel in that Compartimento were threatening to strike if the I.S.R. Administration, within the maximum term of two days, would not grant an adequate indemnity, such as to enable them to meet their familiar expenses.

Identical report was received also from Prefetto at Bari.

2. On the same date, 16 July, the section representative of Railwaymen Syndicate at Fogia wired that the personnel in that locality were seriously agitated because of their poor economical conditions and they asked for urgent economical improvements to be granted anyway. Previously, on 20 June, the personnel of railway plants at Fogia had discontinued their work for some two hours, to protest against the inadequate economical treatment, and they had started again to work only when the Prefetto promised to take steps with the concerned authorities.

3. With reference to the above situation, on 18 July a wire was sent to the Capo Compartimento at Bari, instructing him to induce the personnel to continue their job and to inform them that a Commission, consisting of an officer of the Labour Sub Commission, A.C., and of an official of I.S.R. General Direction, would call at Bari as soon as possible to examine the situation on the spot. **6109**

4. The morning of 21 July, at 0930, a meeting was held in Bari Capo Compartimento's office, under the presidency of Major Small of

some section and category representatives of personnel at Bari, Poggia, Taranto, Brindisi, etc.

5. Dott. Papa reported that, with the present salary, the personnel are unable to meet the most elementary needs, and he asked that the salaries be increased with an amount - to be paid under any title - of lire 4000 per month.

He pointed out that, should such request be not met within Wednesday 25 July, he could not assure that the personnel continue their job.

6. From investigations it resulted that:

According to agreements between Prefetto and Camera del Lavoro, the daily pay for a labourer belonging to a private industry has been fixed, effective 18 June 1945, to be of lire 250, including the presence and high cost of living indemnities. Besides, the following daily familiar fees are being paid:

Lire II,50 for each parent living with the labourer

" 14 for the wife

" 13 for each child

An I.S.R. labourer, with wife and two kindreds, residing at Bari, gets the monthly net salary of some lire 6.500, that is some lire 217 per day, including the familiar indemnity. If the same labourer was residing at Poggia, he should get some lire 5.800 per month, that is lire 193 per day, including the familiar indemnity. **6108**

7. Although a certain difference of economical treatment between State and private labour may be justified, as the job of private labourers cannot be continuous, however such difference could be reduced.

The Italian Railwaymen Syndicate pointed out several times that the economical situation of I.S.R. employees cannot be met any longer; the I.S.R. Administration tried to explain that the serious deficit of the Italian budget does not allow to meet further expenses. ./.

The I.S.R. personnel themselves don't ask for increases of salary, but, most of all, they ask for shoes and clothing to be purchased at a reasonable cost, according to their economical possibilities.

Of course, any increase of salary is of no use if shoes and clothing, essential to live and work, are not available on the market.

I suggest that, rather than salary increases, we ought to allocate more quantities of shoes and clothing, even salvage items, as it has been done in the past.

Furthermore, it is to be considered that, should the railwaymen's salary be increased, the same economical measure ought to be taken on behalf of all the State employees.

2. It is understood that Potti, Italian Minister of Labor reported the position in regard to the threatened strike of railway workers to the Council of Ministers at the Council meeting held at 17.30 hours on Monday 23 July 1945.

3. As the question of rates of wages payable to railway workers is one that affects the whole of Italy and cannot be dealt with in the light of the position at Bari alone, it is understood that it was decided that the matter should be considered by the Council of Ministers at the earliest opportunity, possibly at the next meeting on Friday next, the 27th July 1945.

4. In the meantime the headquarters representatives of the Confederazione Generale del Lavoro undertook to do what they could with the view to averting the threatened strike at Bari.

SUBJECT: Threatened Strike of ISR Workers in Bari Area.

TO : Labor Sub-Commission

1. On 20 July 1945 I proceeded to Bari accompanied by Ing. Palmerio of the Italian State Railways to confer with the workers in that compartoamento on the subject of increased wages. Workers had given notice of the strike for 19 July but had agreed to continue work pending discussion of their demands with Dr. palmerio and me. On 21 July we met with the head of the ISR for the compartoamento and with the representatives of the workers. The workers have been agitating for wage increase for some months and had presented demands to ISR headquarters. Ten days before the meeting there had been a three hour strike of workers in Foggia. During the meeting it became apparent that the workers were highly agitated and with considerable justice. Railway workers are receiving only one-third to one-half the wages received by private industry workers and these private industry workers include those working for civilian contractors actually doing work on the railroad. We, therefore, have the position of a railway worker in Foggia receiving 5800 lire per month while the worker of the private contractor doing the same work on the same railroad receives 400 lire per day. It is recognized that railway workers enjoy certain advantages including permanent employment and pension rights, but the discrepancy in wages is nevertheless far too great.

2. Ing. palmerio agreed that the demands of the railway workers for a monthly increase in all grades of 4000 lire per month were not unreasonably high. The ISR have been repeatedly advised of the situation and, in turn, had requested increases for the railway workers, but have been able to get no action from the Italian Ministry of Finance.

3. It is believed that the situation is critical, that the workers are entitled to an increase and that work stoppage will result if no increase is granted in the immediate future. The workers realize that military personnel will probably take over limited operation of the railways in event of a strike and that the workers' position would not be improved by a strike, but they have become so agitated over their low rates of pay that the situation is getting beyond control of the workers own union representative.

4. It is recommended that the Italian Government be urged to grant an immediate anticipation of 3000 lire per month to all railway workers in the compartimento pending an overall adjustment of governmental salaries in Italian Government territory.

THE REPORT
VISIT TO COASTAL RAILWAY BARI & 20 TO 21 JULY
1943 BY MR. PALERMO.

I arrived at Bari at 19.00 hours on 20 July 43 and I called on the Capo Consigliere di Caccia. The head of the Local branch of the Union was also present. I explained the purpose of the visit of Major Zay and myself to Bari and we arranged for a meeting two days later at 09.00 hours to be held in the offices of the Opere Comunali, o.

The meeting started at 09.30 hours on 21 July 43:

Chairman: Major Small, Labour Sub-Commission, A.C.

Present: Ing. Carone, Capo Comitamento.

Ing. Palomino, I.S.R. Rome.

Dr. Pape, Head of Bari Branch of the

Railway Unions,
Section Chairs of the Union Transbari,
Foggia, Taranto, Brindisi etc.

Dr. Pape was asked to explain the reasons of the unrest among the railway employees. He explained that the railway employees are no longer in a position to go on with their work, because they are insufficiently insuficient to cover their daily needs. He said that he personally tried to keep a friendly atmosphere among the railway employees, but under the present circumstances he thought that something should be done at once because otherwise a strike could not well be avoided. He pointed out that the corresponding classes of workers in private industry, on account of present increases, have a better rate of pay (the latter operation as from 10 June 43).

Facts elicited by Ing. Palomino were as follows:-

An unskilled labourer with wife and two children in industry receives a total daily pay of 333 Lire and the corresponding I.S.R. employee at Bari draws monthly 6,500 Lire and at Naples 5,700 Lire.

Contracts between I.S.R. and Civil Contractors pay 20 lire & 25 lire or lire 40.00 per hour, which amounts to about 100 lire a day for 8 hours work.

The discrepancies appeared evident to Ing. Palomino. Under small also thought that a better treatment of I.S.R. employees was necessary and he promised that he would do his best to procure the amendment of the I.S.R. employees. The main consideration was that the work had to go on without interruption because the running of the railways was indispensable from the Allied point of view.

Dr. Pape declared that the I.S.R. employees in the Bari Comitamento were earning for a monthly flat income of 4,000 lire for all families. He was willing to wait until Wednesday for a positive reply; otherwise he could

Dr. Rose was asked to express his impressions of the present status of the railway employees. He explained that the railway employees are no longer in a position to do all their work, because they are continually insufficient to cover their daily needs. He said that he personally tried to keep a friendly atmosphere among the railway employees, but under the present circumstances he thought that something should be done at once because otherwise a strike could not well be avoided. He pointed out that the corresponding classes of workers in private industry, on account of recent increases, have a higher rate of pay (per hour) operation as from 12 June 1945.

Facts elicited by Ing. Pimerio were as follows:-

Dr. Pimerio labourer wife and two children in industry received a total daily pay of 3,800 lire and the corresponding I.S.R. employee at Bellinzona monthly 6,500 lire and at Novate 5,800 lire.

Contracts between I.S.R. and C.I.T.I. Contractors now provide for a payment of lire 49.80 per hour, which amounts to about 1,000 lire a day for 8 hours work.

The discussions concerned stricten to Ing. Falencio. Major small also thought that a better treatment of I.S.R. employees was necessary and he promised that he would do his best in trying to represent the demands of the I.S.R. employees. The main consideration was that the war had to go on without interruption because the running of the railways was indispensable from the Allied point of view.

Dr. Rose declared that the I.S.R. employees in the Rail Compartimento were asking for a monthly flat increase of 4,000 lire for all classes. He was willing to wait until Friday for a positive reply, otherwise he could take no responsibility for the operation of the railroads during this time.

The meeting ended at 11.15 hours.

NOTE. In I.S.R. Pimerio's opinion an increase of 3,000 lire per month, perhaps even less, might meet the demands of the railway employees if given at once. It is realised that whatever increase is given must be given to all I.S.R. employees in Italy, the present ~~not~~ pay being considered insufficient. He thought there was a case for an immediate temporary grant to meet the existing situation, subject to the whole question of all railwaymen's wages in Italy being brought under review.
