The increases, as outlined in correspondence, are not undaty out of line with allowances payable to civilians employed by the Allied Forces in Italy (vide Establishment Memo No. 6) which provides in the case of a Linesman, whose daily rate of remmeration is L. 202, and who for an absence from the normal place of duty and home may: (a) in the absence of service accommodation and rations, be paid a subsistance allowance for each full days absence of 24 hours of L. 175. (b) for absences of more than ten but less than 24 hours which involves the procurement of meals only an allowance of L. 35 may be paid for each mean, and (c) for absence involving procurement of sleeping accommodation by the worker at his our expense L. 70 may be paid in addition to any allowances payable under (a) above. No allowances are however payable under (b) above if rations in kind are provided or under (c) above if quarters are provided. 3.
