TO : HQ. Allied Commission
(Attn. Labour Sub-Commission)

1. Confirming this morning's telephone message (Director Labour Sub-Commission and this Executive Officer) Indennità di pane is now being paid in AMG territory of this Region.
2. This, in effect, appears to produce a situation which is contrary to AFHQ Administrative Memorandum No 5 dated 31 January in which it is forbidden to pay an amount exceeding the Allied Force daily maximum.
3. It is understood that, the Italian Decree having been implemented, employees have the legal claim to the Indennità so that it must be paid. It is further understood that the next move, if any, must be from AFHQ on the wage scales for Allied Forces.
4. Provincial Commissioner Perugia is promulgating the decree on 13 March.

For the Regional Commissioner:

2. This, in effect, appears to produce a situation which is contrary to AFHQ Administrative Memorandum No 5 dated 31 January in which it is forbidden to pay an amount exceeding the Allied Force daily maximum.
