P YREPORT ON PANTELLERIA

1. Public Works program - (1) nothing done yet except to clean the streets.
 (2) roads on South & SE of island dangerous due to rocks and material having rolled down from the sides.
 (3) no hospital fit for work.
 (a) the present location cleared would liberate houses for the people.
 (b) a place possible for the hospital in old Naval barracks after repair.
 (4) no school.
 (5) no church - (church walls appear not too bad - a move in right direction to repair it).
 (6) no municiple.
 (7) Port must be cleared up as it is dangerous now in bad weather.

2. This comune not on list of "War-Damaged." It is 95% at least destroyed.

3. Cooperation from prefect and genio civile of Trapani does not exist. It is time that one of them actually saw the conditions on the island. There is at least one firm on the island that can do the public works program and there were enough men as labourers. There is no need for outsiders.

4. COMMUNICATIONS

A ship, the "Lampedusa" or another one, is needed at once. Its non-arrival is seriously affecting the allegiance of the islanders to Italy. It is nearly impossible now to travel on anything like a schedule between Sicily and Pantelleria and there is no allowance made for passengers on the fishing schooners, the only present means of communication. An Italian naval boat is supposed to do runs 3 times a month but once a month is its best average to date.

A plane service weekly Malta-Lampedusa-Pantelleria-Palermo should be possible

5. SUPPLIES

Glass, cement, lime and roofing materials are needed at once. Salts, is the most necessary material next to food on the island. ³⁰⁰⁰ Everything runs on it - water, transportation, electricity, hospital. A greater quantity needed. (see para 7 (a)).

Boots & leather, clothing or clothing materials are requested but not at the prices prevalent in Sicily.

6. FINANCIAL

Sussidio has been paid to many foreigners here without homes and hence the money allowed them is not enough.

The workers do not get the "cost of living" bonus that is normally given. Even AMO employees do not get this.

7. GENERAL

(a) Why can Pantelleria not get some of the diesel oil at Ragusa? They can send 200 bbls. by schooner and four return trips with 50 full bals. each trip and they have it, enough for electricity for nearly all winter.

(b) AMO mail arrangement to be made through Italian Navy at Trapani.

(c) Salvage work on port should be started at once.

(d) What is the status of war material left by, or taken from Italian forces on Pantelleria?

REPORT ON LAMPEDUSA

1. This island has been neglected and much building material which was on the island has been removed or wasted by a former administration. At present cement or lime, and roofing materials are needed, together with glass. There are many large buildings with walls standing and untouched by bombing, etc. these were partly completed barracks, etc. With roofing and glass, they would house many people.
2. A church is needed but one of these buildings could be adapted. There is no place for nuns, a necessity, apparently, for the children who at present are running wild.
3. Communications here are as for Pantelleria. The island tends to lean to Malta.
4. Doctor wants to stop traffic to Malta if more cases of bubonic plague are reported.
5. Food was coming to the island in bad condition and representing the culled material from Agrigento. This has now improved due to the intervention of high commissioner.
6. The firm of Consiglio Vincenzo of Porto Empedocle have a claim for about 2,000,000 lire which is the cost of transportation of food from Agrigento to Lampedusa. This should be looked into by the high commissioner's office at once.
7. The fish canners have a great problem as follows:-
 - (a) An order from the high commissioner makes them set aside 20% of their production for Sicily and Italy at a price of 280 lire/kg.
 - (b) The oil costs 300 lire/litre because although they had authority from High Commissioner to take oil from Sicily they were not given the oil from the ammasso.
 - (c) The cost of fish 130 lire kg.; 2 Kg. fresh give 1 Kg. ³⁰⁰⁰ ~~dashed~~: high cost of oil; result is that the price should be (in their figures) 500 lire/kg.
8. Coal or wood for the winter is the great concern of the authorities now as winter approaches. It is possible that Pantelleria and Lampedusa could come to a mutual agreement on that.
9. Medical supplies are urgently needed on the island and, although asked for several months, none has arrived. A list of the needs is attached to this report.
10. Two years ago a number of mules were taken to Malta from the island and the owners have not yet been paid. Since the Maltese authorities have paid the Italian Government -- may the owners now be reimbursed?
11. There is much salvageable material on the island, i.e. tyres, motors, car and truck bodies, all of which are useless to the people of Lampedusa, but could be of invaluable assistance to Sicily.
There are 4 vessels sunk in the harbour and one of them is a tugboat, not very badly damaged. All of these could be salvaged. /s/ W.J. MacCallum





1. In the early part of 1944 the Director of the Commerce Sub-Commission visited Sicily and requested that certain salaries and travelling expenses be paid to the Citrus Fruit Inspecting Staff of the Export Division. A formal request by the Director of that Division, supported by the Regional Commissioner, was made on the 17 June 44, to the Labour Division - a copy of which is attached for your information.
2. You will notice, inter alia, that a Travelling Allowance of Lire 400 per day of 24 hours and Lire 200 per day of 12 hours was requested. Approval was given by the Regional Labour Officer in concurrence with the Allied Force Local Resources (Sicilian) Board in July 1944. 2603
3. AFHQ Administrative Memorandum No 65 which authorises rates of subsistence allowance has now been issued from which it will be seen that the allowances are considerably lower than those quoted in para 2.
4. May I be informed, please, whether the Citrus Fruit Inspecting Staff, of which there are now only two employees, may continue to be paid travelling expenses at the original rates, or whether it will be necessary to conform to those laid down in Administrative Memorandum No 65.
5. It should be pointed out that these inspectors are experts in the Citrus Fruit Trade, and upon their decisions depends largely the success or otherwise of the export programme.
6. It is recommended that as a special concession the original rates be allowed to remain in force and I shall be grateful to have your decision.

1. It is requested that a decision may please be made regarding the salaries and travelling allowances payable to the Citrus Fruit Inspecting Staff of the Export Division, Region I.

2. This Staff is not actually AOC clerical Staff, but individuals specially employed because of their specialized knowledge (for which no category exists) on which depends the success of Foreign Exports of Citrus Fruits, their by products etc. 3002

It is submitted that these wages etc should be debited to U.K. U.S.A. etc against Foreign Trade Export Expenses (as is the case of stevedoring) and not against AOC clerical Staff.

3. Colonel NVAWS, Director Industry and Commerce Sub Commission, instructed the undersigned to submit to the Regional Commissioner a request for authority to increase specific salaries as under:

These travelling allowances to be applicable only when the individual is on tour out of his regular ~~station~~ station.

Citrus Fruit Inspectors have to inspect not only fruit but also orchards in order to obtain crop information for placing orders to the best advantage. Thus they have to visit different localities paying for their own transportation in many cases, obtain meals and accommodation for short periods. They cannot carry out their duties unless they can meet living expenses. At present, according to the maximum travelling allowance Lira 150/- per day is the most that can be paid to them.

9. Colonel EVANS personally informed Dr. FOIS that his salary would be Lit. 400 per day and that travelling allowances would be as stated above, and instructed me to inform Dr. SURICO, which was done. Both persons are anxious to know when the increases will be sanctioned. I request that they be made retrospective as from 15 April 1944.

SUBJECT: Approval of New Wage Rates for Sicily Stevedores.

TO : Mr. Braine.

1. New contract for setting up increased tonnage rates for work done by Sicily stevedores was submitted by Lt. Mason (now Captain) on behalf of the unauthorised Labor and Wages Committee and the defunct Sicilian Local Resources Board. The matter was considered by the Labor and Wages Control Committee at its December meeting, and decision taken that the submission of such a matter must go through proper channels.

2. In the meantime, the subject was again raised directly with this office by Captain Mason as being urgent. I then conferred with the Resources Section of the AFTRB to determine, first, whether ^{an} ~~intention~~ ^{action} could be taken by myself as Chairman of the Committee, and secondly, whether a decision could be made by this Sub-Commission without reference to AFHQ. We had already studied the details of the new rates and determined that they did not exceed the Armed Force Wage Scale. In fact, the rates are lower than those used for similar work on the mainland.

3. Inasmuch as there was no question of changing or exceeding the Armed Force Wage Scale, it was agreed between the Resources Section and myself that the matter need not come under consideration by either the Labor and Wages Control Committee or the Resources Board.

4. The answers to the questions posed in your memo are therefore as follows:-

- (a) This new wage contract can be approved without permission of AFHQ. ✓
- (b) Neither Finance nor Transportation have customarily been consulted in matters affecting wage changes within the restrictions set up by AFHQ, though I agree that important changes should be so cleared, if for no other reason than to maintain proper liaison and coordination. ✓
- (c) It will not be necessary to inform other bodies of the decision made. ✓
- (d) The wage rates approved are definitely in order. ✓

(e) An earlier reply was not sent to Captain Mason's minute since I was awaiting submission through normal channels as agreed upon by the 18 December Committee meeting, and took the action indicated when the urgency of the matter was again stressed. ✓

5. I believe Mr. Sachs' proposed letter should be changed to make reference only to the approval. Para 1 would then read:

"This will confirm wire of recent date authorising execution of contract submitted. Rates contained therein can be approved without submission to AFLRB, inasmuch as they are in conformity with recent increases in the Allied Force Wage Scale."

Para 2 should be deleted, and para 3 be subject of a separate letter.

1. Your signal 565 of 26 January authorizing the application of the revised Stevedores Contract has been received and the new rates are now in operation.

2. A strike occurred recently in the Port of Catania ²⁰⁰⁸ when stevedores refused to unload two coal ships. The matter was investigated and I attach for your information a copy of my report to the Regional Commissioner.

3. During the investigation the Ministry of War Transport expressed grave concern at the time it was taking for ships to be unloaded, and suggested that a possible solution to speed up discharge would be the payment of dispatch money on certain types of cargo. It was proposed to pay an additional 10 Lire per ton on tonnage in excess of:

a. Coal	165 tons per hatch per day
b. Grain	180 " " " " "
c. Phosphates	120 " " " " "

These proposals are reasonable and should be an encouragement to the stevedores to work for the maximum output. I have agreed to their taking effect from 1 February and would appreciate your confirmation of this action.

SUBJECT: Report on Strike at Catania
TO : Regional Commissioner, Sicilia Region

1. At the request of Lt. Col. Welker I proceeded to Catania on 25 January to investigate a strike that occurred on 23 January in the Port of Catania.

2. A meeting was held at the offices of the LMT at which representatives of the workers were present, and the following facts emerge.

The strike commenced on the morning of the 23 January when approximately 200 men refused to unload two coal ships, stating that the Allied tariff was insufficient to give them a living wage. The DMWR (Mr. Stoker) refused to see the men until work was resumed and the following morning the ships were diverted to other ports. When the strikers knew this they requested DMWR to let the ships remain and stated that they would return to work.

At the meeting the rate of pay was examined and it was agreed that the rate was fair and provided a reasonable wage if a sufficient tonnage was turned over per day.

The men receive 31 Lira per ton and allowing for an average turnover of 100 tons per hatch per day a wage of 200 Lire per day can be earned. It was pointed out that the tonnage moved was considerably less than 100 tons per day, consequently wages were lower. An average daily turnover in Palermo is 120 tons. The low rate of turnover is partly due to the fact that only one railway line services the coal quay and much time is lost in waiting for wagons. The other factor is slackness on the part of the workers. With a little more cooperation on the part of the railway company and greater efforts from the men, 200 tons per day could be unloaded. The matter is being taken up with the railway

With regard to the rate of pay, the men were informed that a revised tariff, which would give them an increase of 2 Lire per ton, had been submitted to Rome for approval. Approval has now been received, effective 1 February 45.

In order to speed up discharge of ships, DMWR suggested that the normal practice of paying dispatch money be reinstated. I have agreed to a figure of 10 Lire per ton on tonnage discharged in excess of 165 tons per hatch per day. It will be interesting to see the result of this proposal.

3. Inasmuch as there was no question of changing or exceeding the Armed Force Wage Scale, it was agreed between the Resources Section and myself that the matter need not come under consideration by either the Labor and Wages Control Committee or the Resources Board. 2992

4. The answers to the questions posed in your memo are therefore as follows:-

- (a) This new wage contract can be approved without permission of AFMRB.
- (b) Neither Finance nor Transportation have customarily been consulted in matters affecting wage changes within the restrictions set up by AFMRB, though I agree that important changes should be so cleared, if for no other reason than to maintain proper liaison and coordination.
- (c) It will not be necessary to inform other bodies of the decision made.
- (d) The wage rates approved are definitely in order.

(3) An earlier reply was not sent to Captain Mason's minute since I was awaiting submission through normal channels as agreed upon by the 18 December Committee meeting, and took the action indicated when the urgency of the matter was again stressed.

5. I believe Mr. Sachs' proposed letter should be changed to make reference only to the approval. Para 1 would then read:

"This will confirm wire of recent date authorizing execution of contract submitted. Rates contained therein can be approved without submission to AFLRS, inasmuch as they are in conformity with recent increases in the Allied Force Wage Scale."

Para 2 should be deleted, and para 3 be subject of a separate letter.

1. This will confirm wire of recent date authorizing execution of contract submitted. This contract was approved without A.F.H.Q. action after being screened for approximate conformity with recent increases in Armed Forces wage scale.

2. It is observed that the 1 October increase in the Armed Forces rate for the stevedores classification was from 85 lire to 110 lire, or approximately 30%. This might provide some latitude for still further increases, if necessary, to promote sound labor relations in the Island.

3. A report has been received through the Italian Government of a recent strike among dock workers in Catania. Forward report on causes and settlement of this strike at your earliest convenience.

1. At the present moment there is much discontent amongst State and Parastatal employees in Sicily, and the following preliminary report is submitted for your information, please.

2. During the past fortnight there have been many rumours that State and Parastatal employees intended to call a General strike throughout the island for:

- a. Payment of a Christmas bonus
- b. Payment of a wage commensurate with the cost of living.

Whilst it has not been possible to obtain very definite information a tentative date of 5 February was mentioned as the day when Palermo workers would strike. Enquiries were instituted by this Division and on Saturday 3 February I was assured that the strike would not take place.

On 4 February a meeting was held at which representatives of the Tribunale, Registry and Tax Offices were present. It was agreed that the proposed strike would not be called, but a meeting for 11 February has been fixed when further decisions will be made.

3. The situation is being watched and I will advise you of any future developments.


a. For the Christmas bonus of Lire 2000 granted to State employees.
