1. Attached is a copy of a letter addressed to this Sub-Commission by Signor Barbareschi, Minister of Labour of the Italian Government, together with a copy of a communication from the Provincial Labour Office of Ancona.

2. These communications were discussed with your Sub-Commission (Col. Glendinning - Mr. Proctor), and it was decided to suggest to Sig. Barbareschi that, as the responsibility for the Administration of Ancona had been transferred to the Italian Government, he, in collaboration with the Minister of Industry and Commerce, should arrange for a joint inspection to be carried out with a view to ascertaining precise details of the economic situation which now obtains in Ancona.

3. It was further suggested that, if in the light of the proposed inspection Sig. Barbareschi would arrange to submit to the Allied Commission details of proposals and recommendations, these would be sympathetically examined.

4. On 4th Sept. 1945 Signor Pinna, Vice-Secretary of Iron Workers of Ancona, headed a delegation, which included the Mayor of Ancona and three Trade Unions' representatives, to appeal to the Director of this Sub-Commission, with a view to acquiring certain items of equipment.

5. It is understood that a request has already been made by the Italian Government to the Allied Authorities for 4 mobile cranes in the Port of Ancona to be turned over to the Italian Government. The Iron Workers' representative asked that 3 other

link belt combustion cranes, at present set up in the yard of the Cantieri Navali Riuniti of Ancona, owned by Ing. Rocce Piaggio, be ceded to the above-mentioned Naval Yard. He stressed of the scarcity of equipment in Ancona and emphasized that in the event of these cranes being removed by the Allied Authorities, any available supply of raw material and the promise of repair or reconstruction work would be practically useless owing to lack of equipment.

6. In view of the serious position in Ancona in regard to unemployment, which position is likely to be aggravated by the dismissal of a large number of workers who are now employed by the Allied Forces, this Sub-Commission strongly recommends that consideration be accorded to the proposal for the transfer of the above described equipment.

Prefettura, i Comandi Militari Alleati hanno reso noto che entro un termine imprecisato, la quasi totalità delle Forze Armate Alleate, che da un anno si trovano in Ancona, si sottometteranno alla Città e che di conseguenza le Unità Alleate procederanno al graduale licenziamento, dei lavoratori italiani alle loro dipendenze.

I casi citati sono solo un esempio e potrebbero esserne molti altri.

Non meno grave è la questione dei mezzi di trasporto per i lavoratori Occorrendo considerare che attualmente il centro urbano di Ancona può ospitare circa il 50% della sua popolazione e che la restante parte vive nelle case private circostanti e si reca quotidianamente al lavoro in città quando per la mattina parte dagli autobus alleati.

E' evidente che, con la partenza delle Forze Armate Alleate, tutti questi lavoratori saranno impossibilitati a raggiungere regolarmente i posti di lavoro.

Tutte queste considerazioni sono state portate a conoscenza delle autorità Alleate locali ed è stato richiesto che le Forze Armate Alleate lascino sul posto, all'atto della loro partenza, il maggior numero possibile di mezzi meccanici e di trasporto, nonché se in cattive condizioni.

Gli Alleati hanno richiesto degli elenchi dettagliati delle attrezzature e dei materiali che si richiedono. Tali elenchi sono in appoggio a quanto essi comprenderebbero tutti gli attrezzi ed i materiali che non sul posto e che potrebbero essere ceduti dagli Alleati ed assegnati preferibilmente ad enti locali o uffici pubblici.

Intanto sembra a questo Ufficio che sarebbe opportuno interessare il Comando Alleato, nonché il locale Comando della 61<sup>a</sup> Armata, affinché le richieste che verranno presentate siano prese in utero esame ed accolta per quanto possibile.

At a meeting specially held on 19th July at the R. Prefettura, the Allied Military Commands announced that within an unspecified lapse of time, practically all the Allied Armed Forces which have been in Ancona for a year will leave the town, and therefore the Allied Units will gradually dismiss all Italian workers in their employment. Within a few months the number of these workers who will be without employment will reach 20,000.

The situation in the Province which, from the point of view of unemployment had been fairly reasonable until now, threatens to suddenly become extremely critical. The problem appears to be even more serious if one takes into consideration the fact that last Spring the number of workers employed by Allied Military Units at times reached even 30,000 people.

So far all plans and initiative remain at the stage of good intentions, the only answer to the principal question is : raw materials.

Besides this, though, there is another no less serious question which might be solved with comparative ease and which consists of the lack of industrial installations, these were all destroyed by over one hundred air raids on the city, the passage of war or by destruction by the Germans. Without these installations all undertakings would be extremely difficult and uneconomical. If, for instance, on their departure, the Allies removed their port installations, the port of Ancona would no longer be able to operate, not only because of absolute shortage of mechanical means, but also of all installations which are indispensable to the operation of the port.

The same may be said about the operation of a Metallurgic Cooperative, which at present works for the Armed Forces with materials furnished by AMF, and does not have any installations of its own.

The above-mentioned cases are only a few of many instances which could be mentioned in this connection.

No less serious is the question of transportation of workers. At present only about 50% of the population of Ancona can be housed in the town itself, and the remainder live in the surrounding countryside, and the greater part are taken daily to work by allied transportation. It is obvious that upon the departure of the Allied Armed Forces all these workers will be unable to reach their work regularly.

All these questions have been brought to the notice of the local Allied Authorities, and it has been requested that the Allied Armed Forces should, at their depart-

greatest possible number of mechanized means and vehicles, even in bad condition.

The Allies have asked for detailed lists of installations and materials seized. These lists are being prepared; they will include all the tools and materials on the spot, which might be released by the Allies and preferably signed to local undertakings or public offices.

In the meantime, this office believes it would be advisable to inform the Allied Command and also the Command of the 61st Air Unit of this, so that when requests are put forward they will receive careful consideration.

1. ORGANISATION.

In Perugia and Terni Provinces, recently added to Region V, it has been found necessary to completely re-organise all offices, which will include new office spaces, personnel changes, obtaining of furniture and equipment, and all records and files of the ex-fascist unions, particularly the assistance case files.

Reports on these two offices are covered in separate attachments.

2. LABOUR DISTURBANCES.

There have been no serious labour disturbances, but there has been a number of threatened strikes, etc, in Ancona and Pesaro Provinces. The Labour Directors have been able to quieten the disturbances, which have been mainly due to unemployment. State and Parastatal employees are still not completely satisfied because the second anticipation on 1,000 lire has not been paid. A Macerata disturbance was due to differences in wages of workers for the Forces and private contractors, both engaged on railway work.

3. POLITICAL DISTURBANCES.

There have been no political disturbances that have affected labour.

4. WAGES AND SALARIES.

The increases in wages is still a major problem, a race being developed on increases for workers of private employers and the Forces. This is aided by the accord reached between the Employers Associations and the various Camera del Lavoro, especially in Terni and Perugia Provinces, where the "lid" is off. ### 5. UNEMPLOYMENT.

In every Province unemployment has increased, generally due to reductions in workers for the Forces. In Ancona about 10% of the unemployed are located in isolated areas, such mass unemployment creating local unrest, which cannot be relieved due to transport shortages or distances. Some plants capable of operation are idle, either because of coal or electricity shortages. The silk plants, now idle, should start operations soon or the crop will be lost. Only relatively minor repairs are necessary and an allotment of fuel. In Pesaro it is estimated that 75% of the registered unskilled labourers are at present unemployed, due to reduction in the number working for the Forces, lack of transport, etc. Several hundred women silk workers also are idle. In Perugia, of the estimated 24% unemployed, about 80% are industrial workers of plants that are closed either due to damage, or lack of fuel and raw materials.

### 6. GENERAL.

The Camera del Lavoro of the Provinces are continuing their activities and are issuing orders for wage increases, without advising the Labour Office Directors in many cases. In Pesaro they attempted to effectuate a wage scale for Hotel, Restaurant and Lunchrooms, without reference to AMG, the proposed rates far in excess of the Forces rates.

A new schedule was prepared through intervention of the Labour Office, and rates requested are under consideration.

All Provinces report increases in costs of living, principally due to increased prices of items in the free or black markets, coupled with continued shortages in the controlled market or ration card items.

The increase in unemployment, especially in the clerical worker group, but prevailing to a certain extent in the industrial class, is due to reduction of numbers working for the Forces and shortage of materials to repair or re-condition damaged plants, lack of electricity and fuel for industrial purposes, and shortages of goods to revive commerce permitting shops and stores to open with ample merchandise. Extreme hardships due to unemployment in certain communes is due to their isolated location and lack of transport. Miners in Pesaro and Ancona Provinces are particularly hard hit through mine machinery damage requiring considerable time for repairs or replacements of machinery and re-conditioning of mines before productive operations can be resumed.

1. Attached are preliminary reports on the Provincial Labour Offices in the a/a Provinces as of first visit of the Labour Officer of Region V. It was found in general that these Offices were not functioning at the standards that prevail in the Adriatic Provinces of the Region, and immediate action for improvement was instituted. The condition of these Offices as of this date is set forth below.

2. PERUGIA.

In the last ten days the Office has been completely reorganised, the Perugia town collocamento office moved from its old location on the 3rd. floor of a building on a back street to premises on the ground floor facing one of the squares on the main street. New premises are being considered for the Provincial Office.

A new budget to adequately provide for the increased activities has been prepared and is presently being reviewed by the Regional Finance Office. Additional typewriters, furniture and equipment has been obtained, and inventories received from the Intendenza di Finanza are being examined and ex-union records obtained necessary for the handling of workers benefits.

A referral of the position of the four reorganised fascist unions has been made to determine their legality.

3. TERNI.

Action has been started to improve the working conditions and increase the activities of the Terni Labour Office. Conditions similar to Perugia have been noted and corrective measures should show their results in a few weeks.

4. Captain M.L. Schnee is directly handling the Terni Office, and has assumed supervision of all other Provinces of the Region, except Perugia, which is being handled by Captain L.H. Bailey, pending his departure to his new assignment.

1. As instructed, a visit was made 25 April 1945 to Terni to inspect the Provincial Labour Office, which had been reported as functioning satisfactorily.

3. The office was closed when the visit was made as it operates on a single shift basis, closing at 2 P.M. One clerk was in the office to answer the telephone and receive visitors. The furniture consists principally of tables, secured from one of the fascist unions. There are two typewriters, one on loan and one formerly a fascist union machine, both in poor condition.
4. The table of organisation examined indicated a reorganisation was in process in accordance with instructions from the Minister in Rome. There are at present 12 persons employed in the Provincial Office. Three communal officers are planned but only the collocamento communal office in Terni is open to date. 1. A preliminary report of labour and Provincial Labour Office of Perugia Province is submitted herewith as instructed.

a) PREMISES.

The premises of the ex-fascist labour organizations are now occupied as shown on Exhibit "A". It is noted that none have been allocated to the Prov. Labour Office, but parts of the two old offices have been given to ex-unions which reorganised, one is occupied by refugees, one Mutua Malattie, one by Sepral and the balance requisitioned by the Military. Except for military the use has been obtained by Prefectural requisition.

The Labour Office at present occupies three rooms formerly a dwelling, which are poorly located and unsuitable for the proper functioning of an active Labour Office.

b) RECORDS.

The records of the ex-fascist unions are at present as shown on Exhibit "B". It is noted that four of the ex-fascist unions have been allowed to reorganise and retain the files, records, etc., of the old unions. In the cases of the other ex-fascist labour unions the records have been divided between the Camera del Lavoro and the Labour Office. The records in the Labour Office represent a relatively small portion. It appears that of the records taken by the Camera del Lavoro, a portion have been destroyed or sold by the Camera for waste paper, the proceeds of the sales being retained by the Camera.

According to AMG regulations all records of ex-fascist unions are supposed to be placed in the custody of the Intendenza di Finanza and released to the Labour Office when created by General Order 28.

c) FURNITURE, EQUIPMENT, ETC.

The present location of furniture, equipment, etc., of the ex-fascist labour unions is shown on Exhibit "C". It is noted that some has been retained by the reorganised fascist unions, some by the Camera del Lavoro, who in some cases have refused to permit an inventory by the Intendenza di Finanza as required by AMG regulations.

The few pieces of office furniture now in the Labour Office were obtained from the Intendenza di Finanza, and is at present supplemented with living room furniture which is entirely unsuitable for an office such as the Labour Office.

The Intendenza di Finanza has not completed his inventories of the possessions of the ex-fascist labour unions nor has he been able to take custody of the same, holding it for use of the Labour Office, if required by them.

The typewriters, duplicating machines, and other similar equipment which is urgently needed for the functioning of the Labour Office is in the possession of others, either by Prefectural order, or by outright seizure. The Camera del Lavoro has two duplicating machines of ex-unions, as well as typewriters. The reorganised fascist unions also have typewriters, etc., of the fascist unions.

d) REACTIVATING OF FASCIST UNIONS.

The Labour Office Director advises that four of the fascist unions have been permitted to reorganise. General Order 28 permits workers to organise under certain conditions and for certain purposes, but does not include employer organizations, or authorize the organisation of successor organisations of the fascist corporate syndicate. The four organisations should be liquidated for lack of proper AMG permission, or an AMG Order of approval, and the fascist properties placed in custody of the Intendenza di Finanza.

c) GENERAL ORDER 28

The Director of the Provincial Labour Office advises that General Order n.28 was posted in this Province about 31 October 1944.

f) PROVINCIAL LABOUR OFFICE

The Provincial Labour Office of Perugia was opened about 1 November 1944 after much difficulty as the office space was requisitioned by military on one occasion, and shortages of furniture, equipment, etc., added to their troubles. They finally obtained rooms at Piazza Biordo Michelotti N.6. There are at present 22 employees including 4 in the local Collocamento Office, and 4 others located in two other communal offices. Neither the Provincial Office or the Communal Offices are functioning properly, and reorganisation in accordance with AC requirements is in progress. There are insufficient communal offices at present to properly service the workers, and three additional offices are to be opened shortly.

The Camera del Lavoro is operating collocamenti offices in some communes contrary to General Order 28 which places this function solely with the Labour Office.

The budgets of the Labour Office are being reviewed. It has been noted that since its organisation the Labour Office budgets have carried an item of 1,500 lire per employee per month for payment as an anticipation against the proposed Italian decree which is to increase State employees salaries and family allowances. However, only one payment of 1,500 lire and one payment of 1,000 lire an employee have been made to date. It has also been ascertained that when budgets have been approved the money has been placed in the Bank of Rome. Several items of the old budgets appear to have been greatly over estimated leaving large balances of funds at the end of budgetary periods. The budget for the second quarter of 1945 has not been prepared or submitted to AMG, and it is now in preparation under close supervision to eliminate large balances. A revision of salaries is also being made to bring them in line with the salaries of the State employees doing like work. This will eliminate the necessity of adjustments when this Province passes to the Italian Government and the Labour Office becomes a State Office.
