SUBJECT: Application of Decree 22 February 1945 No. 38
relating to Elimination of Political Price of Bread.

TO : Ministero dell'Interno
Direzions Generale Amministrazioni Civili

1. Your letter of 16 September 1945 (your Ref. No. 25100-35) has been referred to this sub-commission for reply. Your letter requests information as to the status of the above-mentioned Decree in Northern Italy.
2. The Decree of 22 February 1945 No. 38 was not extended by ASG to the provinces north of the so-called Economic Boundary-line.
3. Instead, a General Order, known as General Order No. 38, covering the same subject matter was published with effect from 1 August 1945.
4. This General Order contained provisions similar to Decree No. 38 with reference to prices for bread and cereals. With respect to the Caropane Indemnity, however, this indemnity for employees in private industry and also for employees of statal and parastatal agencies was eliminated. The Caropane Indemnity was included, however, for the benefit of certain groups of persons, such as indigent poor, disabled persons etc. described in Art. 3 of Decree No. 38.
5. With reference to employees of statal and parastatal agencies the Caropane Indemnity was taken care of by DIL of 15 March 1945 No. 116 which was implemented in Northern Italy by ASG with effect from 1 May 1945.
6. With reference to the Caropane Indemnity for employees in private industry, this indemnity was incorporated into the Family Allowance system by a Decree of 15 August 1945 No. 552 (published in Official Gazette No. 114 of 22 September 1945.) This Decree was implemented in Northern Italy by ASG by virtue of Order No. 1820 which was published in Official Gazette No. 127 dated 23 October 1945.
7. A copy of General Order No. 38 is here inclosed.

1. The terms of the proposed General Order No. 38 are agreed on the understanding that they relate to persons other than direct employees of the Armed Forces. Probably Article VII excludes Armed Force employees or there may be some general Order stating that Armed Force employees are excluded from the terms of general wage or bonus Decrees.

2. If there is no such general exclusion or if Legal Sub-Commission are of the opinion that the general term "worker" used in the proposed Order could be interpreted as applying to Armed Force employees, it would be advisable to include an Article stating that the provisions of the Order do not apply to these persons.
