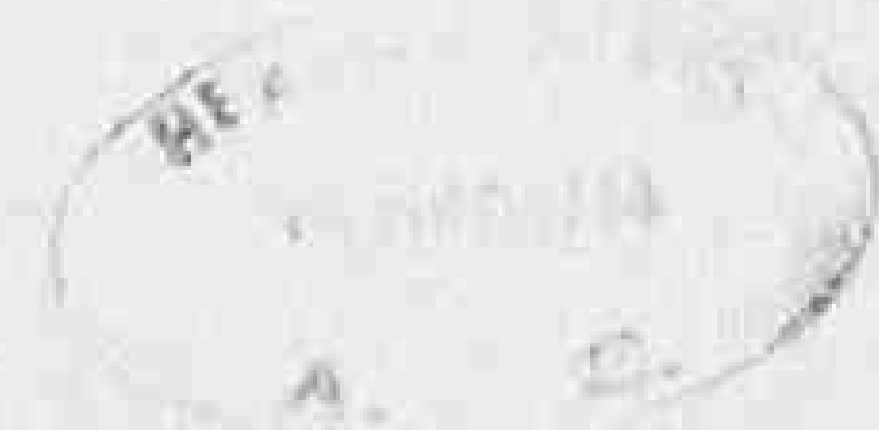

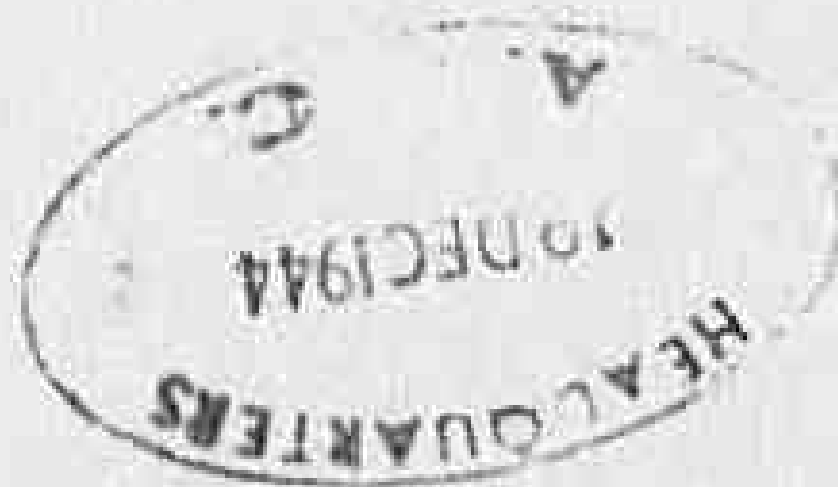

Dispute is because Italian railway law makes 24 hours rest essential after 48 hours week. Sud Est workers work 40 minutes overtime each day so as to obtain payment for Sunday rest day. Italian State Railway receive payment for Sundays without working overtime. Demand is now first overtime rates for the 40 minutes overtime per day and second payment for Sunday rest day. Italian Director ORBETTINO states cessation of overtime will not affect production as stated by Major BAISTER. Full report follows when received from BARI.
