SUBJECT: "Granai del Popolo" (Granaries of the people)
Porterage in the province of Macerata.

It was already brought to the notice of this Ministry the fact that it seems that the rates fixed by the Labor Chamber of the province of Macerata, for the porterage work in connection with the Granaries of the People - rates approved by the A.M.G. - are different from those applied in the near-by provinces, and that they are considerably higher than the latter. Inasmuch as these differences may have a disturbing effect, both of financial and social character, we kindly ask to your Commission to issue directions intended to uniform, the porterage rates in all the provinces not yet turned over to the administration of the Italian Government.

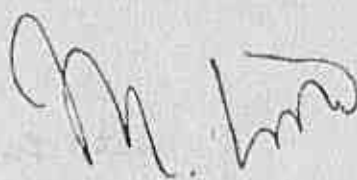

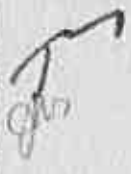

1. General Order No. 45, this Headquarters, dated 1 November 1944, is hereby revoked.
2. Pursuant to letter OA/23, dated 25 October 1944, and signed M665, AMG 8th Army, Ancona and Pesaro-Urbino Provinces are released to AMG/AC control under the jurisdiction of the Abruzzi-Marche Region.
3. Effective from 1000 hours 3 November 1944, Abruzzi-Marche Region assumes administrative control.
4. Normal security regulations and restriction of civilian movement in that part of the two provinces north of the Rear Army Security Control Line remain in full force and effect.
