SUBJECT: Proposed Establishment of a Special Commission by the Council of Italian Ministers.

TO : Minister of Industry, Commerce and Labor, Italian Government.

1. General O'Dwyer sent a letter (LAB 091.4351), dated 20 August 1944, to your office in which he discussed the advantages of establishing an Italian Civil Service Commission.

2. It occurs to us that such a Commission which would regulate the recruitment, classification and employment status of all public employees would be of great benefit in the orderly reorganization of State Agency personnel, assuring maximum utilization of available skills and also in effecting economies in payroll costs.

3. An additional secondary advantage might accrue if ACC/AMG had the benefit of using procedures developed by such a Commission in the staffing of forward area offices thus facilitating the later transfer to the Italian Government.

4. I should be interested to know what your reaction is on this subject and what conclusions might have been reached to date by your Government with respect to the development of such an agency. Also I should appreciate advice from you as to what present provisions exist in the field.

SUBJECT: Inquiry on Italian Civil Service Commission.

TO : President of Council of Ministers.

1. On 3 September, the Ministry of Industry, Commerce and Labor, forwarded to your office the suggestion made by the Economic Section, A.C.C., concerning the need for an Italian Civil Service Commission regulating the recruiting, classification and employment status of all public employees.

2. It is believed that such a Commission would be of great benefit in the orderly reorganization of State Agency personnel, providing for the best utilization of available skills, and at the same time effecting economies in payroll costs.

3. Procedures developed by such a Commission might also be used by AMG/ACC officials in staffing forward area offices, thus facilitating the later transfer to the Italian Government.

4. Will you please advise us of present provisions in this field and of your plans for their future development?

SUBJECT: Proposed Establishment of a Special Commission  
by the Council of Italian Ministers

TO : Minister of Industry, Commerce and Labor

1. From the reports of our various Sub-Commissions on their work with the various Ministries of the Italian Government, it is apparent that one of the greatest difficulties common to all the Ministries is that of personnel classification and recruitment, particularly for technical and administrative positions.

2. In the opinion of this Commission, there is a great need for immediate action on the part of the Italian Government to improve and extend its activities in the field of personnel administration for the public service.

3. Specifically, it is suggested and urgent that there be appointed at once on behalf of the Council of Ministers a non-political Commission competent to study and recommend concerning the immediate problems of personnel practices and also concerning the establishment of a permanent and inclusive Civil Service Administration for all State and Para-State employees.

4. Such a Commission appears necessary at this time since apparently the present Civil Service Laws, many of which have fallen into disuse or abuse under Fascism, have no central administrative or advisory body and the practices of the various Ministries lack uniformity and effectiveness.

5. It is requested that the Allied Control Commission be advised of your contemplated action in this field. Full cooperation is offered including the assistance of Commission personnel experienced in Civil Service administration in Britain and the United States.
