5. Considerando che la provincia dell'Emilia e parte della Toscana sono state passate sotto il controllo del governo Italiano, ci meravigliamo che il numero di dipendenti impiegati (Col. b.) non sia aumentato.

1. Inclosed herewith progress reports covering period 15 - 30 June, 1945 which are delayed due to need of investigation of figures.

2. It will be noted that little or no progress has been made in proceedings concluded. This is due to the absence from Rome of the President of the Epuration Commission with the largest number of cases to judge.

3. It will also be noted that there are less cases initiated than previously reported. This is due to the dropping of several cases which had been initiated without sufficient details.

4. Generally speaking there seems to be a general feeling of laissez faire about the whole defascism program on the part of the officials charged with completion of the program.

To: Ministry for Post and Communications.
 Commission for expurgation, 1st degree. R O M E

I undersigned SABATELLI Bruno di Giovanni, residing at Florence, and a prisoner of war at the present, answer your letter dated 30 April 1946 pursuant to articles 14 N. 186, art. 18. With reference to my expurgation I am pointing out as follows:

At the beginning of August 1922 I was a letter carrier with the express post office of Florence, Railroad Station. There I was advised, and then threatened, by a group of postmen headed by a certain Grassini Bruno to join the National Fascist Party. This I did, first on account of my youth, which was inclined to enthusiasm and not able to distinguish the good from the bad. I believed in a good cause, but there was also involved our permanent employment, because we had been only on a temporary basis to this time: thus, on 18 August 1922, I received my membership card. After this, on 12 Sept. 1922 I was inducted with the 2nd semester of class 1902. When I came back towards the end of 1923 I was dismissed because veterans, and wounded veterans of the war 1915 to 1918 were employed instead. In March 1924, however, I was reemployed by your Service and continued to be a party member, also due to the general orders which at that time were in force, for all state employees.

I am stating that in the whole long period as a Fascist I did not make any propaganda for Fascism, did not hold any discussions, was not a party to any highhanded activities; in the party, I was just a number in the masses. I was only thinking to do my duty as an employee in the only interest of the state, and worked long hours for the upkeep of my family which had been hard hit by sickness and death. As far as my activity as a Fascist is concerned, I appeal to the good judgment and sense of justice of my superiors and fellow workers and name them as witnesses for my statements. To-day I am possibly the only one in the whole Service of Florence who has to pay for his mistake of 20 or more years ago by my long imprisonment which is certainly not deserved.

In the name of my children who are abandoned in misery and not guilty of another person's fault, and in the name of my good and unimpeachable conduct throughout the 26 years which I worked in your Service, I am appealing to this Commission itself and asking them for pity on my fate which is already sad, and to be mild in their judgment as to my membership in the National Fascist Party.
