1. With reference to your letter S/83/4813 of 21 Dec. 44 it is known that the channels previously used for private correspondence from Italy to Spain were slow and circuitous.
2. The arrangements introduced in September last for direct despatches from the SPS Section in Rome (PS.16/15.154) should have resulted in improvement and indeed the letter from the military attaché suggests that this improvement is noticeable in the case of the most recently posted letters.
3. Possibly the postal authorities in Madrid can give him some information regarding the average transit times of the direct mails.
4. Perhaps you will wish to ascertain how the Ministry of War actually disposes of the official mail referred to in the final paragraph of the letter from the Military attaché.

EXTRACT

From Post Office Circular of 13th December 1944.

POSTAL SERVICE TO ITALY.

The Postal Service to Italy, i.e., registered and unregistered letters not exceeding 2 oz. in weight and postcards, will as from the 20th of December be extended to the provinces of Ancona, Perugia, Arezzo, Siena, Livorno, Aieti and to the cities and provinces of Pisa and Florence.

Correspondence addressed to areas of the province of Pisa and Florence situated to the north of the River Arno will be held by the Italian Post Office until delivery can be effected.

Working copies of the Post Office Guide (pages 232-233) should be amended accordingly.

POSTAL SERVICE TO FRANCE.

Correspondence for France, restricted to postcards and letters not exceeding 1 oz., in weight, may now be accepted for registration. Working copies of the Post Office Guide should be noted accordingly. There has been no extension of the areas in France to which correspondence may be sent (see P.O.C. 8.11.44, complete edition, p.523, DF 110, Sub-Postmasters' edition, p. 377).

Ref. your 201316/11 of Aug. 29th, received on 14 instent.
After some months private letters from liberated Italy have begun to arrive here, with a certain irregularity,

through normal postal channels; some of these letters are now delayed only of a fortnight; some other, on the contrary, arrived now, have been despatched from Italy on the last spring. The impression is, however, that the service is on its way to regularity.

From official pouches arriving, up to now very irregularly, through Allied courier, from the Foreign Office, and from the ones outgoing, by the same means, from this R. Embassy, are still excluded private correspondence of every kind.

As far as official correspondence is concerned, it is pointed out that, by the means above mentioned, this Office has received, on the 13th instant letters from the Central Military authorities dated 27 June - 5 October 1944



I. In connection with the increase of the letter post weight limit to one kilo the United States Authorities have issued the following regulations

"Letters and packages prepaid at the letter rate of postage may NOT contain merchandise of any kind but are restricted to communications (personal or business) which are NOT transactional in character."

" The provision of Order 26354 dated 30 October 1944 regarding gift packages for civilians in the VATICAN CITY STATE and the Italian cities of ROME, NAPLES, PALERMO, SICILY, remain in effect. Parcel post packages for other places in ITALY are NOT acceptable."

2. The British Post Office has indicated that it is unable to ensure the exclusion of goods etc. and therefore the increased weight limit will not at present apply to letters FROM the U.K.

"The provision of Order 26354 dated 30 October 1944 regarding gift packages for civilians in the VATICAN CITY STATE and the Italian cities of ROME, NAPLES, PATERMO, SICILY, remain in effect. Parcel post packages for other places in ITALY are NOT acceptable."

This announcement will be enforced and no change in the provisions of the last paragraph of MAT 420 is anticipated.

Notification was given in MAT 394 that commercial and business communications could be accepted in ITALY up to 2 pounds 3 ounces (1 Kilogram). In last paragraph of MAT 420 it was urged that it be ensured that this weight be applicable to such correspondence only and that private persons be not allowed under the guise of such communications to send articles and goods to ITALY.

From the wording as received here of announcement made in WASHINGTON on December 12 it appears that impression has been given that persons in US can send mail to ITALY up to 2 pounds 3 ounces (1 Kilogram) irrespective of type of mail. Urgent clarification is requested as to exact scope of US announcement. British position was stated in TROOPERS 99968 CA14 of 7 December.

U.S. - ITALY MAIL SERVICE INCREASED.

Washington - December 12 -- Additional mail service is now available to that part of Italy receiving ordinary mail from the United States and also to the Vatican City, the Post Office Department announced last night.

Letters and packages up to two pounds three ounces will be accepted at a prepaid rate of five cents per ounce, the letter postage rate. Letters have been limited to two ounces.

Mail to Italy is still restricted to personal or business communications "not of a transactional character" the announcement said. (OWI)

MEMO : Above news release discussed by telephone with Lt. Col Jackson G-5 who will send cable to Washington pressing for increased weight limit to be applied to written and printed matter, other goods and articles to be excluded. Col. Munro P.W.B. seen and confirms that the extract had been released to Italian Press. He will arrange for a notice to be issued saying that the announcement was premature and will be followed in due course by a further announcement by the Postal Authorities.

1. Reference your 383.8 of 10th December, it is noted that the weight limit for letters from the United Kingdom to Italy will NOT be increased as from 12 December.
2. As the attitude of the United States to this question is not known, and as the increase in the weight limit outwards from Italy to the United Kingdom and United States was announced in November (PS-16/15.270) it is suggested that the increase be allowed to stand, to avoid changes in policy.
3. The restriction on contents referred to in my P.15.313/03. of 9th December to the Under Secretary of State for Posts and Telecomms. (copy to you) has been notified to all Italian Post Offices and will be shown on the relative public notices.
4. It is not thought that there is a serious danger of infringements of the regulation in the service from Italy.

1. Correspondence intended for transmission by the normal civil mail services from overseas to Italy is censored in the country despatching the mail.
2. Apart from the exceptions made recently in the case of the United Kingdom and the United States, it is prohibited to send correspondence of a commercial or financial character in the civil mail service to or from Italy.
3. Presumably, therefore, it is the intention that the attached letters should be treated as Allied official correspondence since the financial bodies concerned (Controller of Finance and Accounts in Tripolitania and Finance Sub-Commission in Italy) have an interest in transmitting and for which they accept responsibility as regards the nature of the contents.
4. It is considered that the envelopes of any correspondence accepted for transmission through Allied channels outside the normal censorship regulations should bear the signature of the Allied Officer concerned.

1. Reference your letter 834994/IUPU dated Nov. 29th, enclosing for transmission to the International Postal Union Bern a notification to the effect that the maximum weight for letters from Italy to the United Kingdom and the United States has been raised to 1,000 grams.

2. It is considered desirable, before sending your communication forward, to await the receipt of information, which has been asked for via A.F.R., regarding the precise conditions which have been announced in the United Kingdom and United States as applicable to the posting there of packages up to 1 kilo in weight for Italy. We have as yet no definite information as to:-

(a) whether the increased weight limit applies in those two countries only to commercial correspondence (if so, precluding the posting, by letter post, of e.g. food and personal articles)

(b) whether letter post rates are actually being charged or not.

3. The application of the letter rate to postings of commercial correspondence from Italy was of course agreed upon at our meeting as the most appropriate course in the circumstances. The local notification (circularised to Provincial Post Offices, in your telegram No 289180 of Nov. 16th) that the weight limit for "letters" to the United Kingdom and United States has been raised to 1 kilo, was more all-embracing than was intended by the terms of our P.15.370 of Nov. 14th; but this need not occasion concern at the moment, as probably there is no great use made at present of a 1 kilo letter post from Italy for sending personal articles etc. to the United Kingdom and the United States.

4. If however it is practicable in the case of two countries to raise the maximum permitted weight for letter post from 40 gms. to 1 kilo., and if there are no exceptional problems in other cases, it could be expected that the same higher limit - though not automatically the inclusion of commercial correspondence - should be applied to all external services which are operating from Italy.

5. In these circumstances you will no doubt agree that despatch of the communication to Berne should preferably be held in abeyance for the moment.

6. Pending clarification of the whole matter, the relative notifications issued in A.S.G. provinces concerned advise that the 1 kilo. limit applies only to commercial correspondence for the United Kingdom and the United States. Whether or not these notifications - or those issued in Italian Government territory - will be required to be modified will depend upon the further information which is awaited. It is the intention that the same conditions should apply in each direction.





Italian Government now states that increase of minimum foreign postage rates from 1.25 lire to 5 lire will constitute an inflationary measure and will infer Italian recognition of the extent of currency devaluation and compromise their position relative other financial matters.

2. They state that proposed rate is not substantial compliance with Universal Postal Union Convention, but they will accept 100 % increase to 2.5 lire. Such acceptance is apparently compromise agreement since Article 2 of final protocol limits increase only 40 % of rates fixed by Article 34, Section 1.

3. Rates for Italian external mails proposed in our W6144/5606 of 21 November based on gold franc as monetary standard, with 5 gold centimes equal 1 cent. Former postage rate of 1.25 lire or 25 gold centimes, would now equal 5 lire based on present value of lire.

4. 2 courses action appear open: (A). Approve rate of 1.5 lire for post cards; 2.5 lire for letters up to 20 grams; and 4 lire for letters up to 40 grams. These rates are acceptable to Italians. (B). Establish rate of 3, 5, and 7 lire as proposed our W6144/5606 of 21 November, notwithstanding present position of Italian Government in this matter.

Question of postage rates for external Italian mails raised in MAT 141 was referred to United States Post Office Department for an opinion. It supplies the following information relative to the determination of rates under the Universal Postal Convention:

"The unit of weight for computing postage for letters in the international service is 20 grams (or one ounce in countries which can not adopt the metric system of weights on account of their domestic legislation) while Article 20 of the Buenos Aires Convention provides that "The franc used as the monetary unit in the provisions of the Convention and Agreements is the gold franc of 100 centimes weighing 10/31 of a gram and having a fineness of 0.900."

"The Buenos Aires Convention provides, in Article 105 of the Regulations of Execution, as follows:

'Administrations fix the equivalent of the rates and fees contemplated by the Convention and Agreements by agreement with the Swiss Postal Administration, which latter Administration shall give notice of the equivalents through the intermediary of the International Bureau. The same procedure is followed in case of change of equivalents.'

"The situation with respect to the Italian postage rates is, of course, the result of the disturbed economic conditions in that country brought about by the war. Such conditions prevailed in a number of countries at the close of World War I, and it is accordingly deemed pertinent to review briefly the situation with respect to international postage rates prior to and following World War I.

"Before the Convention of Rome (1906) became effective, the postage rate for letters was 25 centimes for each weight unit of 15 grams (one-half ounce). This rate was reduced by the Congress of Rome through an increase in the unit of weight from 15 to 20 grams, although the post card rate (10 centimes each) remained the same.

"Prior to World War I, there was considerable agitation in some countries for a further reduction in international postage rates, but with the advent of the war and the resulting postponement of the Congress of Madrid from 1914 to 1920, the views of the countries advocating reduced rates had meanwhile undergone considerable change due to depreciated currencies after the war and a movement for increased postage rates (as well as increased transportation rates) had developed.

"For your information, there are transcribed below excerpts from the discussions of the First Commission of the Madrid Congress concerning postage rates:

'According to the Swedish Delegation, the words "the money of a country which has not at present a stable value as compared with gold" could very well be cancelled. Under present circumstances we must not only allow countries whose money has fallen in value to fix themselves the taxes (rates) which they will henceforth collect, but we must give this same liberty to all the countries of the Union. To decide at present, with the excuse of safeguarding the principle of the uniformity of international taxes, that the countries whose money is stable as compared with gold, will have to collect the exact equivalent of the taxes indicated in gold francs, is simply a theoretical idea. The uniformity of taxes, as understood by the preceding

Congresses, no longer exists. We may hope for it to be re-established at the next Congress, but today, when only one or two of the countries would be in a position to apply the exact equivalents of the taxes fixed, the argument in favor of uniformity has only a relative value.

.....

'In consequence, Italy proposes the following terms, or others more precise:

'The contracting countries are free to fix, in accordance with the Swiss Administration, the equivalents in their interior money, of the taxes referred to by the present Convention, taking the conditions of the country into consideration but without, however, exceeding the corresponding value of these taxes in gold according to the average of the exchange."

'The Delegation of the United States of America considers, in accordance with the Financial Sub-Commission, that in order to act justly it is necessary to sacrifice the principle of uniformity with regard to the international taxes until economic conditions have once again become normal throughout the entire world. But it appears to them unjust to give certain countries the liberty of fixing their postal taxes according to their needs and to deny this liberty to other countries.'

"The next Congress (Stockholm, 1924) again reduced the rates by restoring those in effect under the Rome Convention. These rates were continued in effect until 1939 when the Buenos Aires Congress saw fit to make a further reduction by fixing the rates as set forth earlier in this letter.

"Doubtless the next Universal Postal Congress will give particular consideration to the economic conditions resulting from the present War, as did the Madrid Congress with respect to those brought about by World War I, by again making special provision for considerable freedom of action on the part of the countries concerned in fixing the equivalents in their own currency of whatever postage rates may be adopted by the next Congress.

"It may be well to add that the situation with respect to rates for other articles (printed matter, commercial papers, etc.) in the Postal Union mails has been substantially the same as that applicable to rates for letters and post cards, that is to say, the rates were increased by the Madrid Convention (1920), reduced by the Stockholm Convention (1924) and further reduced by the Buenos Aires Convention (1939)."

1. Arrangements have been made for the extension of the existing letter mail service to the U.K. and U.S. to include commercial items within the categories outlined.- It is noted that more specific details are being sought.

2. On the assumption that our proposed weight limit of 1 kg. will be acceptable, that figure is being announced as the maximum for the service from Italy.

3. Although certain of the enclosures to commercial correspondence may be of a character normally eligible for transmission by a subsidiary service cheaper than letter post rates, it has been decided, in consultation with the Italian postal authorities, that all commercial correspondence will be subject to pre-payment at letter rate (2.50 lire for the first 20 gms.; 1.50 lire for each additional 20 gms.) It is gathered from the letter of 24th 115 that letter rate will be charged on similar items to Italy.

4. It is considered very desirable to confirm from CGS that the increased letter post weight will be applicable only to commercial correspondence, and not to articles or goods (e.g. food) which under normal conditions might be sent as letter packets (subject to certain importation and customs restrictions and provisions).- It would not be possible to cope with 1 kg. food packages for the whole of the postal delivery area.

Individuals and firms in liberated Italy may request information regarding the status of their pre-war deposits in U.S. and U.K. Banks and other financial institutions and may also request documents such as birth certificates, death certificates, wills and legal notices. It is to be noted that requests for powers of attorney, proxies and payment orders to Italy will continue to require licences from the existing controls in the U.S. and U.K."

2. This notification is confirmed, together with the following provisions, as agreed upon in our discussions, for the extension of the present letter mail service to the United Kingdom and United States to include commercial and financial correspondence as defined in para. 1 above:

(a) The maximum weight limit for any one package will be 1 lb.

(b) Letter rates of postage will be chargeable, i.e. 2.50 lire for the first 20 gms. ; 1.50 lire for each additional 20 gms.

3. (a) Will you please arrange for the press and general public, and all Post Offices under your control, to be notified accordingly. So far as this Commission is concerned, these notifications may mention, for general information, that the question of making the registered letter service available for external mails is under consideration.

It is ~~to be~~ noted that requests for powers of attorney, proxies and payment orders to Italy will continue to require clearance from the existing controls in the U.S. and U.K."

2. This notification is confirmed, together with the following points agreed upon in our discussions:-

(a) All mail other than postcards posted as commercial correspondence will be subject to postage at letter rate - i.e. 2.50 lire for the first 20 gms. + 1.00 lire for each additional 20 gms..

(b) The maximum weight for any one letter - private or commercial - will be raised to 1 kg. (Confirmation is awaited from the United Kingdom and United States that they will conform on this point for mail from those countries).

(c) The maximum weight for the internal letter post to be raised to 1 kg. (in view of the increase of the external mail limit). On this point it may be found necessary, in newly opened provinces in A.E.G. territory, to restrict postings from such provinces (but not for them) to the present maximum of 250 gms. at the outset.



Ruling on Business Correspondence

Amplifying a recent U.S. State Department announcement regarding business communications between the United States and Italy, the Post Office Department yesterday listed the types of communications that will be permitted.

These include: replies by US. banks and other financial institutions to request for information from their depositors in liberated Italy; documents such as birth certificates, wills and legal notices, marriage certificates, death certificates; powers of attorney, proxies, and payment orders to Italy, if application is made to the U.S. Federal Reserve Bank for an appropriate license.

In addition, Italian and US . business firms are permitted to exchange business information and correspond on matters relating to the resumption of business relationships.

1. Instances have recently occurred where the "Letter Bills" proper to specific Civil Mails received from abroad, have become separated from the relative bags, before they are received by the Civil Post Offices at Naples or Rome. Details of five cases are shown below:-

2. The five Letter Bills advising these mails were received together in one envelope at the Rome Post Office HQ. Building. Unfortunately the cover bore no indication of the sender's official address.

3. The examination of the correspondence contained in these mails is undertaken by the Censorship officers at the Ferrovie Post Offices of Naples and Rome, and the Bills must therefore have been irregularly treated before reaching those offices.

4. It is understood that Civil Mails for Italy received from U.S.A. are bagged in outer sacks which have to be opened at the Base Post Office before separation can be made for various destinations.

It is possible that the Letter Bills are placed in these outer sacks instead of being enclosed in the actual bags of correspondence to which they refer and that it is at this stage of handling that the separation occurs. This system is not thought to apply to arrivals from Britain, although one of the instances of mistreatment occurred to a bag from London E.S.

5. As it is necessary ^{to} for the Italian Postal authorities to record certain particulars shown on these Letter Bills and to check the number of bags received, with the number advised on the relative Bill, it will be recognized that its arrival with the applicable mail is important to the routine working of the Postal Service. The non receipt of such Letter Bills ^{has} to be reported to the office of origin of the mail.

6. Considerable assistance ^{is} should be afforded the Italian Postal Service if the U.S. and British Army Postal Units were instructed to forward any bills found separate from civil mails with the bag to which they refer. In the event of bags having to be opened to verify whether the contents are Civil or Allied Forces correspondence, the relative labels should again be attached to the bags before transferring to the Civil Post Office.

7. The importance of the correct use of the Letter Bills is particularly stressed at the present time as it is probable that a Foreign mail Registered Letter service will be re-introduced in the near future.

It was at first thought that the letter bills may have been extracted from the relative bags by the Censorship Officers at Rome and Naples but this theory has now been disproved.
2. To ensure however that the Postal officials are able to carry out their routine procedure of checking the number of bags received recording the weight and class of mail and completing the necessary details on the Letter bills (date of receipt and impression of stamp of office of destination etc.) It has been confirmed with the Censorship Group Headquarters, that the mails for examination will be dealt with in the presence of a member of the Sorting office staff at either Naples or Rome Ferrovie offices.
3. As it is possible that the bills were originally enclosed in outer sacks, received with Civilian despatches enclosed and necessarily opened by personnel of the Army Postal services, a communication is being sent to the A.P.O. ~~6756~~ ensure that such bills are forwarded to the Civil Post Offices to which they refer.
4. Will you please arrange to forward the accompanying Letter bills to the respective offices of destination. From the serial numbers of despatches shown on the bills numbered 1 and 2 it is thought the mail was proper to be dealt with at Naples.

1. The Board of Trade announce that by arrangement with the Postmaster General they have made a general licence (S.R. & O. 1944 No.1179) authorising confidential business correspondence with liberated Italy. This step towards the resumption of national business relations with Italy is in accordance with the joint statement of the Prime Minister and President Roosevelt that the application of the Trading with the Enemy Acts must be modified so as to enable business contacts with Italy to be resumed for the benefit of the Italian people. Similar action has been taken in the United States.

2. Banks and other financial institutions may now reply to requests for information from their depositors in liberated Italy, documents such as birth, death and marriage certificates and wills may be transmitted, and British and Italian firms may exchange business information with a view to the future resumption of business relationships. The resumption of private trade is not yet permissible. The despatch of powers of attorney and proxies is subject to normal procedure under the Defence (Finance) Regulations. The postal service is available only to places in certain provinces of liberated Italy which can be ascertained by enquiry at any Post Office. Correspondence for Italy cannot be registered or insured.

3. Italian-owned property in the United Kingdom will continue to be under the control of the Trading with the Enemy Department and the Custodian of Enemy Property. British subjects resident in Italy who desire to obtain a release of their property in the United Kingdom should apply to the nearest British Consul.

4. Arrangements have been made for the release of British-owned property in Italy (private and other property) to its original owner or his authorised agent. Applications and enquiries by persons in Italy should be addressed to the nearest British Consul and by persons in the United Kingdom to the Consular Department of the Foreign Office. Some prima facie evidence of ownership should be supplied but the original document of title should not be forwarded unless specifically requested.

Examination by Censorship Officer

1. Considerable difficulty is being caused to the Postal Officials at some sorting office through the present arrangements made in connection with the Censorship examination of incoming mail from abroad.
2. Whilst it is recognised that the full normal postal routine cannot be fully carried out by the officers examining the mail, everything should be done to avoid confusion to the Postal Staff when the mails are transferred to the Civil Post Office Staff.
3. In the cases under report, it will be readily recognised that the some Post Office were unaware of "the number of bags" advised in any of the despatches to which the five accompanying "Bills" (feuille d'avis) refer, for in each case these advices were retained by the Censorship Office instead of being sent to the Post Office with the correspondence contained in the relative despatches. The dates of arrival are uncertain as the Bills have not been stamped with a date stamp.
4. In some instances it is stated, that a mail originally received in say 4 bags is transferred to the sorting office in two or three bags. A check of the number of bags received, is essential, as an advice of non-receipts ~~has to~~ be sent to the Originating Office.
5. The Post Office have to prepare records of weight of mail received under the separate headings of "Civilians" and "POW" arrivals. Particulars of such weights are usually recorded on the neck label of each mail bag, but the relative labels are rarely again attached to the bags after opening in the Censorship Office.

6. In the cases of the Bills numbered 1 and 2 (in red) it will be seen that the mails to which these advices refer are due to have been dealt with at Naples and not Rome. Although the headings have been partially deleted, serial numbers "78" and "91" cannot have been yet reached in the New-York - Rome series. Naples in the meantime has without doubt reported the non-receipt of these despatches to New York.

7. To avoid all such irregularities, can it please be arranged for instruction to be given to the officers responsible for opening the mails, to preserve the normal make up of the mail, re-tie the corresponding label to the bag to which it refers, and replace the Bill in the bag in which it was received. Under ordinary international postal arrangements the label of the bag containing the Bill is additionally marked with the letter "R", but at present when the mail is received at the Post Office no indication remains to show in which bag the Bill is to be found and an unsuccessful search is often made of all the correspondence. If necessary a Postal Officer from this Sub-Commission would explain the necessary procedure to be followed.

8. If in your opinion these details of work of a purely postal nature would cause difficulties to the Censorship personnel, will you consider the following possibilities in re-arranging the present routine.

(a) Recognising that incoming mail is only examined to verify that it has been censored and not a complete censorship of the correspondence, could not the examination be made at the Rome Ferrovie Sorting Office. On arrival of the mail at the Sorting Office, the Censorship Office could be informed by telephone and a Censorship Officer proceed to the Ferrovie Office and complete the necessary examination, whilst the Postal routine matters would be undertaken by the Post Office personnel.

(b) If the mail must necessarily be conveyed to the Censorship Office, could arrangements be made for a Post Office employee, (to be detailed by the Director of the Ferrovie on being informed by telephone from the Censorship Office of the arrival of foreign mail), to undertake the postal routine work in the Censorship Office.

9. The importance of this work is especially stressed at the present time, as it is possible in the near future for registered correspondence to be included in the mails received from abroad.

2. In the light of TAM 320 and report of U.S. Post Office Dept announcement of 30 Oct (reported in Basic News of 1 Nov) it is now possible to make an announcement to the Italians in the following sense:

Italian business firms are now authorized to correspond with firms in the United Kingdom (reference your signal 5488 of 26 Oct) and U.S. firms on matters relating to the future resumption of business relationships and exchange of business information.

Individuals and firms in liberated Italy may request information regarding the status of their pre-war deposits in US and UK banks and other financial institutions and may also request documents such as birth certificates, marriage certificates, death certificates, wills and legal notices.

3. It is to be noted that requests for powers of attorney, proxies and payment orders to Italy will continue to require licence. (see TAM 320 ~~and para. 3~~ of Basic News of 1 Nov).

4. When you are in a position to let this HQ know what weight can be handled (see paragraph 4 of TAM 335) this HQ will, in the same cable to CCS, seek more specific clarification of the particular types of communication which are permitted. The above however will enable an initial public announcement to be made in Italy.

1. Reference is made to G-5/383.8 of 15 Oct. (marked attention Finance Sub-Commission) to which you replied in your 13053/F of 22 Oct. and enclosed therewith a copy of a memo addressed to your Finance Sub-Commission by the Director of the Communications Sub-Commission. It is understood that the latter Sub-Commission are now mainly handling the matter.
2. Attached is a copy of TAM 335 received here today. Your comments are requested on it urgently and particularly on the question of weight to be allowed. In this connection it is felt that your answer will naturally be closely bound up with the views expressed by you recently on the question of the limited parcel post traffic from the U.S. and you are requested to state definitely whether you can handle more than 40 grams in weight for any commercial or financial communication.
3. So far as any public statement in Italy on the matter is concerned it is considered that this must be delayed until it is definitely known what the United States and British authorities are actually allowing to be sent. Clarification of this will be sought from both sides when you have been able to reply to the query about weight which you can handle and the relaxations or renewals you propose with regard to registration of letters and cards.

Resumption of commercial and business communications with liberated ITALY.

The present practice of UNITED STATES Postal Censorship regarding closed letter mails is to sort 100% against watch lists and to read 50% of mails to ITALY and 25% of mails from ITALY, which UNITED STATES censorship regards adequate for Western Hemisphere security and controls. The word "adequate", as used in Paragraphs 1 and 2 of your cable is assumed to mean the above unless UNITED STATES censorship finds that a lesser percentage will suffice or unless UNITED STATES censorship manpower declines to a point where an adjustment of percentage must be made, in which event you will be informed. Is such an interpretation satisfactory for the Italian Theater as far as UNITED STATES mails are concerned?

The Post Office Department desires to ascertain whether any of the existing prohibitions on registration, insurance and airmail may now be removed or relaxed, particularly with reference to registration of letters and cards.

"Following on the announce given yesterday by President Roosevelt, of the ^{lightening} ~~relaxing~~ of certain restrictions, which had been applied to the commercial reports with Italy, in connection with the law on the "commerce with the enemy", the Treasury ~~the~~ Ministry details that no particular permit, by the Ministry itself, will be necessary for those communications, which will not have the character of effective financial or commercial transactions - For instance, the Banks and other financial agencies may reply, without any particular licence, to request for informations from their account holders in liberated Italy; documents, such as birth, death and wedding certificates, may also be transmitted, as well as legal informations

The Treasury Ministry has also ~~not~~ informed that Italian & U.S. firms ~~can~~ may ~~to~~ exchange commercial correspondence and correspondence in order to re-establish their ~~com~~ contacts - However no permit will, for the present, be issued for private commercial transaction, because commerce with Italy is actually operated only through Governmental Agencies."
