1. With reference to correspondence from the Director, Communications Sub-Commission under reference CS/4/7, dated 3th August 1944, respecting the above named, the following is submitted for information.

2. Subject was born in London on 13th November 1884 of Italian parents. He is now living at Via Sistina 27, and his business address is 3 Piazza Mignanelli. He was inscribed in the Fascist Party in 1923.

3. In 1923 he was suspected by the Italian authorities of assisting Germany politically and commercially against the interests of Italy, however investigations did not result in any positive proof. At this time he was connected with a firm at Milan in the manufacture of precision instruments, and also acted as a technical adviser to SIEMENS of Berlin and another firm trading in the same city under the name of HALSC. His connections with German firms dates back to 1910.

4. He was appointed a Knight of the Italian Crown in 1933.

5. Records show that he was granted visas for all European countries except Russia and Spain. In 1940 he was in Germany.

6. S.I.M. (Italian Military Information Service) in 1943 ordered that AUTERI's correspondence with Germany was to be censored as he was interested in the patent of an instrument for naval and aeronautical purposes. This patent was later sold to Germany with the consent of the Fascist Government.

7. Information has been received that during the early part of 1944 he was in Germany.

His connections with German firms dates back to 1910.

4. He was appointed a Knight of the Italian Crown in

1933.

5. Records show that he was granted visas for all European countries except Russia and Spain. In 1940 he was in Germany.

6. S.I.M. (Italian Military Information Service) in 1943 ordered that AUTERI's correspondence with Germany was to be censored as he was interested in the patent of an instrument for naval and aeronautical purposes. This patent was later sold to Germany with the consent of the Fascist Government.

7. Information has been received that during the early part of 1944 he worked with a German firm on radio receivers for submarines.

8. The foregoing shows AUTERI was a close collaborator of the Germans but I am unable to obtain definite evidence that he assisted the removal of equipment to northern Italy and Germany.

1. Inclosed is copy of letter from Siemens Societa Anomina addressed to A.C.C. dated July 29th, 1944.
2. The questions contained in this letter were referred to the Property Control Sub-Commission which after careful consideration of the problem involved has ruled that A.C.C. has no jurisdiction except to the extent that questions of security or intelligence may be involved.
3. As no such questions involving Allied interests appear to be involved the answer to the questions raised in Siemens' letter of July 29th are a responsibility of the German Government.
4. One of the telephone installations previously maintained by Siemens was the PBX of the Ministry of Corporations building now occupied by A.C.C. HQS. For security reasons it was not deemed wise to have a German controlled firm continue to maintain this installation.
5. It is requested that the Ministry of Communications reply to the questions raised in Siemens' letter.
6. Attention is drawn to the fact that there are several Italian controlled concerns in Rome fully as capable as Siemens to do the work previously carried out by them.
7. Delay in reaching a decision as to handling this matter is regretted.

MEMORANDUM FOR THE A.C.C.

The Firm "Siemens Societa per Azioni", in Milan is an Italian Society, not only lawfully, but also effectively, because it has its manufactories and its clients in Italy and employs only Italian personnel and workmen.

As it is authorized to use all patents and fabrication methods of the German Siemens, the last retains the majority of the Italian Siemens shares.

In consideration of this bounding with a German firm, I was very busy - as soon as Rome was liberated - with looking for a leading person of R.A.C. who could be able to give me instructions concerning the future desired activity of Siemens Rome Office.

In the first days it was impossible for me to find out a competent man to give me such instructions.

On the 12th of June I spoke with Brig. Gen. Buchanan, Chief of "Wire Board Command" in Piazza Foro Traiano 1, and I gave him the here enclosed notices.

The Brig. Buchanan was so kind to take vision of them and express his advice that the overaid Branch directed by me could go on with its actual works.

As I think, that at present, such arguments are in the line of A.C.C., I allow myself to ask for a kindly communication on the following points:

A) May the Roman Office of Siemens Milan continue its activity in the present way?

The commercial possibilities after September 1943 of Siemens Rome were considerably reduced by the German Command which took and carried away all the materials from our store in Via Frattina.

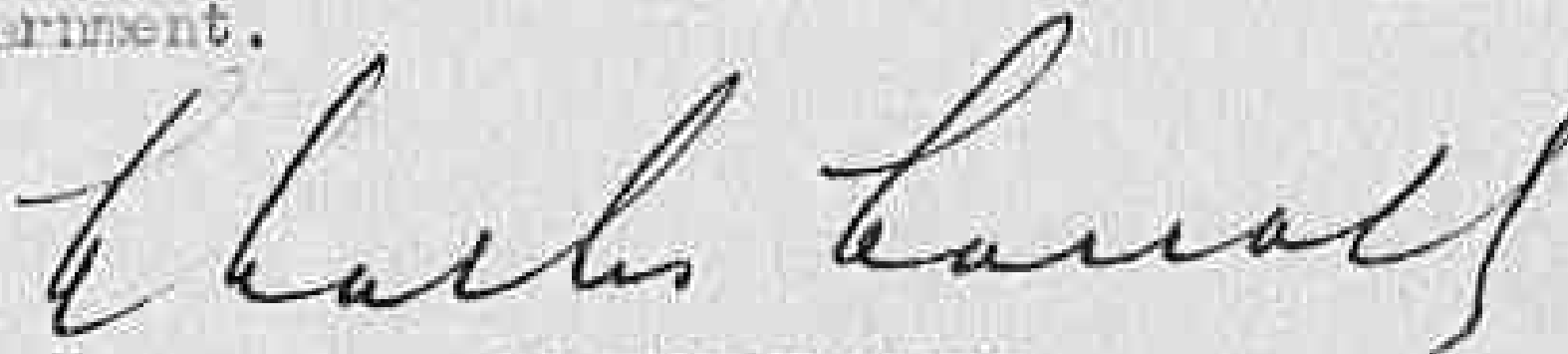

1. Reference your letter CS/61/1/1 of 3 Aug 44.
2. I am enclosing copy of letter from RCP Region IV, which led me to believe that there was nothing more to be done so far as your inquiry was concerned.
3. Today Major King informs me that you do want a reply to your original inquiry so that you may write to Auteri.
4. Property Control sub-commission has no jurisdiction with respect to property of German nationals located in transferred territory, and it is my opinion (which I suggest you check with Legal Sub-Commission) that ACC has no jurisdiction except to the extent that questions of security or intelligence may be involved. In all other respects German property is the responsibility of the Italian Government.
5. It seems to me that Auteri should be told to direct his inquiries to the Italian Government.

Al

L'Ufficio Tecnico Regionale di Roma, della Siemens Società per Azioni di Milano (il cui capitale Azionario appartiene alla casa Siemens di Berlino) ha la sua sede in Piazza Mignanelli N° 3 Roma. Ha anche un deposito in Via Frattina N° 50 ed un negozio di Fotoriproduzione ove il pubblico porta disegni, documenti commerciali etc. per la immediata riproduzione (circa 10 minuti).

Prima dell'attuale guerra i più importanti clienti del nostro Ufficio erano:

- La Società Telefonica Tirrena, concessionaria di tutti i servizi telefonici pubblici del Lazio, Toscana e Liguria a cui fornivamo le centrali telefoniche automatiche per Roma, Firenze, Genova e rispettiva regioni;
- Il Ministero delle Comunicazioni al quale direttamente e assieme con la nostra Consociata S.I.R.T.I. di Milano (fornitrice della rete telefonica Nazionale in cavi sotterranei) fornivamo materiale telegrafico;
- I Ministeri della Marina e dell'Aeronautica per apparecchi telefonici, telegrafici su filo e per radio

Questi apparecchi vengono prodotti quasi esclusivamente a Milano nelle fabbriche della nostra società, ove si fabbricano anche apparecchi Radioriceventi, Apparecchi di elettromedicina etc. del ramo cosiddetto delle correnti deboli (Siemens & Halske)

Nel ramo delle correnti forti (Siemen Schuckert) i nostri più importanti clienti erano le grandi Società di produzioni e di esercizio di energia elettrica. Il materiale per tali forniture veniva in gran parte importato dalle Fabbriche Siemens di Germania, ad eccezione dei Contatori elettrici, prodotti nella nostra fabbrica ISARIA di Milano, e di tutti i carboni per speciali impieghi elettrici (forni elettrici, illuminazione ad arco, spazzole per macchine elettriche, carboni per pile elettriche etc) che vengono prodotti nelle nostre Fabbriche di Narni e Macerata (Società Forni Elettrici ed Elettrocarbonium)

Verso la fine dall'anno 1943, data la estrema riduzione dei mezzi di trasporto e conseguente impossibilità di ricevere Merci e anche di corrispondere e ricevere mezzi finanziari da Milano, dovemmo sospendere quasi interamente la nostra attività più importante e licenziare quasi tutto il nostro personale.

Conservammo solo 12 impiegati e 18 operai, scelti fra i più anziani e con più familiari a carico, che potevano da noi venire occupati per la manutenzione di impianti telefonici da noi forniti per il servizio interno di vari Ministeri, Enti Pubblici e

e Privati, Banche; per la manutenzione degli impianti elettrici di trasporto corrispondenza dell'Amministrazione delle Poste; per il funzionamento del fotoriproduttore in Via del Gambero, angolo Via della Vite.

Un deposito di materiale elettrico del reparto "Luce e Forza", situato in Piazza di Spagna N° 9, nel quale erano rimaste soltanto alcune migliaia di carboni speciali per lampade di proiezione cinematografica, venne da noi ceduto a due nostri ex impiegati di detto reparto, allora licenziati, perchè ne curassero la vendita in proprio e potessero così venire agevolati nella loro attività.

Le possibili risorse commerciali del nostro Ufficio di Roma, erano anche state notevolmente ridotte dopo il settembre 1943, perchè le Autorità militari germaniche dopo aver apposto i suggelli ai nostri depositi di materiale telefonico, radiotecnico, di elettromedicina etc, ci diedero ordine di imballare tale materiale che fu da essi trasportato a Milano con automezzi militari, ivi comprese due automobili Fiat dei nostri piazzisti, consegnate poi alla Siemens di Milano.

Con l'attuale personale e materiale rimastici, il nostro Ufficio può fare ben poco più di quei lavori di manutenzione di impianti telefonici ai quali ora accudisce. Se però lo desiderassero le competenti Autorità, ci sarebbe possibile - data la nostra esperienza e conoscenza della piazza di Roma - di aumentare la nostra sfera di attività, con la riassunzione di operai e impiegati licenziati ultimamente e con la ricostituzione di scorte di quei materiali che fossero indispensabili alla esecuzione di nuovi lavori richiesti.

Scopo del presente breve memorandum, è di chiedere alle competenti Autorità Alleate di Roma, quali siano i suoi desideri e le sue direttive, circa il futuro proseguimento, o aumento, o riduzione della nostra attività, ciò soprattutto per avere sicuri criteri, nell'interesse degli impiegati ed operai da noi dipendenti.

Information to the Allied H.Q.

The local technical office of the Ltd. Siemens Company, which has its seat in Milan (the whole lot of shares belongs to the Siemens Company of Berlin) is located in Rome, Piazza Mignanelli No. 3 - In Via Frattina No. 50. The company has also a store and a shop for the photographic reproduction of drawings, documents, etc. (the operation is performed in about 10 minutes).

Before the actual war the most important customers of our office were:

- The Societa Telefonica Tirrena, dealing with civil telephone communications in the Provinces of Lucca, Toscana, and Liguria. We supplied this company with the automatic exchanges for the towns of Rome, Florence, Genova, and the above mentioned provinces.

- The Air Force and the Navy that we supplied with telephones and telegraph sets

- The Ministry of Communications that we, as well as the Sirti Company, supplied with telephone and telegraph material.

All the above mentioned apparatus were constructed on the whole in the factories of our company in Milan. In the same factories are also built radio receiving sets, electro-medical sets, and everything concerning the branch known as the weak power one (Siemens and Halske). As far as the branch of high power is concerned (Siemens Shuckert), our most important customers were the big electric companies. The necessary material for these constructions was imported on the whole from the Siemens factories in Germany, apart from the electric recorders which were made by our ISARI factory in Milan, and apart from the carbons for special electric uses (electric kilns, carbons for batteries, brushes for electric engines, etc.) which are produced by our factories in HANAU and KASSEL (Electric Kilns and Electrocarbonium Company). About the end of 1943, owing to the difficulties of transports, our activity was nearly stopped, and we were obliged to dismiss nearly all our staff. We only kept 12 clerks and 18 workmen, dropping the eldest ones and the ones whose family was more numerous. We employed these people for the maintenance of installations and telephone lines previously built by us. We had some thousands of special carbons for cinema apparatus left in our store in Piazza di Spagna 9. We entitled two of our former employees that has been dismissed to sell these carbons on their own account so that they could have a little profit. All the rest of our stores in Rome and two Fiat cars used for commercial purposes were taken by the Germans in September, 1943, and sent to the Siemens Company in Milan. At present, of course, our office in Rome cannot do much more than the work of maintenance that it actually performs. But certainly it could be very easy for us, if required, to increase again our staff and start again our former activity.

The reason of this notice is to know whether the Allied Authorities in Rome think to increase or not our activity, and we are asking that, on behalf of the clerks and workmen, that we formerly employed.
