When I took over the AMG Communications of Udine in May '46 one of the first things that I had pointed out to me was the weakened floor structure of the apparatus room of Udine Repeater Station.

The factors contributing to this state of affairs have been, heavy cementing against bomb blast, bomb blast itself and overloading the place with apparatus. It is estimated that at the present time the apparatus room is 80% overloaded.

From time to time I have reported this state of affairs and recently an Engineer was sent up from Rome to investigate and my opinion was confirmed that something must be done quickly.

However, the great difficulty arises of how it is possible to effect the necessary repairs and at the same time maintain the services. Apparatus must be moved so that the flooring can be shored up into place and owing to the limited floor space and the type of repairs to be carried out it would mean that the portable apparatus would have to be cleared from the floor. At the present time this apparatus consists of:

(American) 2 Sets C.F.I. 2 Hybrids and 6 Ringers

(British) 5 comp. Sets C.F.2. and 1+4.

The total weight is approx. 3 Tons.

Today in Udine I met representatives from the Azienda di Stato and a structural engineer from a firm in Udine. This latter is very definite that any temporary repairs are to be avoided and that before anything can be done it is absolutely necessary to relieve the floor of as much weight as possible.

To this end, and bearing in mind that something must be done quickly, it is proposed that the engineering firm will prepare the ground floor to receive all the equipment mentioned above. The firm will knock down a partitioning wall and install heating apparatus for the protection of this apparatus and personnel. The space thus provided would be more than adequate for military equipment needs.

It is understood of course that before anything can be done the C.S.O. G.H.Q. must be consulted. The question of availability of duplicate apparatus, cabling and racking would have to be gone into. The Italian personnel would assist in any way possible but I believe that extra British assistance would be required.

The main point is that something must be done immediately

In the few months that I have had Udine this trouble has gradually increased such that compared with a month or two ago the difference in bulge in the ceiling over the charging panel on the ground floor is definitely noticeable. A fortnight ago 88 Division wished to install another C.F.2, so far it has not arrived but when it does it must go on the ground floor.

If the C.S.O. G.H.Q. is able to provide the duplicate equipment the transfer could be effected without any interruption of the military services and the whole work could be completed in a fortnight. If the equipment is not available something will have to be done just the same otherwise the Azienda di Stato cannot hold themselves responsible for what may happen in the future.

Two projects are being prepared by Ing. Dani of Azienda di Stato which he is forwarding to Rome immediately. The first is for the preparation of the ground floor to receive the military apparatus and the second is for the repairs and strengthening of the apparatus floor. It would hasten everything if the Director Communications Division could persuade the Direttore Generale Azienda di Stato to give his immediate sanction to both projects. In any case, the first is a military necessity and when completed would

allow the civilian personnel free access and would be of benefit to both sides.

It is estimated that the first project could be completed in a week and the transfer of portable equipment could also be completed in a week. I have definitely stipulated that adequate heating arrangements should be made in the new position.

## 1. ADMINISTRATION.

(a) Now that 13 Corps have moved from this Zone the title of this HQ is now AMG Venezia Giulia and not AMG 13 Corps.

(b) The C.S.O. 13 Corps has delegated most of his authority to O.C. 1 L. of C. Regt. who in turn has passed a certain amount on to the Trieste Area Signals Officer. Gorizia continues to remain under the control of the Signal Officer 88 American Division.

(c) The Chief Finance Officer is sending a letter (with the S.C.A.O.'s approval) to AFHQ pointing out the need for a definite policy for payment for Army Services from AMG funds. There are many items affecting many Services included in which is the payment to the Concessionaire Company for Telephone Services and work done for the military. The letter will ask the C.S.O. AFHQ for a closer check and greater economy to be kept on telephone apparatus and work done on military installations.

(d) As the result of my visit to Rome arrangements are being made for the loan of an Inspector Director to visit me in the near future to go into the question of staff problems, employment conditions, etc.

## 2. TECHNICAL.

(a) As the result of the move of 13 Corps the ex military telephone circuit Trieste-Milan has been taken over for civilian use. This makes two circuits Trieste-Milan. I have instructed the Direttore Azienda di Stato to keep a careful record of all military calls made over either of these circuits and in addition to maintain a record when the circuit is used by the Welfare Service for the Troops Telephone service to the U.K. At the present time this service operates on Mons, Weds and Pris from 1700 hrs to 2200 hrs.

(b) Until 13 Corps staff are completely clear

of the area it is difficult to say just how much will revert to civilian use. I hope to get back/

- (i) The three U.C. pairs Trieste-Monfalcone
- (ii) The whole of the O.W. route (11 pairs) Trieste-Duino-Monfalcone.
- (iii) At least 100 subs positions on the Trieste-Auto.

(iv) The 07 level taken for 13 Corps switchboard. and reduce congestion considerably.

Later, endeavours will be made to reduce the number of positions occupied by the military on the Azienda switchboard or if possible terminate long distance circuits on a military switchboard.

The following circuit was taken over from military for civil use:

3. UDINE.

(a) Could the Director get in touch with the Director General of Azienda Stato with a view to commencing work immediately on the repair of Udine Repeater Station. The building suffered from bomb damage such that the apparatus floor is weakened. About six weeks ago I accompanied Ing. Dani (Azienda Stato Venice) over the building and notes were made of what was required but nothing further has happened. Recently (due to the move to Padova) more apparatus has been put in the building and the floor is now well overloaded. I believe to the extent of 80%.

If the Azienda do not wish to do anything I propose to get a surveyor to overhaul the building and if necessary effect temporary repairs.

As the result of complaints made by the local Signals Unit in Udine against the TELVE Personnel and the Technician of the Repeater Station (Azienda Stato), I have made enquiries and I have formed the following conclusions.

The Dirigente in charge of the Repeater Station is weak and I have asked Rome to have him removed.

The Director of TELVE and his Engineer however have made counter complaints which, I am bound to say may have some foundation.

They allege that there are many people from whom they may receive orders and sometimes counter orders.

That the Signals have complete control over their main frame and that since May '45 much work has been done by the Signals Unit on the TELVE circuits and they have only a hazy idea of what it has all been about. They are not allowed to run a circuit over their frame without the authority of the military (of course they do not carry out this instructions to the letter otherwise their work would stop, but officially this is so).

Further and what I consider is most important they do not use Works Orders. During operations nobody has time for Works Orders but in static conditions I think it is the only way of getting things done with any degree of accuracy and eliminating that muddle which could occur where many people give orders.

I should like to suggest that the military are taken off the TELVE frame and the civilians allowed a freer hand with their own apparatus, after all they have been running it since it was built and are therefore more efficient. I think I can safely say that in no other town in Italy have

the Signals interfered with circuits at the frame terminations.

A further allegation is that extra keys of zone boxes have been made to enable the military to go in at any time and make cross connections. This has often been done with no later reference to TELVE.

I am suggesting that there is a deal of truth in these statements because I have spoken in a general way to one or two O.R.s working in the Repeater Station, and they complain of interference from TELVE, lack of cooperation and so on.

I agree that this Concessionaire company is different from any other in Italy and there are many reasons why this is so but I would suggest that better cooperation would be obtained if there was less interference from, perhaps N.C.O.'s and a closer cooperation by O&C Units with the Director Himself and not the Chief Technician or Head Lineman.

Further, I would suggest that a system of Works Orders is instituted without delay.

SUBJECT : Italian Legislation Udine Province.

TO : Chief Commissioner and Executive Commissioner,  
All Sections and Sub-Commissions.

1. Your attention is invited to the enclosed draft order which it is proposed to publish in the Italian Official Gazette.

2. As you are aware, problems are bound to arise due to the fact that the Province of Udine will continue to be administered by AMG until further notice.

3. For the purpose of Italian Legislation the Province of Udine will be treated in the same manner as the rest of the territory which is now being restored.

4. Decrees previously implemented in the said Province by the usual AMG orders will continue to be regarded as having come into effect on the date provided for in the said orders and not on the date of the "handover".

5. A number of Decrees have, however, been modified by AMG implementation orders, especially in relation to the dates from which certain benefits granted under the provisions of a decree would accrue or various tariffs established by decree would enter into effect. All such modifications will remain in force unless expressly abrogated.

6. It is therefore suggested that Sections and Sub-Commissions discuss as soon as possible the problems arising out of the special position of the Province of Udine with the Italian Ministries concerned taking into consideration the provisions of the enclosed draft order.

## DRAFT ORDER

WHEREAS the Allied Military Government in Italy will be discontinued on 31 December 1945 except in Venezia Giulia and in the Province of Udine ,

Now, therefore, I, M. Carr, Brigadier, G.B.C., M.C., in the name and on behalf of the Chief Civil Affairs Officer, Allied Military Government , hereby order as follows:

1. The decrees listed in the schedule below which have been previously excluded from Allied Military Government territory or certain parts thereof including the Province of Udine shall become operative and shall have full force and effect of law in the Province of Udine as from the 1st January 1946.
2. All decrees promulgated in the Gazzetta Ufficiale issue No. 144 of 1st December 1945 and in following issues shall until further order become effective in the Province of Udine on the same date as in the territory administered by the Italian Government without an express order of the A.M.G. to that effect. Provided, however, that the Provincial Commissioner of the said Province shall have power to suspend or modify in part or in full by Provincial Order the provisions of any decree contained in any of the aforementioned issues of Gazzetta Ufficiale as applied in the said Province.
