PWB has:

1. Taken over some of the employees, discharged some, others left. Those employed are radio technicians, linemen, etc. paid by PWB.
2. PWB controls everything except the radio tax collection.
3. The tax collectors are not employed.
4. PWB occupies all rooms in the studio except two occupied by the tax collection section.
5. These two rooms are required by PWB and the furniture.

Finance AMGOT say:

1. Tax organization to continue. Radio tax L. 82 per annum.
2. The tax law is still effective.
3. The tax is being collected.
4. Finance are investigating the bank account.
5. Tax section to be paid by Finance.
6. Section to vacate rooms only if others found.
