- Reference is made to the meeting held at A.F.H.Q. on 23 June 45, attended by Lt. Col. Fernyough of this Sub-Commission, at which the above subject was discussed.
- G-4 (A) stated that they were prepared to hand over to A.C. (Truck Maintenance Group) all maintenance and repair equipment, culled from P.B.S. to 1,2,3 Truck Bns, which was needed by the Truck Maintenance Group. The Truck Maintenance Group is preparing a list of equipment which it is desired to retain for submission to G-4(A) as agreed at the meeting.  
Meanwhile sufficient equipment for 1st. Ech. Maintenance, is being handed over to Truck Pools, to which the vehicles are being assigned ex 2 Truck Bn. Disbandment of 2 Truck Bn. commences 2 July.
- G. (A E) undertook to release the Truck Maintenance Group equipment for 461-466 L.A.D's based on scale 6058/7 and S.E.L. 308/1 ( authority A.S.D/922.8 (B) 1 dated 23 April 45 ). 221, 222, 225 and 226 I.E.Coys A.C. are now collecting a limited quantity of equipment for 461, 462, 465 and 466 L.A.D's. It is not known what equipment has been received by 223 and 224 I.E.Coys at TRAMI for 463/4 L.A.D's.

2. G-4 (A) stated that they were prepared to hand over to A.C. (Truck Maintenance Group) all maintenance and repair equipment, on loan from P.E.S. to 1, 2, 3 Truck Bns, which was needed by the Truck Maintenance Group. The Truck Maintenance Group is preparing a list of equipment which it is desired to retain for submission to G-4(A) as agreed at the meeting.

Meanwhile sufficient equipment for 1st. Ech. Maintenance, is being handed over to Truck Pools, to which the vehicles are being assigned ex 2 Truck Bn. Disbandment of 2 Truck Bn. commences 2 July.

3. G. (A E) undertook to release the Truck Maintenance Group equipment for 461-466 L.A.D.'s based on scale 5058/7 and S.E.L. 308/1 ( authority L.S.E./522.B (B) 1 dated 23 April 45 ). 221, 222, 225 and 226 I.T.Coys A.G. are now collecting a limited quantity of equipment for 461, 462, 465 and 466 L.A.D.'s. It is not known what equipment has been received by 223 and 224 I.T.Coys at TRAMI for 463/4 L.A.D.'s.

Will you please ask G. (A E) to discontinue issue of equipment to the 6 L.A.D.'s in view of disbandment and to release earliest the balance not yet issued to the Truck Maintenance Group, who will collect on advice of outstanding items and issuing depots. **2452** is urgently needed for maintenance in **2452** tools.

Meanwhile the Truck Maintenance Group has been instructed to withdraw equipment held by the L.A.D.'s on disbandment and to issue 1st. Ech. Scale to Truck Pools receiving trucks ex 211 - 216 I.T.Coys ( A.C )

4. G. (A.E.) also agreed to release to the Truck Maintenance Group the equipment held by 457 - 470 L.A.D.'s (att. 227-

543/6

230 I.T.Coys -- ex 1000, 1001, 1002 and 1004 Italian G.T.Coys ) when these units are disbanded on 1 August or later .

These I.A.D.'s were formed on 15 May under authority A.P.H.A. letter G-1 (RR) 1026/A.1 (Ser R320) of 25 May, with equipments on Basic Equipment list 6098/7 and S.E.L. 308/1 .

5. It is requested that you will urge C (A E) to notify this Sub-Commission of formal approval to hand-over to the Truck Maintenance Group all L.A.D. equipment mentioned in paras 3 and 4 above and to turn over to the Italian Government with the New Truck Tools at a later date .

6. Will you please let us know whether G-4 have any further information re-arrival date in Italy of the tools mentioned in para 3 of A.P.H.A. letter AG 537/177 G.D.S. - O dated 13 May 45 .
