

1. Attached is letter from HQ. AMG. LAZIO-UMBRIA Region Ref. AGR/LUR/161 - undated, but received in this office 27 March '45. (2)

2. The letter refers to a telephoned request from Capt. Keim on 23 Mar. '45 for movement of straw & hay from warehouse in Rome to FUSCOLANA Station for movement by rail to CIVITAVECCHIA. The telephone call came at a time when Mr. Bompard of ENAC was in this office & he said he would make immediate arrangements, which he did by telephoning his H.Q. from this office. No orders were given by this office to Mr. Bompard. Capt. Keim was later telephoned & informed that rail arrangements had been made & that ENAC had made arrangements for the lift from warehouse to Rly station.

3. In reference to para 3 of Lazio-Umbria Region letter, it cannot yet be confirmed by Lazio-Umbria Region that any application had in fact been made to the Inspector of Agriculture for a permit to move the hay & straw (telephone conversation Cotterill/Stait Gardner 1200 hrs 28 Mar.) If an approval had been obtained it would appear that the action of the, ENAC representative referred to was justified.

SUBJECT Request for transportation.

TO Major Stait Gardner,
Transportation Sub-Commission (Roads)

1. Reference telephone conversation Major Stait Gardner-Capt. Ker Eric O. Lazio Umbria Region concerning the authorized use of trucks by ENAC to transport hay and straw to Tuscan Station for shipment to Civitavecchia on the account of Berico Arati, Via Balbo No. 3, phone 42760.

2. As per telephone instructions received from you we advised Signor Arati of the arrangements you had worked out namely for ENAC to transport the hay to the Station thence to be expedited by rail to Civitavecchia 24 March 1945. His secretary proceeded to the ENAC office on the above date filled out the necessary forms with cash in hand to pay the charges.

3. The individual of ENAC whom he contacted advised him that for the movement of hay he needed the approval of the Inspector of Agriculture and refused to act despite orders received by ENAC from your office. Thus the movement did not take place as planned.

4. It may be that we are disappointed in putting it mildly. However we are not surprised because every other previous attempt of this office to make use of ENAC transport has been a gross failure and we have studiously avoided any contact whatsoever with their unwieldy machinery so clogged with red tape as to be useless for any action that requires promptness in its execution.

TO : Transportation Sub-Commission, HQ., Allied Commission.

1. Will Food Sub-Commissions please be advised that losses of food by pilfering are continually taking place from the W.D. trucks hauling food from the Livorno warehouses to Army and Regional Area warehouses, after the trucks have left the warehouses. Such losses as are reported in detail to the warehouse staff are made the subject of reports but many losses come to the attention of the office indirectly and long after they take place. The warehouse C.O. does not believe that such losses, in total exceed 1% of the total food hauled. This date, a telephone call advised that a truck had been located which with its load of barley, had been "hi-jacked" about 2 weeks ago. Recently large, sealed, steel drums of lard were shipped by trucks of the 1st Truck Bn. to Florence. It is now reported that several of the drums arrived at destination with the head removed and up to half of the lard content removed. Barrels of powdered milk have been reported opened in transit and apart of the contents removed. Shortages occur in the number of packages and boxes received.

2. Before leaving the Livorno warehouse, the driver of each truck signs a "Tally Out" as having received the goods. Two transfer sheets are furnished the driver of each truck, showing the goods moved and the destination. One sheet is to be left at the receiving warehouse and the other signed by the warehouse foreman and returned to the Truck HQ for transmission to the warehouse at Livorno. Only about half of these forms are returned to the warehouse.

3. The Warehousing Section of this Division, can assume no responsibility for safeguarding commodities once they are checked out of the warehouse on to the trucks as it has no guards to accompany the trucks.

4. The Region has no control of the trucking units generally used to haul from the warehouses; they are usually P.B.S., 5 Army QM Units of trucks of the A.C. 1st Truck Bn.

If the guards were stationed at any point other than at or near the truck companies, it would not be possible to return the guard to his quarters at the end of a day's trip.

6. The warehouse at Livorno will continue to issue food for transportation on unguarded trucks until orders are received from Food-Sub-Commission, AC, to the contrary.

SUBJECT : Proposed Bus-Line to Rome.

TO : Officer, Hq. Emilia Region.

1. The Società Italiana Aero-Motore Italia Centrale (SIAMIC), via Usberti N° 1 Bologna, was organized about 1928 and operated bus-lines in northeastern Italy, and in 1943-4 also ran a once-a-week bus from Bologna to Rome. The Società has now made application to me for a permit to resume the Bologna to Rome line on a once a week or twice a week basis.

2. For equipment the Society has :

- a) a 1938 Fiat 621 RN, with places for 26 Passengers; 40 hp; diesel motor; six tires in fair condition with two spares; present mileage about 50,000 Km. I have inspected this bus and it looks like it could do the job.
- b) also a 1940 Fiat 626 RN, with 28 places, 50hp, 6 tires plus 2 spares, also about 50,000 Km. mileage.

This vehicle is of a later model, and is now at Padua undergoing certain small repairs. It was stated that this bus would be brought to Bologna in good condition in a week or ten days.

3. In addition to passengers the bus could carry up two quintals of mail on a trip.

4. The Rome terminal would be at Ministry of Transportation, via Nomentana.

5. The proposed tariff would be 900 Lire per passenger each way.

6. For motor fuel the requirements would be 400 liters

 - b) also a 1940 Fiat 626 RN, with 28 places, 50hp, 6 tires plus 2 spares, also about 50,000 Km. mileage.
This vehicle is of a later model, and is now at Padua undergoing certain small repairs. It was stated that this bus would be brought to Bologna in good condition in a week or ten days.
3. In addition to passengers the bus could carry up two quintals of mail on a trip.
4. The Rome terminal would be at Ministry of Transportation, via Nomentana.
5. The proposed tariff would be 900 lire per passenger each way.
6. For motor fuel the requirements would be 400 liters of diesel oil (Naphta) for the round trip, with half (200 liters) available at each terminus.
7. It is the Società's proposal that only full-trip passengers be carried, so there would be no en-route stations.
8. The need for such bus service is very great, especially for transportation of officials on public business. The amount of naphta consumed would make unnecessary the expenditure

of a much larger quantity of petrol now used by many small vehicles which carry two to four people to and from Rome. The Società has offered to give all public official requests the priority on space booking.

9. There is no fuel available here for this enterprise, but the authorities at Rome could make an extra allocation for the necessary amount at each end of the trip.

10. I recommend the establishment of this service and request that this letter be forwarded to the Transportation Sub-Commission, AC. et Rome with your indorsement.

Reference is made to the above mentioned letter with which it is requested the reason why it has been instituted the said bus line of the "Compagnia Italiana di Oltremare" (C.I.D.O.) and the opinion of this Ministry.

Therefore we point out that owing to the interruption of the rail service between Rome and Florence, the operation of mentioned bus-service will be very useful to link up these towns and other important urban centres.

This Ministry is favourable to the institution of the service which will still operate for a length of 40 Kms. on the territory under the administration of the Allied Commission.

SUBJECT: Rehabilitation Rail Line Terni-Aquila.

1. The section of this line between Antrodoco and Rieti has been in operation since August of last year, and work is on hand for the repair of the section Terni Rieti.
2. A request has now been received from ICR for authority to proceed with the rebuilding of the section Antrodoco-Aquila in order to reach the chief town of the Province.
3. It is appreciated that Aquila is extremely difficult to reach by road, and that it has no means of access other than routes over mountain passes.
4. Your report as to the desirability of the reconstruction of the line, (without immediate priority owing to cement shortage) is requested.
