1. Ref. my AC/10/8/Tn 3 dated 10 April '45 and confirming phone conversation (Lt.Col. Christensen-Capt. Bullock) 12 April, the representative of Pirelli Tyre Coy called here 12 April upon your instructions and stated that release had now been arranged, and that tiles would now be delivered to trucks upon application at Sinalunga.

2. During conversation the Pirelli representative stated that due to there being no stocks, vehicles were having to stand 24 hours awaiting loading from ovens.

Capt. Bullock undertook to report this to Lt.Colonel Maskrey and to make an investigation. Please may this Branch be notified the result of your enquiries.

Meantime Road Division are requesting details of delays from Ufficio Trasporti, Perugia who is in charge of this particular parcel.

1. Reference is made to your letter AC/5603/IND dated 27 March 1945 which has been passed to this Division by AC Priorities Board.
2. Arrangements have been made to stockpile at CHIUSI Station. Movement from SINADUNGA to CHIUSI will begin on 7 April 1945 and will be at the rate of approx 5 tons per day.
3. To enable Rail Branch to make definite arrangements for the allocation of wagons it is necessary for you to complete Rail Bid Form TSC/3 attached, and submit it without delay to Rail Branch, Movements Division, Transportation Sub-Commission.
4. It is requested that all concerned be notified immediately that tiles begin arriving at CHIUSI tomorrow in order that personnel should be available for handling them and for their safe custody.

INTER OFFICE MEMO

SUBJECT : Movement of Tiles

TO : Roads Division (2)

1. For the reconstruction of the FIRMI factory at TIVOLI it is necessary to move 200 tons of tiles from CHIUSI (W 3082) by rail.
2. The tiles are at present at SINALUNGA R.1606. approx 20 miles N.W. of CHIUSI Road transport is required between these two points.
3. Rail Branch- Movements Division can arrange movement at the rate of approx 10 tons every other day.
4. The ideal arrangement would be to stockpile at CHIUSI.
5. Rail movement can begin as soon as tiles can be made available at CHIUSI. It is requested that this movement may be treated as urgent and given a high priority.


