SUBJECT: Illegal Transportation of Controlled Foodstuffs.

TO: All Concerned.

1. It has come to the attention of this command that the Italian Government has at various times alleged that Allied Military trucks are being used to move controlled foodstuffs, such as wheat and olive oil, in order to avoid search and seizure at the road blocks operated by Italian control authorities.

2. All commands will cooperate to the fullest extent with the Italian police in suppressing possible misuse of Allied transport. Existing road blocks and military police patrols will be instructed to check military vehicles to ensure that they are not carrying unauthorized loads on civilian account.

SUBJECT: Irregular use of TRUCKS

Referring to the information supplied with the letter above referred to, we inform that enquiries carried out by this office have yielded the following results:

The trip ticket conforms on all points to the one, a copy of which was forwarded, except for its validity up to 1st June, or June 20 shown on the s/m copy.

As for the questions raised in para 3 of your letter, it is pointed out that:

as regards point a) ENAC is empowered to issue trip tickets also for runs to Revenue. The relevant bill was approved by the Inspectorato Generale delle Motorizzazioni Civile e dei Trasporti in Concessione on request of SEPPAL. As regards point b) ENAC has no possibility of controlling the equipment introduced on starting, and it is used petrol for the haulage of goods. From the presence of DUEZI of passengers it cannot be inferred that there was not sufficient space on the truck for the haulage of goods. As regards point c) : Attached hereto please find a copy of trip ticket No 45640, issued on 20/6/45 by the Rome Provincial Directorate.

SUBJECT : Misuse of transport.

TO : Regional Commissioner
HQ. Venezia Region

1. The following instance of misuse of road transport for wine movement is notified for your information and necessary action.

2. UFFICIO AUTOTRASPORTI at TREVISO issued permit n° 389841 valid for 3 - 6 July for the movement by road of 7000 Kg. wine from SAN SEVERO (Province of FOGGIA) to TREVISO, a round trip of some 1030 miles.

3. The vehicle employed for this purpose, FIAT TV 12418, travelled empty from TREVISO to SAN SEVERO, loaded the wine, was stopped en route by GUARDIA DI FINANZA personnel and the wine impounded, as the movement was illegal.

4. The owners of the wine called at this HQ. today and requested that an AG. permit for the movement be issued to them; this was NOT granted.

5. In this connection you are reminded of the provisions of this HQ. Movements Division - Roads - Memorandum N° 3 dated 26 June 45, which lays down the procedure for the movement of wine, and in this instance the bid (if accepted) would provide for movement by sea to VENICE.

6. It is requested that you cause enquiries to be made into this affair with a view to preventing any future occurrences.

1. Enclosed is copy of Trip ticket issued by ENAC Rome authorising lorry No. 43764 ROMA to proceed from ROME to RAVENNA to collect Cheese, Sausage, Butter, Fats, Honey and Marmalade.

2. The original trip ticket is in possession of Questura, RAVENNA who took it from the driver of the lorry on 2 June 45. It is reported that the lorry has seats as a permanent fixture in the loading space and when it was stopped in RAVENNA had aboard 3 passengers from ROME.

3. Points for your investigation and report to this HQ as follows:-

a) What authority have ENAC ROME to issue trip tickets for journeys to RAVENNA.

b) As the vehicle was obviously equipped for carrying passengers and therefore not able to carry a reasonable load of goods why was a trip ticket issued and why was Benzine issued for carriage of goods.

c) Did ENAC ROME issue a trip ticket for outward journey from Rome

(i) If Not then why Not.

(ii) If they did please may copy be supplied.

1. On 2 June 1945 lorry 43764 ROMA was stopped by the Questura at Ravenna, carrying three passengers from Rome to Ravenna.

2. Enclosed you will find tri-ticket which was in possession of the driver; it is not understood how this small lorry can be allowed to come to Ravenna from Rome for the purpose of purchasing cheese, Sausage, Butter, Fats, Honey, Marmalade, inasmuch as this province itself is in such bad need for these important foodsupplies and since some of the items are strictly controlled also.

3. Would you please be kind enough to inform the responsible authorities of this case; it is also pointed out that the small lorry in question has seats as a permanent fixture in the loading space.

Referring to your letter Ref. 15-07/ES-AO/28/31/Tn5
of 19th. April last, we beg to submit the following points:
Infringements committed by truckers have been
denounced by the same Guardia di Finanza officer who took part
in the known inspection carried out from 4 to 6th. April last,
to the competent judicial authorities, in conformity with the
rulings contained in L.Decree of 17th August 944 N° 188 ,
establishing ENAC .

As an administrative measure, in these same cases, the
withdrawal of circulation permits has been maintained .

As regards infringements committed by ENAC personnel
mysterious enquiries have been started . As soon as these are
completed, measures of the utmost severity will be taken against
the offenders .

In this respect we beg to inform that the instructions
issued to all ENAC Directorates, and aimed at forbidding the
haulage of wine is dated the 31st March, whereas it has been
ascertained that some of the Directorates, e.g. Benevento and
Avellino, received it only on the 12th. of April .

As a confirmation of the above statement, the fact
is that in the second inspection, effected by the same officers
from the 15th. to the 13rd. of April last, only four instances
of such infringements were found out, and they been committed
solely by the truckers themselves, by carrying travel papers .
Also in these cases a denunciation has been made .

Your Commission will be informed of all further
measures which will be taken, and meanwhile an adequate opportunity
will be afforded through the press .

Referring to your letter ref. 15-07/ES-MO/26/31/Tns
of 19th April last, we beg to submit the following points:

Infringements committed by truckers have been denounced by the same Guardie di Finanze officer who took part in the known inspection carried out from 4 to 6th April last, to the competent judicial authorities, in conformity with the rulings contained in L.Decree of 17th August 1944 No. 138, establishing ENAC.

As an administrative measure, in these same cases, the withdrawal of circulation permits has been maintained.

As regards infringements committed by ENAC personnel rigorous enquiries have been started. As soon as these are completed, measures of the utmost severity will be taken against the offenders.

In this respect we beg to inform that the instructions issued to all ENAC Directors, and aimed at forbidding the haulage of wine is dated the 31st March, whereas it has been ascertained that some of the Directors, e.g. Benevento and Avellino, received it only on the 12th of April.

As a confirmation of the above statement, the fact is that in the second inspection, effected by the same officers from the 15th to the 23rd of April last, only four instances of such infringements were found out, and they been committed solely by the truckers themselves, by forging travel papers. Also in these cases a denunciation has been made.

Your Commission will be informed of all further measures which will be taken, and meanwhile an adequate publicity will be afforded through the press.
