We have received a request from the Italian Air Ministry for an air courier service twice weekly between Rome and Catania. A service already exists between Rome and Palermo.

Due to the present situation of land communications,
the reopening of air traffic between Italy and Switzerland
should have a remarkable importance also in view of the
economical relations we hope to establish between these two
Nations in a very near future; therefore this initiative is
being encouraged also by the Swiss Authorities.

The air service with Switzerland, having a call at
Zurigo, should be very useful also because intercontinental
air lines depart from that town.
