proprietors Mr. Filippo Conti, the subject plant needs only
minor repairs to be put into operation.

2. We are in full accord with the reactivation of
this factory, and your active collaboration with the firm to
this end would be greatly appreciated.

3. For your own guidance, we hereunder give the
plant's monthly requirements of raw materials and supplies :

Pyrites	NONE : the plant has enough in stock for six months.
Phosphate rock	900 tons
Nitric acid (36% Be')	6 " (10 tons initial)
Scrap Brass	200 " for a monthly output of 500 tons of copper sulfate.
Fuel oil	60 "
Coke	7.5 tons
Vaseline for Acid pumps	0.3 tons
