

Dear Major,

attached, please, find the requested letter from General Matteini, regarding motor transport asked for and never received from the Italian Ministry of Transport. I feel sure your very kind support will help us out also in this case in which, incidentally, I have a personal interest since one of the "jeeps" might be assigned to me.

With reference to this morning's telephone conversation regarding "Punta Mica and Punta d'Ostro", I would appreciate very much if you could write us a note to the effect that the above mentioned ships are no longer required on behalf of the Allied Commission on the Civitavecchia-Fiumicino coal run and consequently could be reverted to normal Cogena use.

My request is originated by the fact that a representative of the shipowners states that A.C. Instructions, for the use of these ships on the Civitavecchia-Fiumicino ferry service, are still effective.

A written notification to Cogena would thus eliminate useless arguing and consequent waste of tonnage which practically would lay idle until owners were convinced of the real state of affairs.

At the same time, please, let me know if your instructions apply also to the "Dina" which has the same status of the two other ships. 271?

2. The recent instructions from Ministry of Marine mean that the Captain of the Port now takes over certain routine duties previously undertaken by Cogena agents.

These include : -

- reporting sailings of schooners and cargo loaded

3. 

SUBJECT : Movement of food by schooners.

TO : Food and Agriculture Sub-Commission.

1. Reference is made to Ministry of Marine letter 13143 of 21 October, which was addressed to Ministry of Food on the subject of movement of foodstuffs by schooners and proposing a change be made in the present method of shipping essential commodities. Copy of letter (in Italian) is attached.

2. The following is a "free" translation of this letter with our comments on some points. Your comments and considered views are therefore requested.

"From information received from Legona we understand that of 109 schooner allocations (totalling 19,17 tons), which were made from 1-16 October to move essential goods, 52 schooners (equal to 2,322 tons) were not accepted by the shippers when loading was due to commence. Of this number only 16 schooners (equal to 1,660 tons) were employed for other voyages" (a)

"In the past similar refusals on the part of shippers have taken place. Schooners which had been allocated and subsequently refused by shippers up to 16 October (including allocations made before 1 Oct.) totalled 109 vessels with a capacity of 8,170 tons. 40 of these schooners (capacity 1260 tons) were subsequently re-employed."

"To the above mentioned reasons is attributed the impossibility of fulfilling the 30,000 monthly programme to be moved by schooners, as already agreed with the Allied Authorities. (b) If this situation deteriorates, transportation by schooners will be compressed, which would raise further objections from the Allied Authorities, who have already complained that Legona have not fulfilled their agreed programme in full."

SUBJECT : Movement of food by schooners.

TO : Food and Agriculture Sub-Commission.

1. Reference is made to Ministry of Marine letter 13143 of 21 October, which was addressed to Ministry of Food on the subject of movement of foodstuffs by schooners and proposing a change in the present method of shipping essential commodities. Copy of letter (in Italian) is attached.

2. The following is a "free" translation of this letter with our comments on some points. Your comments and considered views are therefore requested.

"From information received from Cogema we understand that of 197 schooner allocations (totalling 19,127 tons), which were made from 1-16 October to move essential goods, 52 schooners (equal to 2,522 tons) were not accepted by the shippers when loading was due to commence. Of this number only 15 schooners (equal to 1,260 tons) were employed for other voyages." (a) 2788

"In the past similar refusals on the part of shippers have taken place. Schooners which had been allocated and subsequently refused by shippers up to 15 October (including allocations made before 1 Oct.) totalled 109 vessels with a capacity of 6,170 tons. 40 of these schooners (capacity 1260 tons) were subsequently re-employed."

"To the above mentioned reasons is attributed the impossibility of fulfilling the 30,000 monthly programme to be moved by schooners, as already agreed with the Allied Authorities. (b) If this situation deteriorates, transfer of tonnage by schooners will be compromised, which would raise further objections from the Allied authorities, who have already complained that Cogema have not fulfilled their agreed programme in full."

"We have therefore thought it proper to notify the Ministry in order that action should be taken to avoid these difficulties in future."

"We believe this question could be solved if we decided to limit the movement of essential commodities to rationed foodstuffs, excluding wine etc. from (c)

"This is proposed not only because our (i.e. wine etc.) could bear the "free" or "b"

freight rates, but a proportion of these commodities is at present being moved at "free rates". (a)

"In consequence, wine etc. is being moved at present at controlled cogona rates as well as at "free" (i.e. uncontrolled) freight rates. It is reasonable to assume that when such commodities as wine are moved at cogona controlled freight rates, which are lower, the additional profit made mainly goes to the shipper or producer instead of to the consumer's advantage, as such supplies are bound to be sold at current market levels." (a)

"We draw your attention on the matter and beg you to let us know the action it is proposed should be taken."

3. Perhaps you would obtain the views of the Ministry of Food on the question and send your agreed opinions to this Sub-Commission in order that the Allied Shipping Authorities and Ministry of Airline can be informed of any change; it is proposed to recommend should be made.

4. Comments by Transportation and Shipping

Sub-Commission.

- (a) The balance of 14 schooners it is presumed must have been allocated to "free voyages" by which is meant a trip when the schooner owner is able to accept any cargo at uncontrolled current freight rates. The excessive number of "free voyages" is affecting the fulfillment of the 30,000 tons required each month.
- (b) This argument is not necessarily accepted, but it is a possible explanation for the monthly lift usually being approx 20,000 instead of 30,000 tons. There may, however, be other reasons. For instance, the total capacities of all schooners available for allocation would need to be known and also the tonnage allowance of "free voyages" (which are granted after "extensive repairs" and when cargoes are not available). The two totals would then have to be compared with tonnage of essential commodities actually shipped.
- (c) A list of rationed foodstuffs would be required, also one of the commodities which, on account of non rationed goods, would be deleted from "essential commodities list".
- (d) By "free rates" uncontrolled freight charges are meant, by which the schooner owner arranges freight rates with

which are lower, the additional profit made mainly goes to the shipper or producer instead of to the consumer's advantage, as such supplies are bound to be sold at current market levels." (c)

"We draw your attention on the matter and beg you to let us know the action it is proposed should be taken."

3. Perhaps you would obtain the views of the Ministry of Food on the question and send your agreed opinions to this Sub-Commission in order that the Allied Shipping Authorities and Ministry of Marine can be informed of any change, it is proposed to recommend should be made.

4. Comments by Transportation and Shipping Sub-Commission.

- (a) The balance of 34 schooners it is proposed that have been allocated to "free voyages" by which is meant a trip when the schooner owner is able to accept any cargo at uncontrolled current freight rates. The excessive number of "free voyages" is affecting the fulfillment of the 30,000 tons required each month.
- (b) This argument is not necessarily accepted, but it is a possible explanation for the monthly lift usually being approx 20,000 instead of 30,000 tons. There may, however, be other reasons. For instance, the total capacities of all schooners available for allocation would need to be known and also the tonnage allocation of "free voyages" (which are granted after "extensive repairs" and when cargoes are not available). The two totals would then have to be compared with tonnage of essential commodities actually shipped.
- (c) A list of rationed foodstuffs would be required, also one of the commodities which, on account of non rationed goods, would be deleted from "essential commodities list".
- (d) By "free rates" uncontrolled freight charges are meant, by which the schooner owner arranges freight rates with prospective shippers. This means rates must fluctuate and are competitive.
- (e) It must be pointed out that 25% of the cargo of wine is sold at prices fixed by Ministry of Food and 75% (the bulk) is sold on the open market.



1. The Società di Monteponi, owners and operators of extensive metal mine holdings in Sardinia, are endeavoring to re-establish shipping facilities between Sardinia and the Italian mainland.

2. The Società di Monteponi requests information as to the possibility of chartering a small coal burning coastal fishing boat which may be easily converted into a cargo carrying vessel. They have located such a vessel in the Port of Cagliari, she is the "Assunta Madre", DWT 83, net 32 tons, burns local coal. The vessel was requisitioned by the Allies in 1943. About 4 months ago she was de-requisitioned and returned to the owner Giovanni Susnick of Cagliari and has not operated since the time she was returned to the owner.

3. Rather than have the above named vessel remain idle in view of the almost complete lack of shipping available to the Italians, recommend that Società di Monteponi be granted permission to charter the "Assunta Madre" if such action is not contrary to current policy and procedure.

1. Reference is made to recent verbal reports on the above subject.

4. It is considered essential in order to avoid delays, waste of tonnage and unnecessary money loss by everyone involved in those particular trips, that we be supplied with the following information:
 - (a) Whether there is, on the route, a calling forward point for schooners bound to Venice.

1. Reference your letter dated 20th inst. and the previous correspondence on the same subject.

2. We noted the detailed explanation received regarding the schooners "Roma" and "Nicola", and inform you of the following:-

(a) It is known that from the 1st July the Italian Organisation Itmare is responsible for the control of Italian Shipping for the whole of Italy, Sicily and Sardinia. (In case you didn't receive it through other channels, attached in duplicate in Italian and in English is copy of Shipping Instruction No 15 dated 26 June issued by H.Q. Allied Commission).

(b) Therefore, in accordance with the procedure stated in the above said Instruction, Itmare is the appropriate organisation for the assignment of ships for transport. The Allied Authorities who wish to use the ships controlled by this organisation, will have to submit a request to the Allied Commission who will forward it for action as an emergency request.

3. With regard to the schooner "Nicola" we inform you that the documents sent by your Agency were not sufficient.

Although your Agency is authorized to make emergency decisions, the above mentioned action must be taken only after having been officially requested by the appropriate Authorities.

Especially where the schooner "Roma" is concerned and according to what your Agency has let us know, the request was presented by the consignees of the goods who had an interest in having the transport continued, and from the copy we possess it ~~was~~ that it was addressed to the Livorno Port Commandant and not to your Agency. The regular procedure is that the demand should have been made and signed by the Port Commandant to whom it was officially addressed. In this manner the Port Commandant would have been personally responsible for the request, while in the

present circumstances he is not concerned in the matter.

4. With reference to your letter dated 2¹ inst. in which you inform us that the schoonere "S. Antonio" has received direct order from the Allied Authorities to load on their behalf.

Also in this case it is absolutely necessary that the Authorities, not specified in this case, should assume the responsibility of such orders writing a regular request. In any case we would like to have further information and the relative documentation.

5. This is to give us the possibility to transmit, as for previous procedure, the documentation to the H.Q. Allied Commission in order to settle the question of the responsibility for this procedure, which is now in contrast with the general regulations issued by the Allied Authorities.

SUBJECT : Permit given to m/s "Roma".

TO : Itmare, Rome.

Reference your telegramme dated 17 inst regarding the authorisation we gave to m/s "Roma" to proceed to Vado Liguria, and our telegramme of the 18th on the same subject.

On the 1st July the consignees of the goods loaded on the schooners "Roma", "Ida" and "Nedda" came to our Agency asking to divert these schooners to a port of the Riviera Ligure possible Vada (see attached copy of the letter dated 10 July written by AMG Genoa to the Port Commandant of Livorno).

We knew that the "Roma" was already in Vada and that the other schooners were on their way to this locality. No instruction has been received up to now regarding these schooners.

Considering that the request was made by Allied Authorities and that too many schooners were already in Vada, and also the impossibility of getting in contact with you in less than 4 or 5 days, we gave to the m/s "Roma" a permit for Vada and asked your authorisation for the schooners "Ida" and "Nedda" which are still on their way.

We issued the permit also because of General Matteini's verbal communication which was confirmed by Commandant Marena, that is to say, that in a case of emergency and for essential commodities we could issue new transport permits.

Giving to the schooner "Roma" the authorisation to continue on her way to Vada we believed to do the right thing and perform our duty as Agents. Executing the order of AMG Genoa in this case, it would have been possible to speed up the delivery to destination and also make the schooner available at an earlier date. For unknown reasons the schooner is still in Vada.

With reference to the telegramme to Cogena Naples dated 16 inst. and the telephone call to you, we inform you that after the circular letter N°5227 dated 21 June regarding the new organisation of the Cogena, no other instruction was received on this subject except the verbal authorisation of General Matteini to give new transport permits for essential commodities and the text of the telegramme referred to above.

We don't know anything else about our duties and the limits of our responsibilities.

We therefore beg you again to instruct us clearly on what our duties are and what action we must take when a decision is needed and we cannot contact you (we receive your telegrammes 3 days later and it is often impossible to use the telephone. As we have also given the schooner "Nicola" the authorisation to go to Santa Margherita Ligure we find it necessary to report the fact to you.

On the 15 inst. the Navy Command of Piombino transmitted to our agent the order from NOIC Piombino to have the m/s "Nicola" proceed to Santa Margherita. As the schooner could not be discharged at Livorno (because not open for civilian traffic) Commandant Ferrarà from the Liaison Office asked us if we could issue a permit for the m/s to go to Santa Margherita. For the same reasons as for the m/s "Rome" and as the m/s was already in Livorno we thought we could carry out the request of the Liaison Officer with the Royal Navy.

By order of the N.O.I.C. Livorno transmitted by telephone to
the Commandant FERRAU, the m/s Nicola 321 must be diverted to

We beg to attach copy of our letter #177 of
14 April last, addressed to the Industry Sub-Commission, with
copy to the Italian Navy, Rome, on the above subject.

Since the matter has become of still greater
importance because the Rosignano Works have started working
again, we therefore beg to ask you to kindly take up the
derequisition of the motor schooner ENRICO (ex "ALMA") of
420 tons d.w., property of the SATI Company, which vessel
would be used by the SATI for the carriage of goods to and
from Rosignano. 2688

This motor schooner has particularly favorable
characteristics for this service, as she can moor at our pier
of VADA without any difficulty in spite of the low depth of

The Solvay Company during the past years, and for a very long time has availed itself of the services of the SATI Company for the carriage of its goods by sea; indeed, it has an agreement with the SATI by which the latter were entrusted with the carrying out of almost all the transport by sea from the Vada pier to various Italian ports, as well as the forwarding of the Company's finished products and the reception of important raw material. 2887

In view of the imminent renewal of production, of the present railway carriage difficulties, of the request made by Industry Sub-Commission, HQ Allied Commission to form depots (stocks) of our products in three large port cities (Rome, Naples, Bari), of the possibility of making use of the Vada pier which has been completely put in working order, the Solvay Company would be most interested in the renewal of carriage of their goods by sea through the SATI Company.





TRANSMISSION OF LETTER DATED 26 APRIL 1945, addressed to the Allied Commission Hq, Transportation S/C, Ports Division, with copy to Economic Section, received from Messrs. A. Lupo Raimondo, Rome and Palermo.

We would ask the Allied Commission to kindly intervene, and invite the SAPPAL to reimburse us of expenses and damage suffered, before the undersigned is obliged to have recourse to the Courts.

We trust that, after careful investigation of the above facts, the Allied Commission will take the necessary measures.

Dear Sir:

Since our conversation the other day, I have made some examination regarding full utilization of schooners. I have had some thirty-six cases examined where the cargoes, originally scheduled for the schooners were not available at the ports, when the schooner arrived. In these particular cases, I find that alternative cargoes were made available, cargoes which had been authorized against the chipping program.

It would therefore appear that the waste is not so serious as originally thought; at the same time, I am not fully satisfied with the information I have so far received and I am investigating the matter further.

L'Alto Commissario per la Sardegna, Generale Pinna, ebbe a suo tempo a concedere alla n/s Ditta il permesso di esportazione dalla Sardegna per oltre 600 tonnellate di merci varie dirette in Sicilia con l'intesa che a tale esportazione avrebbe dovuto corrispondere una equivalente importazione, in compensazione, di merci dalla Sicilia.

In base a tale intesa la n/s Ditta, nel periodo che corre dal 26 Luglio 1944 al 15 Febbraio 1945, ha effettuato sei viaggi da Cagliari a Palermo con 1 motovelieri : Maurizio, S.Vito, Maria Ausiliatrice, I Fratelli, Alberto, Maurizio e Rosa R e un viaggio con il piroscafo S.Padre, per un tonnellaggio complessivo di oltre 600 tonnellate, trasportando pelli grezze, pelli salate, talco e bianco di zinco.

Viceversa, nello stesso periodo di tempo, non e' stato possibile effettuare che un solo viaggio dalla Sicilia in Sardegna e precisamente con il piroscafo S.Padre, nel settembre 1944, con un carico di 1501 tonn. di vini e marsala.

E' bensì vero che alla n/s Ditta era stato assegnato il motoveliero Rosa R per viaggi di andata e ritorno da Cagliari a Palermo, e cio' a mezzo di regolare contratto di noleggio stipulato col Co.Ge.Na di Cagliari ed approvato dalla A.C. di Cagliari ; senonche all'arrivo a Palermo, il 10 Febbraio 1945, del predetto motoveliero, il Co.Ge.Na di Napoli ha disposto che l'assegnazione del Rosa R alla nostra Ditta venisse a cessare con l'arrivo a Palermo.

Di conseguenza, a causa delle esportazioni gia' effettuate dalla Sardegna e per gli accordi presi con l'Alto Commissario dell'Isola, ci troviamo ad avere in Sicilia gia' acquistate merci varie per oltre 400 tonn, destinate alla Sardegna, e precisamente :

- Qli 300 di alcool puro (da servire per gli ospedali)
- Qli 100 di manna per dolcificazione
- Qli 600 di vini comuni (particolarmente richiesti dalla sezione Prov. dell'Alimentazione di Cagliari)
- Qli 500 di vermut
- Qli 2.500 di marsala

Tale merce, di cui viene autorizzata l'esportazione dalla Camera di Commercio e dalla A.C. di Palermo, non puo' essere trasportata in Sardegna, dato che non sono stati assegnati i mezzi di trasporto, e trovasi pertanto da oltre tre mesi depositata in magazzini, all'uopo affittati, a Palermo, con incalcolabile ed evidente nostro danno.



1. Reference this Sub-Commission's letter 754/17/Tn.3, dated 10th March, 1945, addressed to AFHQ, G-4 (Mov & Tn), the following reply, dated 12th March, has now been received. (Ref. No. G-4 (Mov & Tn) 5/484/GDM).

"1. Ref. your 754/17/Tn.3, of March 10th.

"2. The schooner lift allocated for operation by RASC is employed in the carriage of services traffic for the support of Allied Naval Ground and Air Forces. Apart from a small fleet operated by NO'EGIC the balance is operated by COGENA. Should the RASC be unable to employ its allocation fully and economically, the surplus lift is returned to MEDBO for re-allocation. It is not, therefore, anticipated that any RASC operated schooners will be available for lifting essential civilian supplies. 2649

"3. In order to assist your planning, however, it is requested that the estimated lift required be advised to this HQ when an appreciation will be made of what disposition of COGENA schooners can be effected to lift the required items for the supply of the LIGURIAN coast.

1. There are a number of small ports along the Gulf of Genoa (in addition to the larger ports of Spezia, Genoa, Savona and Imperia) and it should be possible to use some of these for the distribution of civil supplies to the coastal areas of Liguria. The most suitable appear to be:-

East of Genoa : SESTRI LEVANTE
SANTA MARGHERITA

West of Genoa : SESTRI POENENTE
VADO
VOLTRI
SAN REMO

2. If enemy minefields are as extensive as is now anticipated in the Gulf of Genoa, it should be possible to sweep a channel into one or two schooner ports East of Genoa before that port is opened. Any sweeping of small ports to westwards will delay the sweeping of Genoa and as the feeding of all NW Italy depends largely on the use of Genoa, it is considered nothing should be allowed to delay the sweeping of that port. This means that delivery to small ports East of Genoa might be possible two weeks after liberation, and delivery West of Genoa from six weeks to two months.

3. If these schooner ports are extensively damaged, there will be no military resources available to repair them initially as these will be fully employed at Genoa. It will, therefore, be necessary to select at the time those ports which are least damaged.

4. There is a limited number of supply barges and craft in NW Italy ports, but as it is probable many will be damaged before our arrival, schooners from our existing fleet will have to be used in this area. It should be possible to load these out of the West Coast ports where stocks of civil supplies are held and later out of Genoa.

5. CAO has stated that the opening of small Ligurian ports will be a matter for negotiation by 2 District with FONAM.

6. It is suggested that a reply on the above lines be forwarded to 15 Army Group.



We have had the pleasure of stating the position of this vessel which has been salvaged by ourselves over four months ago and is now lying in Bari, pending the major repairs she needs before resuming operations.

We cannot, unfortunately, due to the severance of all relations with our head offices in Genoa, dispose of the necessary funds, and we fear that official support, even if possible, may cause serious delay.

We have therefore asked the C.A.F.A.I. of this City, which is officially authorized to transport food supplies into the Rome area, whether it would be willing to advance us at least a portion of the required sum, and they have declared themselves willing to help rehabilitate our ship.

They ask, however, over and above the normal securities which we are quite willing to grant, your assurance that they will be able to use the ship for a certain number of consecutive voyages from Bari, Sicily or Sardinia to Rome, so that their advance may be reimbursed by us in freight.

In consideration of the sum which is to be advanced, the ship ought to follow this approximate schedule:

- Repairs - January 15th / April 1st/15th
- One trip from Bari Region to Fiumicino - about end of April
- two round trips Fiumicino - Sicily or Sardinia - about 15th/30th June.

In other words, the ship would be losing only about six weeks before being able to take up her duties in the coal trade from Civitavecchia to Rome, but we are absolutely sure that this time, and probably more, will be gained by the immediate start of repairs, and by the possibility of utmost elasticity in this work when privately contracted. It is also to be considered that the ship would be free to take whatever cargo you may desire on her cut-bound trips to Sicily or Sardinia.

The undersigned shipowner Lenzi Romualdo, fu Giovanni Battista, domiciled at Cagliari, Via Maddalena N°17, begs to call attention to the following:

On September 24, the ship requisitioning office of the Allied Commission at Cagliari instructed the undersigned to place at the disposal of the Allies the motor fishing boat Delfino with a gross tonnage of 30 tons - net tonnage 8 tons - with internal combustion engine with h.p. of 125 fitted with a refrigeration installation having a power of 5000 refrigeration hours, employed for mechanical fishing in the Cagliari zone.

On October 11, the CO-GE-NA of Cagliari gave orders for the fishing boat in question to depart for Palermo, whence it continued on to Milazzo-Naples.

The boat arrived at Naples on October 30 and is still lying idle at that port. Since so far no use has been made of the boat, it should be noted that:

- (a) The boat has a very small tonnage suitable only for fishing operations (8 tons);
- (b) The dimensions of the boat do not make for safe navigation when carrying a full load;
- (c) The use of the motor fishing boat for the purpose for which it was intended, would be more profitable in providing fish supplies for the city of Cagliari. Commandeering of the said fishing vessel has led to a reduction in the fish ration of the civilian population, which from 250 gm. per capita has fallen to 200 gm., since at the moment there are only two fishing boats in operation;
- (d) it is considered that there are more suitable boats for the use which the motor fishing vessel Delfino may be destined.

Consequently, the Allied Commission is requested to be good enough to take into consideration the above facts, and to take steps to release the boat so as to return it to the more productive fishing operations.
