FOR THE PURPOSES OF THE ACT, THE FOLLOWING ARE THE DEFINITIONS OF THE TERMS USED IN THE ACT.

DEFINITIONS.

1. Calicut carbide for Trieste. This requisition HQS-74-1-422 for one thousand carbide for HQS 13 Corps for January through June 1943 (100 tons monthly).
2. Request procedural action be taken to enable first shipment reach Trieste for HQS 13 Corps by 1 February.
3. HQS has available British theatre stocks (A lot 1327 refers) which will provide January allotment.
4. Justifications required for ship repairs and conversion works on British "Hump" ships on order of HQS at Trieste. Going to drought, lack of electric power, and shortage of coal, practically no availability of calicut carbide in Italy until May 1943. Conversion of ships not possible without carbide. Conversion will provide employment at Trieste.
