1. Reference your communication No. 35079 of 11 December addressed to Ministry of Industry & Commerce.

2. No particular difficulties in shipping cork from Sardinia are anticipated, providing the exporters bid for shipping space in the correct manner.

3. A copy of shipping Instruction No. 16 is enclosed for the benefit of the Industrial Association of Sassari. Attention is called to para 2 which indicates that bids must be made through the respective Italian Ministries. Shipping is arranged only in accordance with requests made by the Ministries to Cogena.

SUBJECT : Export of Cork

TO : Ministry of Industry and Commerce

The Industrialist Union of Sassari has presented to this Alto Commissario, the critical situation in which the local producers of cork find themselves because of the great difficulties hindering the exportation of this product to the continent, where it is much requested.

The cork industry in Sardinia is one of the most important industries of the island because of the capitals invested and the number of laborers employed. It is presently in danger of being paralyzed by the lack of transport, and is menaced, by competition, by Spain and Portugal.

We therefore beg you to take this problem into due consideration with the purpose of assigning to the movement of cork from the Island an adequate tonnage.

We make present too, that the cork Industrialist of the Continent have made similar request through the Federazione Italiana delle Industrie del Legno.
