SUBJECT: Port and Shipping Committee.  
TO : Navy Sub-Commission.

1. Reference your letter NSC/1671, dated 16th February, 1945, and conversation Commander Ziroli-Captain Butler-Col. Sieff on the 19th February.

2. At the second meeting of the informal "Port and Shipping Committee" it was decided to suspend any further meetings of this committee in view of MEDBO's proposed formation of a high level committee to deal with general ship and shore policy in ports handed back to the Italian authorities.

3. Mr. Ian Campbell, who will be a senior member of the MEDBO Committee, was present at this meeting and it was agreed that his committee would consider the necessity for the formation of a committee within Allied Commission to deal with port and shipping problems in which the Italian authorities and Allied Commission are interested, and make recommendations to bring such a committee into being if they think it can fulfill a useful purpose.

MINUTES of Second Meeting of the Port and Shipping  
Committee held at H.Q. Allied Commission on Monday,  
19th February, 1945, at 11 a.m.

10. The Chairman stated that the Port and Shipping Committee was purely informal and had no authority for its existence. The present position was that AFDEO proposed to form a high level committee consisting of senior members of shipping authorities, a member of the Italian Government, and a member of Allied Commission. This Committee would sit down as a permanent committee in being until major policy had been resolved with regard to the working of ports handed back to the Italian Government, and the working of shipping in those ports; it would also establish a precedent for the future running of ports to be handed back to the Italian Government. Mr. Campbell would be the M.W.T. representative on this committee.

11. The Chairman proposed that until approval or otherwise had been given by this high level committee for the Port and Shipping Committee the latter should only meet informally. He asked members for their views as to whether the Port and Shipping Committee could accomplish anything by meeting which could not be done by their respective offices through the normal channels; it was suggested that one useful function it could perform would be to brief the A.C. representative who goes to the AFDEO meetings.

Opinion was divided and it was decided to proceed with the points for discussion and to come to a conclusion at the end of the meeting.

12. MINUTES OF THE LAST MEETING:

Minute 4. Col. Balfour stated that specific cases of motor schooners thought to be deliberately damaging their engines in order to be reclassified had been requested. Mr. Crooks was providing schooner control with this information. Action had been taken against the craft in question. Lt. Larona stated that the COGWA Agent had been dismissed, and the master's licence withdrawn in the case referred to.

Minute 5. Gear for Italian Forts: Col. Balfour stated that a requisition had been made up and was at the moment with Mr. Ryan and the Italian Government representative for checking.

Minute 6. Mr. Crooks stated that arrangements for discharging bulk cereals were in hand.

Minute 8. Mr. Crooks stated that the stabilised Palermo 1944 freight rate was now out. This had been agreed by J.W.T. and W.S.A. who were arranging repayment where rates in excess had been charged during recent months. The rates would be stable until the 31st March. COGNA and A.C. were working out new rates to come into effect on the 1st April, 1945. These rates were to cover COGNA expenses.

13. The Chairman asked members if they had any points they wished to raise.

14. Dr. Biancheri said he had a list of the ports handed back to the Italian Government, and would like to know if this was correct. It was stated that no comprehensive tabulation of these ports and areas had been made. The proposed MEDBO committee would clarify.

15. Dr. Biancheri raised the question of communications between Rome and Civitavecchia. He understood there was no longer a military courier for mail. The Chairman requested Col. Balfour to make enquiries about the courier service via Lazio Umbria Region.

16. Mr. Crooks said he had been informed by Major Blair that stvedores were not being paid at Reggio, and that much dissatisfaction was being caused. The Chairman asked Mr. Crooks to obtain from Major Blair details of specific cases for specific ships. It was thought that Major Blair was consulting dock labourers and stvedores.

Action: Mr. Crooks.

17. Mr. Crooks asked Capt. Butler whether certain draft could be released for coal burning. The Chairman considered that the Civitavecchia-Rome coal run ought to be developed as much as possible in view of the fact that the supply of railway waggons was not likely to improve. If a regular service to Rome could be established it would be of the greatest advantage to the Italians and to the Allies. Mr. Crooks stated the difficulty of getting a suitable tug. It was proposed to save 250 tons a day by one tug. DOHC has provided a 100 ton barge lift suitable for river navigation.

18. Regarding the use of the port of Salerno, Mr. Crooks said the draught could be increased in 15 days to 25 feet. AFHQ had been asked to release the team for this work.

19. With regard to A.C. representation at the weekly MEDBO conference, Col. Balfour suggested that it was only necessary for one representative to attend, and not two as at present. J.W.T. representative did not agree. Col. Balfour pointed out that the A.C. representatives only attended by invitation, and he considered they should be members of the committee. The Chairman said this

If a regular service to Rome could be established it would be of the greatest advantage to the Italians and to the Allies. Mr. Crooks stated the difficulty of getting a suitable tug. It was proposed to have 320 tons a day by one tug. DOHC has provided a 400-ton barge lift suitable for river navigation.

18. Regarding the use of the port of Salerno, Mr. Crooks said the draught could be increased in 15 days to 25 feet. AFHQ had been asked to release the boats for this work.

19. With regard to A.C. representation at the weekly MEDCO conference, Col. Balfour suggested that it was only necessary for one representative to attend, and not two as at present. A.W.T. representative did not agree. Col. Balfour pointed out that the A.C. representatives only attended by invitation, and he considered they should be members of the committee. The Chairman said this matter should be referred to the proposed MEDCO committee for action.

20. SHIPPING IN SARDINIA

The Chairman said there were a number of problems in connection with shipping in Sardinia: (i) Considerable delay and wastage of shipping was occurring at S. Aniccho. It was believed that this was bound up with the amount of coal that could be mined and produced at the quay side. (ii) There were insistent demands from Sardinia and requests from the Italian Government for a ferry service for personnel and general cargo between Olbia and

Civitavecchia: (iii) High Priority for a ferry service for live stock between Olbia and Civitavecchia. A report had been received on Sardinia in which it was stated that insufficient shipping was being provided to lift the exports that were essential for the minimum economic life of the island. The Chairman proposed that representatives of A.C. and the Italian Government should go to Sardinia and in conjunction with the authorities there look at S. Antiocho, Cagliari, Olbia, and Maddalena, and bring back a report. Mr. Crooks was requested to arrange this.

Action: Mr. Crooks.

21. CONTROL OF PORTS.

The Chairman asked how bids for shipping would be made in areas handed back to the Italian Government. Col. Balfour said they would be made through the Chambers of Commerce. Col. Balfour was asked to ascertain what means of postal communication would be available between these areas and Rome, for the submission of bids.

Action: Col. Balfour.

22. SHIPPING INFORMATION.

The Chairman said that inadequate and delayed information was still being received from most ports on shipping. He proposed that MEDBO be asked what information normally sent in the information signals would have to be deleted in order that the message could be sent by telephone.

23. POINTS TO BE RAISED AT MEDBO MEETINGS.

The Chairman agreed that anyone having points to raise at MEDBO meetings should in future take their requests to Col. Balfour.

24. SUSPENSION OF THE FORT AND SHIPPING COMMITTEE.

It was generally considered that the Committee had not achieved anything at this meeting which could not have been accomplished through normal office discussion, and it was therefore decided to suspend further meetings until recommendations were received from the high level committee being formed by MEDBO.



1. Chairman stated that it was proposed to form a Committee within A.C. to resolve problems in connection with Shipping and Port working in Ports, which had been handed back to the Italian Government, particularly in respect of ships in which A.C. had a direct interest. 2. Capt. Butler, Navy S/C, asked whether the proposed Committee would not delay the execution of the declared A.C. policy of handing back to the Italian Authorities as much responsibility as possible as quickly as possible. Chairman stated he considered that the Committee, on which the Italian Government was represented, should have the opposite effect. It had been found that a transition period was necessary at present between the date when the Ports were handed back from Allied Military Control to complete Italian Government Control without any Allied assistance. In the work of reconstruction, organisation of docks clearance, etc., Allied assistance was necessary, though as much responsibility as possible was being delegated to the Italian Authorities. The Chairman felt that, where Allied assistance and advice was necessary, decisions could be made and implemented more quickly and overlapping and duplication of work avoided through the formation of the proposed Committee; Italian Government responsibility would in no way be diminished.

3. Chairman then asked if members of the meeting had any points they wished to raise.

4. Mr. Crooks, Ports & Warehouse Division, advised that certain motor schooners were thought to be deliberately damaging their cargoes in order to be reclassified as Sealing Schooners and so operate independently of COGENA. It was decided to ask M.E.D.B.O. to tighten schooner control and to suggest to them that all schooners be registered on a tonnage basis.
