SUBJECT : Motor Vehicles.

1. Reference your letter Reg 1/15 dated 13 June.
2. As requested enclosed herewith three official requisition forms duly signed by HQ. G-4 (American). All three copies must be signed by the owner of the vehicle and when this is completed two copies are to be returned to this office and the third retained by the owner. Official number will be given after return of forms.
3. Requisition of vehicles for A.C.C. through British channels is not permitted and can only be done through American Army procedure.
4. Reference your letter 2 June re a Fiat vehicle.
5. This has caused considerable trouble with HQ. G-4 and before any decision can be given concerning this vehicle it is essential that :-
 - (a) A letter be given by the American Red Cross stating that they have no further use for the vehicle and have handed same over for your use.
 - (b) The American Red Cross must state if the vehicle has been requisitioned by them, if so what is the American Army number allocated to the vehicle by P.B.S.
 - (c) If the vehicle has never been properly requisitioned then it must be ascertained how it was obtained and who is the owner.
