SUBJECT: Transportation of ISR Employees Returning to Work or
Transferred

TO : AC Tn Sub/Comm, Rail Divn, Building
Director General, ISR, Rome
Capo Compartimento, ISR, Reggio
Capo Compartimento, ISR, Palermo

1. Reference attached letter from undersigned dated 20 Nov 1944, in regard to movement of ISR employees and their household belongings.

2. Henceforth, when employees are to be moved from and to stations within the boundaries of the Reggio and Palermo Compartimenti, or from a station in the Reggio Compartimento to a station in the Palermo Compartimento, or vice-versa, such requests shall be submitted by the Director General or the Capo Compartimento to AC Tn Sub/Comm, Rail Divn. Notice of approval or disapproval of the move will be given to ISR Director General or Capo Compartimento by AC Tn Sub/Comm, Rail Divn, decision to be based upon the general policy that requests will be favorably considered when movements involved are not to the detriment of military and/or civilian requirements.

3. Several requests are attached hereto for attention of Tn Sub/Comm, Rail Divn.

or TransferredTO : Director General, Italian State Railways
Commanding Officer, 701st Ry Grand Divn, APO 512

1. In order to return employees of the Italian State Railways to their former locations and also in transferring employees from one location to another which involves transportation of their families as well as household goods, the following procedure will govern the transportation and movement of such personnel with their effects:

(a) Application will be made to the Director, MRS, by the Director General of the I.S.R. or by the Capo Compartimento, direct for approval.

(b) Approval will be either granted or denied to the Capo Compartimento who will arrange for placement of car or transportation for the personnel involved. When shipment is made, a copy of the letter of approval from this headquarters will be delivered to the person being transferred which will be their authority to move through the various yards where RTC personnel check trains.

2. In the past several days such movements have been checked at Rome and the personnel involved have not had proper credentials authorizing their transfer and it is necessary that they be provided with copy of the letter from this headquarters authorizing the move, which will be retained in their possession until destination is reached.

3. When letters authorizing these movements are passed to the Capo Compartimento, sufficient copies will be forwarded for an extra copy to be delivered to the person being transferred.
