1. Impresa Pietro Cidonio has contracts with the Genio Civile and under the direction of this Sub-Commission for the reconstruction of bridges and maintenance of roadways on Military Highways.

2. The Contractor claims to have considerable stocks of materials and equipment in Pantelleria which are urgently needed in connection with the work outlined above, but which are frozen by A.M.G.

3. If the materials and equipment are not being utilized to benefit of the Allied interests in Pantelleria, a release to the Contractor for use on Military Highway work on the mainland will be appreciated.
