SUBJECT : Rome-Naples Service.

TO : Regional Commissioner,
Southern Region.

- 1.) Ref. is to your letter R/1454 20 January 1945.
- 2.) It is intended that the following should be included in the title "AC Officers on duty" and as R/Cs on duty", for the purpose of issues of warrants for travel by the Rome-Naples train, within the limits of the accommodation set aside for the purpose:-
 - a) Italian Officers and soldiers employed by AC.
 - b) Italian Civilians employed by AC.
 - c) American or British Red Cross personnel associated with AC.
 - d) Members of the Staff of the UNRRA.
- 3.) The question of amendment to the existing courier service is being dealt with by the Headquarters Commandant so far as journeys from this end are concerned, and doubtless you will hear further from him on the subject.
- 4.) For your information, it is intended to reduce the train timing between Rome and Naples to ten hours in the near future, and the question of further reductions will be considered in the light of experience on that schedule.
