1. In accordance with Allied Commission policy, it is necessary that the functions of the Stores Branch be changed from the present supervisory position to that of advisory by the 1st of November.

2. It is therefore necessary, that, on your own initiative, you obtain materials without assistance or approval of the Allied Commission, however if assistance becomes necessary it will be given.

3. As advised at the last meeting of the Stores Sub-Comm. of the Allied Railway Board you are at liberty to move any of your stores as desired, without requesting permission of M.R.S. or this Sub-Commission, however, it is desired that you send this Bdg. a monthly report of stores moved.

4. It is also desired that you send a monthly report giving the position on steel, cement, calcium carbide, oxygen, acetylene, tires, lumber, coal and coke, and gross ties.

5. Advice will be given you as to where and how to obtain materials if you have any difficulty in securing ~~your~~ ^{of} goods.
