TO : Executive Officer (U.S.).

1. Reference your Memorandum dated 4/Jan. '45.
2. Reference Para 1. The Armies do not propose to release the Fiat Garage in Naples at this time. It is believed, however, that the existing Fiat organization there could go into operation almost immediately their Garage is released.
3. The Regional Transportation Officer, Lazio-Umbria Region, has been forwarded Commerce Sub-Commission's Release Note MC. 2060 for 450 Quintals of Cement for the restoration of the Fiat Garage in Rome, and has been instructed to put in hand the necessary work.
4. The present plan contemplates the restoration of vehicles on a commercial basis by several civilian firms in the Rome Area. This plan is being worked out in detail with the Regional Transportation Officer, Lazio-Umbria Region.

1. The keeping of the existing Italian auto-transport on the road and in working condition is of a paramount importance for rehabilitation of the country.

2. The Fiat Co., which before the armistice had a well equipped and manned garage and auto-repair shop at Pescara, is anxious to rehabilitate it, to invest about 2,000,000 liras in rebuilding its premises, to install all necessary machine tool equipment and to start its operation.

3. Capt. T.R. Price of the Truck Pool No. 3, Region V AC, at Chieti which occupies this garage and repair shop, in his letter of Oct. 28, 1944 to Capt. Richardson R.C.T.O. Abruzzi-Arche Region recommends that full assistance should be given to the Fiat Co. because it promises a great improvement in the maintenance of AC vehicles.

4. On the basis of these facts the Industry Sub-Commission is supporting the request of the Fiat Co. for building materials, as per list enclosed, and is asking the placing by you of a bid for these materials before the proper authorities.

1. If it meets with the approval of the Regional Commissioner it is proposed that the Transport Division Garage and Workshop (SITA) in Firenze shall be used for the servicing, repairing and safeguarding of Regional HQ. vehicles that may be on duty in Firenze until such time as the HQ. Garage moves to Firenze.

2. a Gasoline and lubricating oil will be issued during the day from 07.00 hours to 17.00 hours to Regional vehicles, if marked ACC/VIII and carrying the Regional service number.

b Regional vehicles may be stored in the Garage at any time.

c Vehicles leaving the garage will be receipted for by the driver before leaving who must present an identification letter showing that he has the right to take the vehicle from the Garage.

d Tyre repair facilities will be available within the limits of available materials.

e Mechanics will be available for minor repairs and adjustments.

f Cars will be washed, when required, as promptly, as labour and facilities will permit.

3. One full day during each 10 days period each vehicle on duty in Firenze will remain in the Garage for washing, greasing and servicing. The officer responsible for the vehicle will arrange a satisfactory

SUBJECT: Organization and Functions of Super Garage

TO : Transportation Sub-Commission
Att: Col. Carnes

1. Upon being assigned to the Transportation Sub-Commission, Allied Control Commission, I was given verbal orders to report to and take charge of the Super Garage, which included all maintenance, dispatching, civilian personnel, British Motor Pool, and other installations, and also to supervise the activities carried out therein.
2. After taking charge of this garage and upon making a survey of conditions, I have endeavored to coordinate and centralize the various activities under sections heads. This has shown marked improvement over the previous conditions, particularly with regard to civilian requisitioned vehicles, the service of which is badly needed by the Commission.
3. In the absence of any instructions to the contrary, the operation and administration of this garage has been continued (except for minor administrative details) from what they were when the garage was under the jurisdiction of the Headquarters Commandant. For some time, however, I have felt the necessity of reviewing with the Transportation Sub-Commission the organization of Super Garage with the view to define its functions and the scope of my authority and responsibility.
4. I have felt this necessity particularly with regard to our relation with the Headquarters Commandant, to whom we have continued to send records of payrolls of civilian personnel, invoices and pay vouchers for purchases of spare parts, services, etc.

5. The operation and maintenance of WD vehicles serviced at this garage are performed in accordance with prescribed WD regulations. Likewise the operation of the British Motor Pool is carried out in conformity with British System of maintenance and operation of motor vehicles. The availability of standard parts and the systematization of the functions of these two sections in Super Garage have facilitated a more normal operation.

6. The procurement of spare parts and other materials needed for the maintenance and repairs of civilian requisitioned cars has been carried out under extreme difficulties due to the lack of regular suppliers, and efforts have been made in every occasion to maintain these vehicles in operational conditions. It has been the practice at Super Garage to satisfy all requests within the limit of possibilities and I have (in the absence of definite instructions on the subject) endeavored to exercise extreme care and good judgment in determining the order of priority in which each request for repair or maintenance of civilian requisitioned vehicles are to be complied with. However, it is probable that some times our inability to do the impossible might have been misinterpreted by some members of the Commission. If such is the case, I shall be glad to follow any system of priority which may be considered an improvement over our present practice.

7. In view of the vagueness of the verbal orders under which I took charge of Super Garage and in view of an apparent necessity of clarifying and defining the functions of same, I would like to suggest that the Transportation Sub-Commission issue pertinent orders or instructions, so that any doubt or misunderstanding can be dispelled, and the functions of this garage and my responsibilities understood by all.

Approximately 130 civilian vehicles are dispatched from this garage each day. All taxis are dispatched from this garage daily.

All civilian cars being dispatched each morning from S/G will probably bring forth difficulties and will require more of a dispatching staff to make available to HQ & officers, cars at 0800 hours each morning.

It is suggested that if all cars are pooled, that said pool be broken down with distribution of cars to Sub Commissions and that those cars be held in the pool pending approved Transportation request from heads of Sub Commission or Sections.

Transportation request should reach dispatching officer, Super Garage, prior to 1600 hours the day before transportation is needed.

Transportation request for long journey should be made 24 hours in advance to this Disp. office, in order that all arrangements may be completed before departure.

SECURITY MEASURES FOR SUPER GARAGE

The security measures for the Super Garage listed below have been published for all concerned and will be complied with immediately :

1. Guards at garage entrance will be doubly certain :
 - (a) all vehicles are properly dispatched;
 - (b) the Hq NO. and trip ticket compares with vehicle marking or assigned NO. on ACC. windshield sticker.
 - (c) all vehicles are inspected for government property which could be taken from the garage.
 - (d) vehicles not of ACC. origin have pass from M.T.O. (am. or br.).
 - (e) between the hours of 1800 and 0700, a record is kept of every vehicle leaving or entering garage together with time. This compiled record will be kept by the Am. M.T.O.

2. Petrol dispensors, under the Br. M.T.O. will double check:
 - (a) that only official ACC. vehicles receive petrol and driver signs for same.
 - (b) all vehicles not of ACC. origin requesting petrol, are cleared through Br. M.T.O.: or O/iC of garage and permission has been obtained for a designated amount of petrol.The British M.T.O. will be directly responsible for the dispensing of all petrol.

3. Dispatchers, either AM., BR. or civilian, will issue trip tickets only to accredited ACC. drivers or personnel. When in doubt of any driver or vehicle, situation will be reported to M.T.O. (Am.) who will take immediate steps to clarify same.

MEMO.

TO : Col. Carnes, Trnas. S/C.

To date I have not made a report to you on Garage activities and there are a few things I should like to bring to your attention.

The civilian personnel problem was very much confused at first, and after conferring with the Hq. Comd't, I received from him regulations and certain ground rules which I have published and now govern pay, hours and overtime of personnel employed here. This has straightened out some problems, but the pay is not adequate for the mechanics and specialists working here, and I have been assured in the near future that the pay scale will be raised. A large part of my time is spent in supervising the administration necessary to clear this personnel work and have requested I be given a G.I. clerk who knows routine administration to assist me in order that I may spend more time in organization and maintenance of vehicles.

I would also like to suggest a change which I would like to make soon, placing Capt. Mac Phail in charge of all maintenance and dispatching. Lt. White has not been cooperative in the establishment of maintenance charts and records which I had requested be kept. I am convinced that Mac Phail will do a fine job, but will not release Lt. White, until the investigation I spoke to you about previously is brought to a close. This must be climaxed for the good of all.

The daily average of taxis for Hq. has been brought up from thirty to thirty five, upon request of Capt. Birch Transportation officer, and has relieved G.I. vehicles for other uses.

Mr. Ryan has assured me that he will make tire & tubes available, for cars to be assigned, as soon as possible and hope to have three more ready next week. Three are in the shop now being conditioned for future assignment.

The big battery charger with a seventy-five battery capacity, will be repaired shortly, so that expected trouble from run down batteries in the coming cold weather will be handled more expediently.

Two new dual-purpose gas pumps operated by electric or hand, have been installed thus making gasoline available at all times even when the current is off.

British M.T.O. Capt. Hoyle, has a very good organization and is doing a fine job. His main trouble is obtaining spares, and parts not obtainable have been machined or made by civilian workshops.

I am also told that the new Nashs are to be driven by civilians and enlisted drivers to be released. As yet no decision has been made nor have the cars been turned over to me. They should be controlled by one office, and at the present, I have no knowledge of who this may be. Could you possibly clarify this?.

 - g) All Allied Govt. cars, including A.C.C., will be paid for by me in cash to the Lancia cashier out of the cash obtained ~~there~~ (f). As this money will have been debited originally to the Italian Government, all such payments will be made by us with Italian Government money.

- h) I will naturally keep a record of all payments made but I do not think it is necessary to collect the money from A.C.C. and other formations as it all goes against the Italian Government in the end.
- i) I very strongly recommend that this scheme be adopted as it will enable us to keep only one book i.e. a cash book. All other bookkeeping will be done by the present staff of Lancia.
- j) Under this scheme, Lancia will be responsible for all wages, salaries of employees there by again saving us countless hours in making out wages lists etc.

SUBJECT: ACC Transportation Division, HQ. Garage (Piazza Verdi).
TO : Colonel B.L. CLOUGH, Executive Officer, HQ. A.C.C.

1. It has, this date, been agreed that spaces within the above garage are allocated as follows to 2675th Regt. (American) and HQ. ACC (British). All other spaces and facilities will remain under the control and for the use of A.C.C. Transportation Division. It is also agreed that the respective British and American organizations will have full use of and complete control over the spaces allotted to each:

a - For heavy maintenance of trucks and vehicles that cannot be taken up the ramps; for all welding and painting and battery charging the rear portion of Floor II. British to have use of inside bay and American to have outside bay which will also be used for painting and welding work.

1 American 2675th Regt. - Front room
2 British HQ. A.C.C. - Next to front room

d - For washing, greasing and servicing of all vehicles whether British, American or requisitioned civilian vehicles the regular service area along rear of building on Floor II. Transportation Division, A.C.C. to provide all staff personnel for the performing of the work.
The American and British organizations each to provide personnel for supervising and directing the doing of the work on its respective vehicles.

TO : Colonel E.L. CLEUCH, Executive Officer, HQ. A.O.C.

e - For maintenance and service work on vehicles which can be moved on the ramps Floor X or top floor.
1 American organization will use south and east sides including the storage room on the south side.
2 British organization will use north and west side including the storage room on the west side.

f - For storage of vehicles other than trucks and for supply rooms and stock rooms.
1 American organization Floor III
2 British " " Floor IV

g - For outside parking of trucks and performing of first echelon maintenance on trucks the full length of Via Claudia Monteverdi between cross streets - (along south side of garage). Close pavement area to all traffic except A.C.C. vehicles. Leave sidewalk full length along south side and for that length along the shops of the garage open for pedestrians.

h - For inspection of British vehicles the British organization will install a ramp within the parking area "g".
For office space the office room on right side of service area entrance.

i - For gasoline and lubricating oil service the pumps and space in the front of the building Floor II will be used by all vehicles. The gasoline and oils will be provided by and accounted for through Transportation Division, A.C.C. Italian personnel will be provided by Transportation Division for performing the work.
The American and British organizations each to provide personnel for supervising and directing the doing of the work on its respective vehicles.
