Dear Ingegnere Lombardi:

I will ask you to refer to your predecessor's letter No. 4827/S.P. of 9 November 1945 on the question of transfer of certain ex-Allied vehicles from your Ministry to the Ministry of War, for the Italian Army, as agreed with this Headquarters in October 1945.

It is noted in a further letter from Dottore La Malfa dated 27 November 1945, that 153 vehicles, out of the total of several thousand outstanding, had been made available to the Ministry of War. At that date, however, there was still no information as to when the balance, which it was originally agreed should be handed over by your Ministry at the rate of five hundred per month commencing 1 November, would be made available. No reply can be traced to my further request for information on this subject contained in letter AC/62/91/Pa.5 of 15 December.

It is appreciated that this is now primarily a matter for settling between yourself and the Minister of War, who is no doubt most anxious to obtain the balance of the vehicles in question. At the same time the Chief Commissioner, while appreciating your difficulties in the reconditioning of the ex-Allied vehicles, is a little perturbed at the slow rate at which these vehicles are being turned over to the Italian Army.

It is intended, therefore, with a view to examining the present position and the future program as regards handing over the balance of these vehicles to the Ministry of War for the Italian Army, to hold a meeting in this Headquarters on Thursday next 3 January in the small conference room at 1600 hours. It is requested that you will attend, and the Minister of War is also being invited; it is hoped that you will be able to put forward at this meeting a firm acceptable program for the handing over of the balance of the vehicles involved.

Will you please confirm by telephone (AG Extension 376) on Monday 31 December if the above time and date are suitable. If, on the other hand, you are unable to be present at that time and date proposed, will

Reference your 10434/U.R.M. dated 7 Dec 45.

1. You state in paragraph 4 that officials of the Ministry of Transport have indicated verbally that the reconditioned Allied vehicles which are to be handed over to the War Ministry in exchange for the Army vehicles retained by civilians, will have to be paid for by the War Ministry. This is directly contrary to the terms of the agreement proposed by Transportation Sub Commission on behalf of the Ministry of Transport, and agreed by M. E. I. A.

2. You are advised to obtain, as soon as possible, written confirmation from the Ministry of Transport that they undertake to hand over an equivalent tonnage in reconditioned Allied vehicles free of charge to the Italian Army, in accordance with the agreement. Under no circumstances should vehicles be accepted that have not passed a road test. Any difficulty in obtaining confirmation from the Ministry of Transport should be notified to this M. C.

1. - Reference 8272/136/EC dated 21st. November 1945. It would be greatly appreciated if the following points could be clarified: -
 2. - Can organizations holding more than one vehicle retain the entire number or may some be withdrawn and reissued to other firms.
 3. - Can vehicles in possession of political organizations such as C.I.N., partisans, etc. be withdrawn and reissued instead to civilian firms who require trucks.
 4. - Are transfer documents to be filled in by Rome and forwarded to the present operators of vehicles or should documents be filled in at Region and forwarded to Rome for register. 1523
 5. - It is obvious from the lists submitted by this office that organizations or firms holding fleets of trucks will have a very large commercial advantage over competitors by receipt of title to these trucks without charge for same. It is suggested that a more equitable distribution be used.

1. Agreement has been reached between the Ministry of War and the Ministry of Transport; whereby Italian Army Vehicles at present operated by civilians, may be retained by them, subject to an equivalent tonnage of Allied vehicles now being made available to the Italian Government being handed over to the Italian Army .

2. Only such vehicles as have been reported on lists forwarded by you are covered by this agreement. Provided sufficient information, i.e. Targa number, engine and chassis numbers have been furnished; a Transfer Document will be prepared by the War Ministry and delivered to the Ministry of Transport, entitling the present owner to continue to operate the vehicle. Transfer Documents will be issued in respect of vehicles of equivalent tonnage to those which have been received by the Italian Army from the Ministry of Transport. A specimen Transfer Document is attached at Appendix " A " .

3. It is to be clearly understood by all concerned that the lists forwarded by you are final, that no additional vehicle may be added , and that recovery action will be taken by the War Ministry in the case of any other Army vehicles in the possession of civilians .



TO : Chief, Supply Group

1. Attached hereto is copy of letter from the Ministry of Transport dated 27 November 1945, informing the Transportation Sub-Commission that 153 vehicles are now available at Pontedera airport for turn-over to the Italian Ministry of War, and arrangements have already been completed for the Ministry of War to withdraw these vehicles.

2. On the 9th of November the Minister of Transport advised us that the schedule for the delivery of additional vehicles (500 per month until complete turn-over has been completed) would be delayed due to the fact that contractors which were to be engaged for the rehabilitation of these vehicles had asked exorbitant prices for the repair work necessary and consequently the bargaining for the price of repair had greatly retarded putting the work in hand. This was discussed with MMIA. At this time the Minister of Transport is unable to give a firm date regarding the future delivery of additional vehicles. **1520**

3. Due to the fact that the administration of the Italian Army has now been turned back to the Italian Government it is the opinion of this Sub-Commission that future discussions regarding the delivery of vehicles to the Italian Army should be left solely to the Minister of Transport and the Minister of War.

4. This Sub-Commission will continue its endeavour to ensure that the Minister of Transport carries out his obligations to the Ministry of War with the least possible delay. No doubt the Minister of War will also be pressing the matter with the Minister of Transport.

Reference is made to AC/62/62/Tn 5 of 17 Oct and this H.Q. Q/5/10 of 23 Oct.

1. Vehicles listed to date total 1,666.
2. No further communication has yet been received as to when the delivery of equivalent tonnage is to commence.
3. It will be recalled that the equivalent tonnage of the 153 vehicles listed in our Q/5/10 of 31 Aug was to be made first priority. The tonnage was notified as being 525 tons in our Q/5/10 of 24 Oct.
4. You are requested to state:
 - (a) how many Allied vehicles are actually in possession of the Ministry of Transport and where they are at present located.
 - (b) When delivery of the priority 525 tonnage will be made.
 - (c) What arrangements are proposed regarding the balance.
5. It is pointed out that the terms of the agreement proposed in your 540/16/Tn 1 of 7 Oct 45 are reciprocal, that the necessary action has been taken by M.M.I.A. as regards the War Ministry responsibility, but that to date the Ministry of Transport has done nothing more than continually revise their estimate of when Allied vehicles will be made available. A reply is therefore requested not later than 1 Dec, giving the information detailed in paragraph 4.

Dear Doctor La Malfa,

Thank you for your letter of 9 November 1945, (No. 4027/S.P.) referring to the handover of reconditioned vehicles to the Italian Army; the contents of this letter have been communicated to the Military Mission to the Italian Army.

M.M.I.A., while appreciating your difficulties in arranging for the repair of these vehicles, have now requested as follows:

- (a) That the priority promised in Paragraph 5 of your letter be more specifically defined, having regard to the repair facilities available. It is requested that a definite date be now given by you by which the tonnage equivalent of the first 150 vehicles will be available to be handed over, and a firm revised estimate given of what will be the subsequent monthly turnover.
- (b) That the Minister of War's agreement shall be obtained by you to the above, and that you will request him to notify M.M.I.A. in writing of his concurrence.

It is believed that certain of the vehicles you have received from Allied sources have already been allocated by you to the Carabinieri. Will you please confirm if this is the case and, if so, furnish to this office a list of the vehicles so handed over; these would count against the number to be transferred to the Italian Army.

1. In the second week of October an agreement was reached with the Transportation SC to the effect that vehicles received from the Allies would have been put in perfect efficiency and returned to the Italian forces to take the place of those Army vehicles which are now in possession of civilians. The above would have taken place with the following schedule :

a)- the equivalent of 153 vehicles, during the month of October;

b)- 500 vehicles for the month of November and for the months following until completion of the replacement of all the vehicles in question;

2. At the time the question was discussed, the difficulties encountered for the repair were not foreseen. The circumstances which appeared afterwards have proven that the above programme needs be modified, since it is now impossible for me to assure you that delivery will take place on the fixed date; delivery which may take place only many weeks later. It was not possible to give the work to a sufficient number of concerns since very high prices were asked.

The price asked for the repair of the vehicles was superior to the cost of a new one. In this cases the bargaining for convenient price greatly retarded the work.

3. I personally discussed the matter with the ¹⁵⁰⁸ Minister of War, Mr. Jacini, who agrees to await until the vehicles are repaired. Mr. Jacini believes that presently the above mentioned programme is to be preferred to that of trying to have back the original vehicles.

4. The Allied Commission must therefore take note that, the schedule programme considered in paragraph 1 will be inevitably retarded, but on the other hand must rest assured that all will be done to speed up the repair work so that vehicles may be delivered at the earliest, if possible starting next month.

5. Priority will be given to the Italian forces in allocating the repaired vehicles.

1. Area Inspector states minister had issued order that Govt trucks pools to function entirely separately from Ufficio Auto-Transporti but to use AMG/ENAC work tickets provided in blank.

2. Govt truck pools do not propose to be controlled by AMG Ufficio auto trasporti or to contribute 3 per cent operating charge.

3. ISR VERONA and VENICE compartimento have issued instructions concerning operation of ISR trucks for transport of goods by road. It appears that there is no intention that ISR trucks shall come under control of AMG Ufficio Auto Trasporti and therefore they may be impounded by Police under AMG Provincial orders which require that trucks over 1 ton capacity have an AMG work ticket.

4. It does not appear practical or economical to have 3 separate groups of officials directly concerned with road movement. Please advise policy on control and use of Ufficio Auto-Transporti work tickets.



It is therefore incumbent on the holders to provide the information required fully and accurately, and on you to ensure as far as you can that they do so.

3. The means of gathering the information is left to you, but it is suggested that an explanation of the commission and a request for particulars be made the local press.

Transfer of Vehicles to the Italian Army

1. It was agreed with your Sub-Commission in the second week of October that vehicles received from the Allies would be reconditioned and turned over to the Italian Army, in replacement of those Italian Army vehicles now in the possession of private individuals, in accordance with the following program.

- (a) A lift equivalent to that of 152 specified vehicles, starting about 28 October. 1499
- (b) 500 vehicles during November, and each succeeding month till the full number was replaced.

2. At the time when this arrangement was made, it was not anticipated that there would be any great difficulty in undertaking the reconditioning of these vehicles. Subsequent events, however, have shown that the above program will have to be modified, since it is not now possible for us to ensure delivery of the vehicles shown on the dates stated, and the program will be several weeks behind schedule. It has not been possible to get sufficient contractors to undertake the work except at an exorbitant cost, the price which was demanded for repair being more than the vehicles cost now. In these circumstances, negotiations have necessarily been protracted in order to ensure that the work is done at a reasonable cost.

3. The matter has been discussed with the Minister of War, who is perfectly ready to wait until the vehicles can be reconditioned, and who considers that the present scheme, even if necessarily somewhat delayed, is the best that can be devised at present, and infinitely preferable to any attempt to seize the original vehicles.

4. The Allied Commission, therefore, should note that the program mentioned in paragraph 1 will inevitably be delayed, but they may rest assured that every effort is being made to hasten completion of repairs so that the vehicles may be handed over at the earliest possible date. Priority in the allocation of vehicles as they are reconditioned will be given to those vehicles to be turned over to the Italian Army.

5. It should be noted, in conclusion, that the above arrangement is conditioned upon the Allies turning over to the Italian Government the full 30,000 ton lift already agreed; of this lift, some 13,000 tons has been handed over to date.

1. In reply to your 0/5/10 of 19 September 1945, it is noted that you agree, subject to certain conditions, to the principle that the Italian Army shall be reimbursed with vehicles equivalent to those now in the hands of civilian owners, partisans, etc., and that these latter vehicles shall be left in the hands of their present operators.

2. The provisos you mention in Paragraph 2 of your above-quoted letter appear reasonable, but the following comments are made on the various conditions as listed by you:

(a) It is only possible to list those vehicles which are known by A.C./A.M.G. to be in existence. Particulars are now being collected, and a complete list of all such known vehicles will be forwarded to you as soon as possible. There will no doubt be other Italian Army vehicles of which there is no record, and it is understood that you realize this fact and accept this position. For your advance information, the figures so far available are as follows:

(b) It is understood that this condition refers to two lists of vehicles, totalling 41 vehicles as follows:

(1) 31 vehicles, said to be nearing completion in workshops in Turin on 15 August, and mentioned in your letter 0/5/10 of 15 August, 1945, to AFHQ (not to AICOM). Regional Transportation Officer, Piemonte Region, has now been instructed to freeze these vehicles if they are still in the factory, or to trace their present whereabouts if they have been issued, in either case so that they may be handed over to the Italian Army as requested.

(2) 10 vehicles, particulars of which were given in your O/S/10 of 25 August to AFM, copy sent to this Headquarters under case reference of 3 September. With regard to these 10 vehicles, instructions are being sent to the Regional Commissioner, Piemonte Region, directing him to arrange delivery forthwith to the MSIA, I.O. at Turin as requested by you.

(c) Agreed. No comment. Instructions are being sent accordingly to the Regional Commissioners concerned.

(d) The arrangements which have already been made for the hand-over of 10 vehicles to the Italian Government do not include any for the hand-over of spare parts. An additional number of vehicles, however, is being handed over for cannibalisation and consequent production of spare parts. Other spare parts may be handed over if they are declared surplus from theatre stocks.

The same arrangements as above will apply in the case of ex 10 vehicles transferred by the Ministry of Transport to the Italian Army, and it is understood that these arrangements will satisfy your condition (d).

(e) It is understood that this condition refers to a total of 153 vehicles, as listed by you in your letter O/S/10 of 31 August addressed to Chief Commissioner. It is agreed that an equivalent number of vehicles, making up the same tonnage as is represented by those 153 vehicles, will be turned over forthwith to the Italian Army, as soon as the necessary arrangements can be made; it is estimated that this will take about two weeks from the date of this letter. With regard to your desire that these vehicles should be turned over as first priority from reconstructed vehicles, this is being taken up with the Italian Ministry of Transport, who is now responsible for allocation.

(f) Program of delivery dates of vehicles and spare parts (or vehicles for cannibalisation) will be forwarded to you as soon as possible. Meanwhile, a preliminary discussion has taken place between this Sub-Commission and the Minister of Transport; the latter has agreed in principle to the scheme which you have accepted with the reservations noted.

Vehicles ex-allied sources are now being handed over to the Italian Government, starting 21 September 1945, and representing a 20,000 to 30,000 ton lift. It is anticipated that this turn-over will be completed by 31 October. Vehicles must be reconditioned after handing over and the speed with which this can be carried out

is a limiting factor. If such reconditioning is not carried out, vehicles can be handed over to the Italian Army as fast as they are taken over from the Allies. As reconditioned vehicles have been promised, however, it is not possible to quote a firm figure of more than 500 reconditioned vehicles a month starting 1 November 1945. If the Italian Army is prepared to assist in reconditioning vehicles, some three times this number of vehicles requiring reconditioning could be handed over in addition. It is hoped in practice that the figure of 500 reconditioned vehicles per month can in fact be improved upon.

3. Will you please confirm that you are in agreement with the above.

SUBJECT: Return of Italian Army M.P.

TO : Land Forces Sub-Commission, A.C. (MIA)

1. Reference your letter 9/5/10 dated 8 October 1945.

2. Reference your para. 1 (a), it has been ascertained that these vehicles are now being released by air stores to Captain O'Donnell, MIA, reference signal 3736, dated 27 September 1945.

Reference your para. 1 (b), every effort will be made by the Transportation Sub-Commission, Roads Division to have the 153 vehicles delivered as quickly as possible.

Reference your para. 1 (c), our agreement to deliver 500 vehicles per month, fully reconditioned, was based on the estimated capacity of Italian Ministry of Transport workshops, and civilian workshops under contract. Before saying that this figure may be increased, the matter must be discussed further with the responsible Italian authorities.

Reference your para. 2 (a), lists of Italian Army vehicles now being operated by MIA are in the course of preparation and will be forwarded to MIA not later than 17 October 1945.

Your para. 2 (b) and (c) are agreed.

3. Due to the fact that Doctor La Malfa, the Italian Minister of Transport, has been absent from Rome for the past few days and is not expected to return until Wednesday, 17 October 1945, it has been impossible for the Transportation Sub-Commission, Roads Division to settle all details. However, a meeting has been arranged with the Minister of Transport for 18 October, at which time final details will be discussed and agreed. You will be advised accordingly. It is the considered opinion of Transportation Sub-Commission, Roads Division that delivery of vehicles can commence by 20 October 1945.

Reference your letter 540/16/Tn of 7 October.

1. Your letter is agreed with the following exceptions:
 - a. Your para 2 (b) (I) - It has now been ascertained the exact figure is 33. However, we are advised that settlement is now being made in regard to the 33 vehicles.
 - b. Your para 2 (e) - Since the use of Italian Army vehicles was and is on first priority by AMG, it must be insisted that replacement of equivalent tonnage for the 153 vehicles must be also on first priority. Your letter does not specify this and leaves the decision with the Italian Ministry of Transport, thereby forcing the Italian Army to deal with that agency. We must have categorical assurance that the 153 vehicles will be replaced on first priority, and I feel it is only just and equitable that you should order the Minister of Transport to agree to this. There should be no difficulty in the provision of such a relatively small number of vehicles by the Ministry of Transport. Moreover, you will note that MMIA is prepared to ask for first priority for only the original figure of 153 instead of the figure 237 of which ~~the details now available~~ 'details now available' as shown in para 2 of your 540/16 Tnl of 7 Oct.
 - c. Your para 2 (f) - The vehicles transferred to the Army must be fully reconditioned. Such workshops and repair organizations as we have are fully engaged.
2. In order to clarify the matter and prevent seizure of Italian Army vehicles left in the hands of civilians, the following procedure should be followed:
 - a. Lists of vehicles to be delivered to MMIA by AC, as soon as possible as a matter of urgency. 1482
 - b. Vehicles covering equivalent tonnage are then released by Ministry of Transport to Italian Army, whereupon
 - c. Italian Army delivers to Ministry of Transport a document covering the vehicle which has been replaced. This document must be for each individual vehicle, so that it can accompany the vehicle left in civilian hands.
3. As this discussion has been going on for nearly 3 weeks and as AFHQ are pressing me for a report on its development, I must ask that you now agree to the 'compromise' stated in your letter 540/16/Tn of 7 Oct., as amended by my remarks above. I will then inform AFHQ and my Staff both in Rome and outstations accordingly.

SUBJECT: Return of Italian Army M.T.

TO : Land Forces Sub-Commission (M.M.I.A.)

1. In reply to your Q/5/10 of 19 September 1945, it is noted that you agree, subject to certain conditions, to the principle that the Italian Army shall be reimbursed with vehicles equivalent to those now in the hands of civilian owners, partisans, etc., and that these latter vehicles shall be left in the hands of their present operators.

2. The provisos you mention in Paragraph 2 of your above-quoted letter appear reasonable, but the following comments are made on the various conditions as listed by you:

(a) It is only possible to list those vehicles which are known by A.C./A.M.G. to be in existence. Particulars are now being collected, and a complete list of all such known vehicles will be forwarded to you as soon as possible. There will no doubt be other Italian Army vehicles of which there is no record, and it is understood that you realize this fact and accept this position. For your advance information, the figures so far available are as follows:

(b) It is understood that this condition refers to two lists of vehicles, totalling 41 vehicles as follows:

With regard to your desire that these vehicles should be turned over as first priority from reconstructed vehicles, this is being taken up with the Italian Ministry of Transport, who is now responsible for allocation.

(f) Program of delivery dates of vehicles and spare parts (encl 30) vehicles for cannibalization) will be forwarded to you as soon as possible. Meanwhile, a preliminary discussion has taken place between this Sub-Commission and the Minister of Transport; the latter has agreed in principle to the scheme which you have accepted with the reservations noted.

Vehicles ex-Allied sources are now being handed over to the Italian Government, starting 21 September 1945, and representing a 20,000 to 30,000 ton lift. It is anticipated that this turn-over will be completed by 31 October. Vehicles must be reconditioned after handing over and the speed with which this can be carried out

is a limiting factor. If such reconditioning is not carried out, vehicles can be handed over to the Italian Army as fast as they are taken over from the Allies. It is hoped in practice that the figure of 500 reconditioned vehicles per month can in fact be improved upon.

1. In reply to your O/5/10 of 19 September 1945, it is noted that you agree, subject to certain conditions, to the principle that the Italian Army shall be reimbursed with vehicles equivalent to those now in the hands of civilian owners, partisans, etc., and that these latter vehicles shall be left in the hands of their present operators.

2. The provisos you mention in Paragraph 2 of your above-quoted letter appear reasonable, but the following comments are made on the various conditions as listed by you:

(a) It is only possible to list these vehicles which are known by A.C./A.M.C. to be in existence. Particulars are now being collected, and a complete list of all such known vehicles will be forwarded to you as soon as possible. There will no doubt be other Italian Army vehicles of which there is no record, and it is understood that you realize this fact and accept this position. 1. AMHQ Admin Memo No. 5 dated 11 April 45 reads as follows:-

II - TITLE TO ITALIAN ARMY VEHICLES

The title to vehicles of the Italian Armed Forces falls into two categories as follows:-

1. Vehicles captured by the Allied Armies prior to the Armistice with Italy. These vehicles have become spoils of war and remain the property of the Allied Military Authorities who have discretion to allot them as they see fit in accordance with existing instructions covering captured enemy material.

2. All other vehicles of the Italian Armed Forces.

a. These remain the property of the Italian Government as outlined in AMHQ Circulars Number 13, and Number 29, 1944.

b. This transport should be used to the maximum benefit of the Italian nation as a whole, bearing in mind the calls made by Headquarters AC on the resources of the Allied Armies to meet essential civilian requirements.

c. The allocation of this transport in accordance with paragraph b above will be made as follows:

Italian Army vehicles by the Land Forces Sub Commission AC (MFA). Italian Air Force vehicles by the Air Force Sub-Commission AC. Italian Navy vehicles by the Navy Sub-Commission AC. Transport surplus to the minimum needs of the Italian Armed Forces which is desired for civilian use by Headquarters AC will be allotted to civilian use by the appropriate Sub-Commission, AC title thereto and operation thereof being by the Italian Armed Forces under the control of the appropriate Sub-Commission, AC.

d. The Italian Armed Forces will exert every effort to locate and acquire vehicles still undisclosed. Allied Authorities will give every assistance possible to the Italian Authorities and to the respective Sub-Commissions AC. Any vehicles coming into the possession of the Allied Authorities will be reported to the appropriate Sub Commission, AC for disposal.

2. Many hundreds of Italian Army vehicles were found in the north immediately after liberation and were rightly at once put to the maximum benefit of the Italian economy as a whole by Army AMG and Regional Commissioners. Many, if not the majority, were found to be in the possession of Partisans, or CIs and were being used by them to distribute food, to move refugees, and sundry other purposes. The AMG Authorities permitted this to continue. Had they not done so the internal economy in N. Italy would have broken down.
3. Land Forces Sub-Commission have always taken the line that they had no objection to the use of these vehicles for state purposes but they resisted retention by individuals for purposes of private gain and they rightly insisted on the registration of such vehicles as Italian Army vehicles in order that the title of the Italian Army to them could be maintained. They in fact insisted on 2 (c), i.e. making the allocation of this transport themselves. This, they state, has not been done, and they claim that many hundreds of vehicles are being held by individuals and groups, with the tacit and sometimes patent approval of AMG and Italian authorities, and are being used for private gain. They demand the immediate return of these vehicles to the Italian Army and ask for AMG assistance in so doing.
4. On paper their claim is incontestable and there is no doubt that they have been resisted - at any rate by the Italian authorities in the North. Exception to the claim can be made in regard to the use of the vehicles by Displaced Persons, who have moved many IPW in the trucks and thereby can claim that they are in the service of the civil government. It can also be argued that the Partisan Cooperative and other pool organizations which use these trucks are in the service of the civil government in that they are necessary for the economy of Italy.
5. However that may be we have to face the realities. Is it politic at this stage to withdraw these trucks from the possession of their present owners - realizing that in many cases it will have to be done by force and that it has already been turned into a political issue in Turin. Sig. Parri clearly thinks it would not be politic and the Transportation Sub-Commission (Mr. Franklin) agrees.
6. An alternative has been found - suggested by the Minister of Transport. He proposes to make an offer to the Minister of War whereby these vehicles be left under the Ministry of Transport and left by them in the possession of those now operating them. The Ministry of Transport in return will hand over to the Ministry of War for the Italian Army an equivalent tonnage list from Allied W.D. vehicles which he is now receiving from the Allies and which are turned over reconditioned, and, as I am advised, in a better state generally than the vehicles in question.

7. Transportation Sub-Commission regards this as an equitable compromise - one in fact which would be to the advantage of the Italian Army and which would avoid a great deal of discontent and possibly some bloodshed in the north.

SUBJECT: Italian Army Vehicles

19 Sept. 1945

TO : Executive Commissioner.

1. Reference conversation Brigadier Lush/Mr. Franklin, 18 September, on the above subject.

2. The matter has already been discussed by this Sub-Commission with the Italian Ministry of Transport, and it has been suggested that an agreement along the following lines should be entered into between the Italian Ministry of Transport and the Italian Ministry of War. The Italian Army vehicles which are now in the possession of individuals, e.g., partisans, should be left with the present operators. The Italian Ministry of Transport would then reimburse the Italian Army with vehicles which are now in the process of being turned over by the Allies to the Italian Government. It may be advisable to point out that, if this agreement can be made firm, the Italian Army would gain in the long run, as the vehicles which are being turned over by the Allies are all being reconditioned and being put in first-class shape by the ISR and various Italian motor manufacturing firms.

3. There appears to be only one alternative, namely, that the Italian Government should publish a decree ordering individuals now in possession of Italian Army equipment (vehicles) to hand over such property to the rightful owners, e.g., the Italian Army. The equipment so handed over would then be replaced by the Italian Ministry of Transport with vehicles ex Allied military stocks which are now being disposed of direct to the Italian Government.

4. Of the two possible alternatives outlined above, the first is unquestionably recommended for the following reasons: It is considered that any attempt to remove the vehicles now in possession of their present operators will only result in the vehicles going underground, and may well cause incidents which are better avoided. The Italian Army, in these circumstances, would be the losers, and the Italian Ministry of Transport would still have to make an allocation of new vehicles to enable the Italian Army to carry out its functions. Also, such a forced withdrawal might tend to turn the present operators against the Italian Army, an attitude that might have political repercussions.

5. It should be noted that AFHQ's original order for the hand-over of Italian Army vehicles clearly stated that such transport should be used to the best economy of the country as a whole, and it is therefore suggested that a very short view of the transport situation in Italy as a whole is being taken by MMIA.

6. It may also be pointed out that it is one thing to publish an order or a directive, and another thing to enforce it. If MMIA insist on the enforcement of this order, it will be necessary for them to provide the personnel, as AG as a whole, and Transportation Sub-Commission in particular, are in no position to furnish the necessary personnel for the enforcement of the order.

Reference your Memo of 19 Sep to Chief Commissioner on the above ⁴subject.

1. Your attention is invited to the last A.F.H.Q. instructions on the subject (AFHQ file AG 451/227 GCT-0 of 31 August 1945), which is not quoted in your memo to the Chief Commissioner.

2. In view of your representations regarding the political situation and the good faith of the officers concerned, which are accepted, the alternative suggestion contained in your para 6 is agreed under the following conditions:-

- (a) An exact certified list of all Italian Army vehicles now in the hands of civilians, showing vehicle data in full, will be furnished for transmittal to the War Ministry.
- (b) Vehicles requisitioned or removed from factories (CEM) by AMG, will be returned forthwith, and no further requisitions will be made. For these vehicles no substitutes of W.D. vehicles will be accepted, as A.F.H.Q. have directed that these vehicles will be turned over to the Italian Army.
- (c) No further Italian Army vehicles to the list furnished in sub-para (a) above will be seized, accepted, licensed, or used by AC/AMG or any of its agents, affiliates, organizations, or pools.
- (d) A suitable proportion of spares for the W.D. vehicles handed over will also be handed over to the Italian Army.
- (e) Immediate delivery of W.D. vehicles, and spares, in lieu of vehicles now known to be in the hands of civilians.
- (f) A definite statement of the date of delivery of vehicles and spares in lieu of the vehicles shown on the list to be submitted under sub para (a) above, be furnished.

1. Your attention is invited to the last A.F.H.Q. instructions on the subject (AFHQ file AG 451/227 GCI-0 of 31 August 1945), which is not quoted in your memo to the Chief Commissioner.

2. In view of your representations regarding the political situation and the good faith of the officers concerned, which are accepted, the alternative suggestion contained in your para 6 is agreed under the following conditions:-

- (a) An exact certified list of all Italian Army vehicles now in the hands of civilians, showing vehicle data in full, will be furnished for transmittal to the War Ministry.
- (b) Vehicles requisitioned or removed from factories (CMM) by AMG, will be returned forthwith, and no further requisitions will be made. For these vehicles no substitutes of W.D. vehicles will be accepted, as A.F.H.Q. have directed that these vehicles will be turned over to the Italian Army.
- (c) No further Italian Army vehicles to the list furnished in sub-para (a) above will be seized, accepted, licensed, or used by AC/AMG or any of its agents, affiliates, organizations, or pools.
- (d) A suitable proportion of spares for the W.D. vehicles handed over will also be handed over to the Italian Army.
- (e) Immediate delivery of W.D. vehicles, and spares, in lieu of vehicles now known to be in the hands of civilians.
- (f) A definite statement of the date of delivery of vehicles and spares in lieu of the vehicles shown on the list to be submitted under sub para (a) above, be furnished.

as you know, Italian military authority has been asked by the Allied Authorities to recover all the vehicles which used to belong to the fascist army forces. Strong action is being taken to recover these cars, by establishing road-blocks among other things.

This has nevertheless very harmful consequences for various regions; in certain places, it disorganizes essential services, such as food or sanitary transports; it greatly prejudices workers groups and cooperatives, formed on purpose for the use of vehicles. In many cases, these cooperatives are formed of ex-soldiers, ex-prisoners, ex-partisans, that is to say of categories of workers which it is of great interest not to have unemployed.

I appeal to you, my dear Admiral, who show such comprehension for our economic difficulties, and beg you to intervene with the military organs of the Allied Commission, and perhaps also with A.F.H.C., to obtain they should no longer order the recuperation of all the vehicles which formerly belonged to the fascist armed forces.

To my mind, for what concerns the above mentioned vehicles, the Italian authority should make an exact ascertainment of the ownership which would remain without discussion to the military administrations entitled to it; but it should allow the vehicles to be left at the disposal of the workers which are at present using them, in a useful way, for themselves and for the public.

I can assure you that the Ministers of the Armed Forces, that I consulted, entirely agree with me on this matter.

In North Italy, a similar situation has occurred for vehicles owned by the Germans, taken as booty, and of which part is in the hands of cooperatives or ex-partisans. I heard that these cooperative use these vehicles in a most useful and well administered way. If these vehicles were taken from the ex-partisans to which they give employment and a way of making a living, there might be causes of serious discontent and unrest, especially in Turin and Milan.

I trust that your intervention, my dear Admiral, may obtain the wished for result, which would mean an important contribution to our internal transport requirements and our efforts to fight unemployment in this critical moment.

SUBJECT : Italian Military Vehicles.

TO : VP Economic Section.

1. You are probably aware that during the period June 1944 and following months, AMG Region IV entered into certain contracts with motor firms in and around Rome, the general effect of which was that the firms concerned were to salvage and repair a number of military vehicles originally the property of the Italian Army but abandoned by the Germans in their retreat from Rome and lying in the countryside in a derelict condition.

2. Substantially the terms of these contracts were that the firms should advance a sum of money as a guarantee for the value of the derelict vehicles; that when the vehicles had been repaired, property in them should pass to the firms concerned who would undertake to retain them for a period of approximately one year and to use them during that period for civilian transport requirements. When this property passed to the firms the money which was originally put up as a guarantee fund became payable as the purchase price. When the firms in fact repaired the vehicles, AMG Region IV wrote various letters to appropriate Italian authorities giving instructions for the vehicles to be registered in the name of the firms.

3. It is undoubtedly true that in negotiating these contracts AMG Region IV was acting in contravention of instructions issued by SAC to the effect that all military property which had been the property of the Italian Army before the 8th of September 1943 should remain the property of the Italian Army.

4. Nevertheless, it will be appreciated that the effect of these contracts, however improperly made, must be considered under the provisions of Italian law. This Commission has obtained the advice of expert Italian lawyers whose opinion is that under Article 1153 of the Civil Code, the property in these vehicles passed to the firms, notwithstanding the fact that the Allied Military Government had no title to sell them, provided that the firms acted in good faith and believed that AMG was in a position

to pass a good title. In view of the fact that the firms could not be expected to have knowledge of the order of the SAC and might reasonably infer that AMG was taking possession of these vehicles by virtue of their rights under the Hague Convention, it appears difficult to argue that they were not acting in good faith.

5. However that may be, the question of the right to the vehicles is a matter of Italian law which can only be determined by the Italian Courts. The firms concerned are all situated in Italian Government territory, and are not in any way within the jurisdiction of the Allied Military Government.

6. Notwithstanding these facts, Transportation sub-Commission has written several letters to the firms concerned of which copies are attached which in effect order the firms to deliver the vehicles to the Italian military authorities.

7. A petition has been addressed to the Allied Commission against these letters. The petition alleges that the orders are illegal since the Allied Commission has no jurisdiction to issue these orders and it further alleges that in fact the firms have good title to these vehicles. 1445

8. It appears to the legal advisers of this Commission that the petition is well founded so far as concerns the legality of the orders and that so far as concerns the title to the vehicles this is not a matter in which this Commission should intervene on one side or the other.

9. It appears that the legal aspect of the situation has not been fully appreciated by those concerned and it is requested that the peremptory orders issued by the Transportation sub-Commission be withdrawn pending a further consideration of this matter by the Chief Commissioner.

At the present time there are 47 tires stored at the above mentioned motor vehicle park belonging to this organization. 3. You will notify Major Hall, MMIA, as to the location of the Italian Military vehicles which have not been rebuilt by firms now holding these vehicles. As soon as MMIA has collected these vehicles you will be notified at which time you will make a separate roster of these vehicles as they have been turned in by the firms now holding them.

4. PRINCIPLES TO BE APPLIED

a. Allied Naval, Ground and Air Forces Responsibilities - Enemy Naval and Air Forces material will be dealt with and the necessary reports and returns made by the Allied Naval and Air Forces respectively, subject to such convenient adjustments as may be necessary to deal with cases where the enemy Naval and Air Services do not correspond in their scope with the Allied Naval and Air Services. Enemy Ground Forces material will be dealt with by the Allied Ground Forces and coordination, where necessary, between the Allied Naval, Ground and Air Forces will be effected by the Ground Forces Commanders. The latter in the appropriate cases, must be prepared to assist Allied Naval and Air Forces Commanders in the location and guarding of materail peculiar to the enemy Naval and Air Forces. Common user items will normally be the responsibility of the Allied Ground Forces.

b. Allied Ground Forces Staff and Service Responsibilities for safeguarding and control - The responsibility for the taking over (or the collection where necessary) and the safeguarding of all enemy Ground Forces war material is placed upon the Commanding Generals of Fifth and Eighth Armies, Headquarters 1 and 2 Districts, and Commanding General Peninsular Base Section in their respective areas. This responsibility will be exercised through the normal Allied Staff and technical service channels appropriate to type of material concerned. It is desired that the arrangements made by Armies be such that continuity of management when headquarters of 1 and 2 Districts and Peninsular Base Section take over Armies' areas in Northern ITALY.

5. CONTROLLING AUTHORITIES AT AFHQ - The control of enemy materials will be exercised by AFHQ through normal command and technical channels appropriate to the material concerned.

6. CLASSIFICATION AND WITHDRAWAL -

a. Enemy Ground Forces war material will be classified into categories by the authorities designated below. Notes amplifying classification and withdrawals are at Appendix "A" to this directive.

Initially such reports will be in broad terms and special efforts will be made to ensure the fullest possible reports on material which is significant for maintenance of POW or Allied troops including redeployment operations. In addition to the inventories called for above, addressees will as of the 15th of each month designate such material as in excess of their requirements. The first report of excesses will be as of 15 July 1945.

b. No special reports are required in connection with materiel which is not repairable. It should be rendered innocuous (where necessary) and turned over to Allied military salvage organisations.

c. As of the 15th of each month (commencing with 15 June 1945) to reach this headquarters by the 28th of the same month addressees will report the following information in respect of all captured general purpose (B) vehicles showing vehicles of Italian make separately.

- (1) Numbers and types organised into car/truck companies, held by units within establishments, or otherwise.
- (2) Numbers and types handed over to other agencies.
- (3) Numbers and types awaiting issue.
- (4) Numbers and types awaiting repair.

8. PRIORITIES FOR TAKING OVER AND COLLECTION

a. Material will be taken over (or collected where necessary) in the following order:

- (1) Category 1.
- (2) Category 2.
- (3) Category 3.

The channel of transaction in material of Italian origin which is to be returned to the Italian military authorities will be MIA. Receipt for material so handed over will be taken by the issuing Allied Services and forwarded to this headquarters through normal channels. All remaining recaptured Italian war material will be reported to AFHQ and disposal instructions awaited.

d. War material of US, British, Russian, or French Origin

(1) It will be the policy for material of US or British origin recovered from the enemy by recapture or surrender to be turned over to the American or British services normally responsible for the class of material concerned.

(2) It will be the policy to return to the Russian and French authorities all material which was formally the property of the Russian and French Governments. Pending further instructions all material that is apparently of Russian and French ownership will be segregated and reported to this HQ.

e. War Factories and War Factory Production - The policies contained in letter, this headquarters, file AC 388.5/87 GEG-6, dated 11 Feb 1945, subject: "Policy on Italian Munitions Production" will apply.

f. Ammunition

1440

(1) Attention is drawn to current instructions on the handling of enemy ammunition.

(2) Ammunition of German manufacture if in category 3 and in original containers will be centralized in a few selected parks under arrangements to be made by the addressees. German transport and personnel will be used for this purpose under Allied supervision.

(3) Small quantities of loose ammunition in unguarded dumps which constitute a hazard to life or property will, under arrangements to be made by MMIA, be reported by Carabinieri to the Italian Ministry of War. MMIA will authorize the destruction by the Italian Ministry of War without reference to this headquarters of all such small quantities of German or Italian ammunition. Explosives will, if not available in the dumps, be demanded by MMIA from Armies, Districts, or Base Section.

(4) Small Dumps of German and Italian ammunition (other than that in Category 3 in original containers) of 500 tons or less will be destroyed by the most suitable means by German personnel under Allied supervision. German technical units may be formed for this purpose. If practicable the brass will be recovered and be returned through Allied Army Salvage organisations.

(5) Larger Dumps of German and Italian ammunition in excess of 500 tons will be placed under guard, their contents reported and disposal instructions awaited.

(6) Nothing in these instructions is to be regarded in any way as restricting the authority of addressees to destroy ammunition in any quantity which is in a dangerous condition or constitutes a hazard to internal security, utilising German personnel, under Allied supervision, for the work.

g. Animals

(1) It is expected that a large proportion of enemy-held animals will disappear before Allied control becomes effective. The remainder will be classified and where possible Mallein-tested and Preston-branded from numbers allotted to Armies by this headquarters.

(2) Animals required for the maintenance of surrendered German forces will remain under German care and supervision.

(3) Animals in Categories 2 and 3 will be moved as soon as possible into Allied animal collecting centres. Separate instructions will be issued on this subject.

(4) The remainder will be handed over to the appropriate authority.

f. Ammunition

- (1) Attention is drawn to current instructions on the handling of enemy ammunition.
- (2) Ammunition of German manufacture if in category 3 and in original containers will be centralized in a few selected parks under arrangements to be made by the addressees. German transport and personnel will be used for this purpose under Allied supervision.
- (3) Small quantities of loose ammunition in unguarded dumps which constitute a hazard to life or property will, under arrangements to be made by MMIA, be reported by Carabinieri to the Italian Ministry of War. - (6) Nothing in these instructions is to be regarded in any way as restricting the authority of addressees to destroy ammunition in any quantity which is in a dangerous condition or constitutes a hazard to internal security, utilizing German personnel, under Allied supervision, for the work.

g. Animals

- (1) It is expected that a large proportion of enemy-held animals will disappear before Allied control becomes effective. The remainder will be classified and where possible Mallein-tested and Preston-branded from numbers allotted to Armies by this headquarters.
- (2) Animals required for the maintenance of surrendered German forces will remain under German care and supervision.
- (3) Animals in Categories 2 and 3 will be moved as soon as possible into Allied animal collecting centres. Separate instructions will be issued on this subject.
- (4) The remainder will be handed over on temporary loan to civil authorities by AMG who will obtain receipts.
- h. War Material alienated by the Enemy - Any alienation of war material by the enemy, out of the ordinary course of army administration (for example, materials which may have been sold to the civilians in anticipation of surrender) entered into within three months before the date of surrender shall be provisionally regarded as voidable, and, if required, the material so alienated will be summarily recovered.
 - (i) Repairs to Enemy Material - Except on instructions from this HQ, no attempt will be made to repair enemy material other than that categorised in Categories 1 and 2, but category 3 material will be preserved to the extent of being put in grease and under cover where appropriate. With the exception of Category 1, enemy material may be modified as required for abnormal uses.

j. Passenger and Load-Carrying Vehicles

- (1) To allow for the maintenance of enemy forces and in order to save Allied transport, car and truck companies of German make, by types, will be formed. Whenever practicable, however, such vehicles will not be issued without workshop inspection and never without WD numbers and full registration.
- (2) The issue of enemy vehicles to existing Allied units will be permitted only in cases where such units have deficiencies in their TEs (WES).
- (3) Italian Army vehicles captured after the armistice with Italy will be dealt with in accordance with Section II, AFHQ Circular Number 5, 1945, and returned to the appropriate Italian authorities through MMIA. All other captured Italian vehicles whether requisitioned or not will be turned over to Allied Commission. Italian vehicles are defined as vehicles of Italian make. Italian military vehicles can usually be identified by the R-E on the dashboard or instrument panel. If doubt arises as to whether a vehicle of Italian make is a civilian or military vehicle, such vehicle will be turned over to MMIA who will determine the ownership and subsequent allocation in conjunction with Allied Commission. Receipts for all vehicles handed over to Allied Commission or MMIA will be obtained. As the retention of vehicles of Italian make against deficiencies in unit establishments is, at present, authorized, the ultimate hand-over to Allied Commission or MMIA of such vehicles may be postponed until further orders are issued by this headquarters. Every effort will be made to hand-over to MMIA all stocks of spare parts including tyres for Italian military vehicles which are marked with R-E or are otherwise identifiable as having been the property of the Italian Ministry of War. Stocks of spares for Italian civilian vehicles will similarly be handed over to Allied Commission or in doubtful cases to MMIA. Sufficient spares may be retained for such Italian vehicles as are held against deficiencies in unit establishments. Addressees will not normally be responsible for repairing vehicles of Italian make before they are handed over to Allied Commission or MMIA. The responsibility for insuring the proper registration of, and the provision of drivers for all vehicles handed over to them will be that of Allied Commission or MMIA as the case may be.

k. Captured Civilian Material

- (1) Captured material, which is not required for military purposes including maintenance of POW, which is apparently of a civil character and of Italian origin will be turned over to Allied Commission or AMG as appropriate, who will investigate ownership and authorize its return to its owners under such financial arrangements as may be appropriate. Material of this character, the ownership of which cannot be determined, will be disposed of by sale or otherwise as Allied Commission may determine. Proceeds of sales will be deposited in the Allied Finance Agency under Allied Commission direction and held pending further instructions from CCS.
- (2) Captured German civil material which is not required by the controlling service at this headquarters will be turned over to Allied Commission for disposal as above.
- (3) Captured civil material, which is of neither German or Italian origin will be reported to this headquarters and disposal instructions awaited.
1. (Salvage Scrap) - Unrepairable enemy ground forces war material for which there is no further use, will be regarded as salvage (scrap) and will be dealt with in accordance with existing procedures.

k. Captured Civilian Material

(1) Captured material, which is not required for military purposes including maintenance of POW, which is apparently of a civil character and of Italian origin will be turned over to Allied Commission or AMG as appropriate, who will investigate ownership and authorize its return to its owners under such financial arrangements as may be appropriate. Material of this character, the ownership of which cannot be determined, will be disposed of by sale or otherwise as Allied Commission may determine. Proceeds of sales will be deposited in the Allied Finance Agency under Allied Commission direction and held pending further instructions from CCS.

(2) Captured German civil material which is not required by the controlling service at this headquarters will be turned over to Allied Commission for disposal as above.

(3) Captured civil material, which is of neither German or Italian origin will be reported to this headquarters and disposal instructions awaited.

1. (Salvage Scrap) - Unrepairable enemy ground forces war material for which there is no further use, will be regarded as salvage (scrap) and will be dealt with in accordance with existing procedures.

NOTES ON CLASSIFICATION AND WITHDRAWAL OF ENEMY MATERIAL.

1. CATEGORY 1 MATERIAL. AFHQ will be responsible for indicating to addressees (by means of a list or through liaison officers) what material is to be placed in Category 1 and where it is to be consigned. Material thus placed in Category 1 is not available for any purpose. AFHQ is responsible for maintaining records of all material withdrawn under their authority.
2. CATEGORY 2 MATERIAL. Addressees, subject only to limitation in 1 above, will place any material which they need or likely to need in Category 2. They will maintain simple records of all Category 2 material which they authorize to be withdrawn (e.g. copies of the documents authorizing depots to make issue). Addressees will not prepare consolidated returns of material thus used until ordered by this HQ.
3. CATEGORY 3 MATERIAL. A list of Category 3 material which may be required for the FAR EAST is attached at Appendix "B". Addressees will locate such material and report the quantities held to this headquarters. Such inventories must be accurate and the material so reported must be frozen. AFHQ will declare how much of this material is to be placed in Category 3. AFHQ will be responsible for issuing disposal instructions and maintaining the records of withdrawals of Category 3 material.
4. CATEGORY 4 MATERIAL. If the policy in connection with the equipping of liberated armies is enunciated during the period this headquarters will issue a list of material that might be required under Category 4. The procedures will then be as for Category 3 material in paragraph 3 above.
5. CATEGORY 5 MATERIAL.
 - a. Material which must be destroyed for any reason e.g. perished foodstuffs, dangerous ammunition, will be placed in Category 5 by the addressees and destroyed. Simple records in broad terms of material which has been thus destroyed should be maintained by the addressees (e.g. a copy of the authorization to destroy the material). No returns of such destructions are required from the addressees until ordered by this headquarters.
 - b. All stocks of Toxic Gases will be placed in Category 5 and if practicable segregated under normal safety precautions. The approximate tonnages by types of fillings and locations will be reported to this HQ, which will then give disposal instructions. Isolated stocks of less than 100 tons may be destroyed by any suitable means if such destruction will help to reduce guarding, transportation, or any other problem.
