These two permits have been submitted to us by the firm Rotti Silvano of Rome, Via Eustachio Manfred attached to his request for the substitution for a definite italian permit.

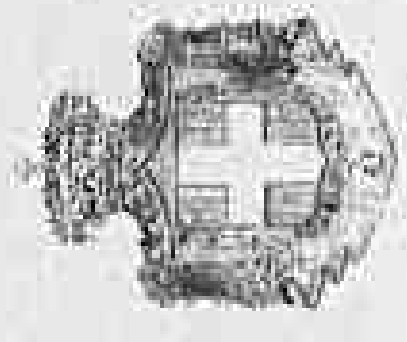
We recall Allied Commission's attention to the fact that the second permit, although made out to a different person from the one that has requested the legalization of the two tires mentioned, regards the same vehicle for whom the new permit is requested, whereas for the first permit authorizing the use of five tires, the legalization is requested only for one tire (i.e. Good Year 600x16 - W 57 S 8748) and not only does it reflect a different person, but also a different vehicle from the one mentioned in the request for legalization .
