Any permit issued against these tires should be invalidated and regularization compelled under existing instructions.



Reference your AC/331/TNS of 18 April concerning tire permits (attached) ostensibly released by Comitato Provinciale, UNRRA, Milan.

Investigation revealed Agent releasing permits had no authority whatever to authorize the use of allied tires and took advantage of his position in the Comitato Provinciale to employ UNRRA letter head and stamp as validation for an illegal transaction.

Permits which I am returning have no legal status and should not be recognized as valid for the issuance of final Italian permits.

UNRRA Protective Service is taking action with regard to individuals implicated.

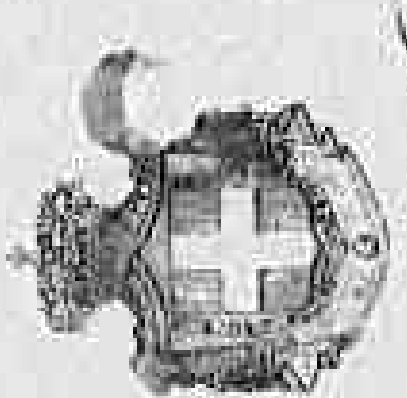

1°) On 23th February 1945 this Board was granted by the A.M.G. (Lazio Umbria Region-Motor Transportation Division) authorization to use Allied tyres (see enclosed copy).

2°) The tyres specified in the authorization were supplied by Lt. Comdr. John Schlee, Head of the Hemp Control Office (Industry S/c) having jurisdiction over this Board. The said tyres were mounted on a Lancia Aprilia car (registered, Rome 79991), which had been requisitioned by the A.C. (and registered with No: 2072) for service in connection with the Hemp Control Office and this Board, to replace the Italian tyres on the car at the time of requisition, which since then had become so worn as to be of no further use.
