1. Attached please find copy of Notification Note No. 122 of 26 May 1945 transferring to I.C.S. 10 tons of clothing and 40 tons of comforters imported from America.

2. The following are the disposition instructions given on these items:

A. 10 DWT of clothing now in Warehouse 676 will be collected by I.C.S. and taken to Warehouse 1254 where it is requested a complete inventory be made. When this inventory is complete a plan for distribution will be arranged between the Ministry and this Sub-Commission. It is also requested that all steps possible be taken to safeguard this clothing from theft or other loss.

B. 40 DWT comforters will be reiled to Leghorn to be stored for use in the North when needs in that area have been surveyed.

1. I have a record that Pfc. Farretti went to Port Salvage on Feb. 7th to inspect some paper sent back to the Port by "Ordnance". Evidently he asked for it to be sent to N. 1550.
2. The 41 packages were sent to Depot 1550 on February 8th, according to the truck tickets, 2 tickets being marked "AMG paper" and the 3rd "Tobacco Paper".
3. No paper is missing from any A.C. consignment on any ship prior to the relevant date, except that some paper Tog 97 appears to be short on the "Grant Wood". This is as far back as my records go.
4. I do not know from the samples whose paper this is. Further identification, such as markings, is essential for recognition.

1. The Tobacco Factory at S.S. Apostoli Naples notified this office on the 13 Mar 45 having received from the Naples Warehouse 38 packages of tissue paper in sheets 96 x 76 cm as per samples "A" & "B" enclosed.

2. As this paper is obviously not suitable for cigarette making and had presumably been delivered in error, this Sub-Commission wrote on the 19 Mar 45 to the State Monopoly with the object of obtaining the following information:

- a) date the 38 packages were received.
- b) whether received direct from warehouse or from steamer
- c) pecking marks and TOG number.

A translation of the reply from the State Monopoly is enclosed, together with sample marked "C" of the quality of paper-bag paper also received.

3. This paper is for the time being held at AC disposal. Would you please ascertain as to whom this paper should be consigned and what has happened to the Cigarette Paper which should presumably have been delivered.

The Manifattura Tabacchi of Naples SS Apostoli has informed us that it is impossible for them to give us the requested data. Said Manifattura was able to give us the following information :

- Pages 38*
- 1) The 38 packages of tissue paper were consigned between 5/8 Feb 45
 - 2) The delivery was made by personnel having no knowledge of Italian and left no document, so that it has been impossible to ascertain the origin of items. The Manifattura, however, retains that the supply was made directly from the port.
 - 3) It is not possible to read the marks and TOG numbers of packages in question owing to the bad state in which the packages were delivered, 5 of which arrived torn, mixed up and wet with sea water.
 - 4) Together with the 38 packages of tissue paper, also three ~~6070~~ delivered (for paper bags) as per sample enclosed.

We are awaiting the decision of this Sub-Commission regarding the use of the tissue paper and the substitution of other paper inreels for the manufacture of cigarettes.
