

1. On 15-16 May 45, 10 trucks of the 6 BSD - RASC were dispatched from Alcom Port Warehouse, Ancona, to the Federation of Consorzi Agrari Forli. They were loaded with lard in wooden barrels; of 420 lbs. each and metal containers of 421 lbs. each. The number of each truck of this convoy with numbers of barrels and weight for each truck as follows:

2. These trucks were never received at the premises of the Federazione Consorzi Agrari, Forli, the no. 2 AC/AMG Supply Dept, Forli.

3. On checking with you the lard stock at your depot, the undersigned officer called to your attention the fact that all drums and barrels had the unmistakable sign of AC Goods.

4. It was agreed that such lard, at present in your depot, would be withdrawn immediately, and it was also understood, that through your headquarters the amount of lard that had been issued by you from this lot would be restored from your stores. It is requested that, if possible, this difference be returned from your stores in Ancona directly to ALCOM Port Warehouse, Ancona.

SUBJECT: Lard at Forli

Our General Warehouses in Ancona wrote us under date of 18/7 as per attached copy. From this, as from copy of letter 6/7 from 1st. Lt. Lester, also attached, it can be seen that 25,200 Kg. of lard dispatched from our Ancona warehouses to our Forli depot in 10 vehicles of the 6th British Supply Depot, Royal Army Service Corps. were consigned erroneously to the 16 D.I.D. of Forli; it is evident that the 16 D.I.D. of Forli, notwithstanding the letter of Lt. Lester, has not arranged for restitution of the lard.

We should be very much obliged if your Sub-Commission would take the matter up with a view to restitution of the lard, as our depot to which it was dispatched is now closed, it could be taken over by the Cons. Agrario Provinciale of Forli and held at disposal of the Food S/C for transference to the provinces in which it is to be distributed.

We await your answer on this subject;

Following communication from our Depot at Forli that these trucks had not reached their destination and made the necessary investigations which resulted as follows:

1. All the lard a/m loaded here was unloaded at Forli at 16 D.I.D.
2. This was ascertained by 1st Lt. (QMC Gard) Lester who also brought to our attention that the lard in the 16 DID warehouse had the unmistakable cable sign of A.C.
3. This quantity erroneously received by 16 DID must be returned.

Will you please expedite from the Allied Authorities the return of the lard (which has not been done so far) and if you deem it opportune, give instructions to the Depot at Forli, or to others, to effect the withdrawal.



SUBJECT : Warehouses - CESENA and FORLI'

TO : Port & Warehouse Division, Transportation Sub-Commission.

1. Reference your W/15/508/Tn 6 dated 17 March '45.
2. The question of increased rail allotment on line 86, North of Ancona, for the purpose of stocking warehouses, was discussed with representative of G-4 (Mov & Tn), AFHQ., on 16 March '45.
3. Increase in rail lift cannot be made until movement period commencing 2 April, when it is certain we shall be given a minimum of 500 tons per day. This will quickly clear any outstanding balance for Forli and will permit a rapid build-up at Cesena.
4. No more road transport can be made available.
5. If Cesena and Forli warehouses can handle more than 500 tons per day between them, every effort will be made to obtain the maximum lift required. Please advise tonnage which can (a) be loaded in Ancona and (b) cleared by warehouses at destinations.

1. Reference your 650/9/Tn 1, dated 17th February, 1945.
2. Signals have been despatched to all concerned clarifying the position regarding warehouses at Forli.
3. Arrangements are being made for Capt. Boyd, now in charge of the Ancona warehouse, to cover the warehouse at Forli. It is now proposed to send forward at least one N.C.O. to be permanently at Forli to understudy the Road Head Detachment now controlling the Forli warehouse.
4. 15th Army Group are being advised through Transportation North West Planning Section of warehouse requirements at Parma.

SUBJECT: Forli Stock Pile.

TO : H.Q. 15th Army Group,
Civil Affairs Section.

1. Reference AMG 8th Army's letter CA/180, dated 15th February, 1945.

2. Every effort has been made by this H.Q. to obtain a minimum allocation of rail movement for 250 tons per day of supplies from Ancona to Forli. High military priorities have prevented this movement during recent weeks. The possibility of this movement being allocated in the near future exists, but AFHQ will only agree to this allocation provided that the bid is made through 8th Army. It is understood that 8th Army refuse to accept this bid because they claim inadequate warehouse space exists at Forli for the reception of these supplies. This matter has been discussed with you (conversation Stewart/Sieff refers) and no further action is being taken by this H.Q. pending results of your efforts. G-5, AFHQ, have been put in the picture.

3. Should, however, warehouse capacity be made available, and the rail allocations still be inadequate, it would be possible for H.Q. A.C. to make available temporarily two platoons for road haulage from Ancona to Forli. This should produce a lift of 100 tons per day. It is felt that it should be possible to find staging areas somewhere between Ancona and Forli to enable this transport to move. Para 3 of AMG 8th Army's CA/180 refers.

4. Arrangements are being put in hand for the control of the stock pile to be handed over to Emilia Region. An H.Q.C. is being attached to the Road Head Detachment at the Consorzio Agrario warehouses immediately as AMG 8th Army suggest.

5. A request has been made through movement and transportation channels that rail sidings to the Consorzio Agrario warehouses and the stove factory, which it is hoped will

be allocated to Allied Commission for stock piling, be connected up. Once this work is completed the amount of M.T. required to clear from the rail head to the warehouses would be negligible. It is suggested that such M.T. as is required should be left behind by 1000 G.T. Company in the initial stages.

6. Finally, providing an adequate stock pile is built up at Forli, should north-west and north-east break at the same time, or should north-east break before the north-west, then the stock pile will be available for feeding into the north-east.
