Port Report

Licata, Sicily

Brief Physical Description

This harbor is formed by three moles, namely, Molo di Ponente, Molo di Levante and Riga Isolata.
Please note attached plan (Exh "A")

Depths

At the present time the use of the harbor is impractically nullified on account of silt accumulations in the entrance channel between the outer mole and the mouth of the harbor between the terminals of the east and west moles. Please refer to Exh. "B" attached hereto, (plan of the port with depth soundings taken in 1935) The pencilled markings thereon at the entrance to the harbor indicate the main silt deposits, where the pre-war depths has diminished from approximately 20ft. to 15ft, creating an impediment to the movement of larger vessels. There is a silt deposit of approximately 3 ft. over the bottom of the remainder of the harbor with additional accumulations alongside the main wharf at Molo di Levante. Also, approximately 300 ton of stone was thrown from this dock by the invasion forces.

The river Salso discharges immediately to the east of this harbor, and carries large quantities of silt, which is washed into the entrance channel.

This harbor was dredged each month previous to the war. Attached are Exh "C", "D", "E" and "F" (pre-invasion air reconnaissance photos), indicating the following:-

- Exh "C" - Photo of harbor (note silt from River Salso to the east of Molo di Levante).
- Exh "D" - Photo east of harbor showing River Salso discharging silt.
- Exh "E" - Photo west of harbor (a considerable quantity of silt is also washed into harbor through westerly entrance). *b.40*
- Exh "F" - Two long range photos of harbor in which silt flow is discernable.

Computations made by a local Italian engineer for the

Port Captain indicate that from 200 to 250 thousand cubic metres silt require removal to restore original depths. The bottom of the harbor is sand and mud with the exception of the 300 ton of stone alongside Molo di Levante.

Pre-War Exports

Licata was the principal port for the exportation of sulphur from Sicily. Other items were grain, beans and cotton.

Total pre-war exports amounted to 150,000 tons per annum.

Pre-War Imports

Coal, timber and phosphates. Total pre-war imports amounted to 100,000 tons per annum.

Pre-War Shipping Traffic

Approximately 150-170 steamers called at this port.

The present traffic is reduced to a few schooners and fishing boats.

Weather

Harbor is well sheltered, but during very bad weather, accompanied by strong S/W wind, vessels alongside Molo di Levante must move away from the quay.

Wharfage

The main wharf is alongside Molo di Levante - Length 870 ft. Steamers used 775 ft. and schooners utilized the remaining 95 ft.

Electricity

3 phase, AC., 50 cycle, 150/260 volts, at present out of operating condition.

Water

No piped supply available at quay, but a small water tank barge is available.

Oil & Coal bunkers

Stevedore Gear

Cargo worked with ships' appliances. An adequate supply of stevedore gear is available, owned by the stevedore firm of Silvio Errante, Licata.

SUBJECT : Dredging of Licata.
TO : G-4 (Mov & Tn) A.F.H.Q.

1. The port of Licata is silting up, and the general depth is now only 16 feet. It is essential that this port is kept open for the import of phosphate rock and export of Sulphur.

2. Application is therefore made for dredging to be carried out. Particulars are as follows :

- A. The port consists of a small harbour.
- B. Quantity to be dredged is approximately 200,000 cubic meters. Bottom is sand and mud.
- C. Present depth 16 feet. Required depth 21 feet.
