1. Reference your W/10/91/TN6 of 18 January 1945.
2. We have had the figures as manifested checked and find them in order except Corned Beef Hash which should be 7,289 cases and not 7,309. This however accounts for only 20 cases of the shortage.
3. When this boat was loaded all stock despatched was checked both at the warehouse and at the dock and the work was under the personal supervision of Capt. Perry. It is believed that the merchandise manifested all actually went on the ship.
4. The bad condition of the packages is agreed; Capt. Perry wrote a report at the time pointing this out. This stock was taken over from I.B.S. when they left the Island and was generally in poor condition.
