

1. There is a bridge across the Piave at Vidor in the Province of Treviso that is impassable by reason of a damaged span.
2. There is a project already in hand for its rebuilding, but it is a four months' job.
3. 13 Corps are willing to put in a Bailey but A.F.H.Q. authority is required.
4. The Vidor link is an essential one to the civil economy of the district. The Piave will be impassable for many miles once the winter floods come.
5. Please be good enough to back this, our request to A.F.H.Q.

1. Ref. your 078/6/PWU of 13th June re the above are enclosed draft project for S.Lorenzo bridge in the city of Trento L.25.000.000.
2. This bridge is not essential for long distance military or civil traffic but is one of the main bridge of the town essential for normal internal traffic and is recommended by the Provincial Commissioner.
3. A local firm having the necessary material for the foundation work is prepared to make a start on this so as to complete it before the winter.

A.C.2 for this will be presented as soon as the project is approved in principle.

4. If the draft design is approved a detailed design on these lines will be prepared and the contract for the main portion of the bridge put out to competition.

SUBJECT: Initiation of Works - Bridges.
FILE No: RXII/PWU/400

1. It is felt that some clarification on the subject of Bridge reconstruction on Roads, other than State Highways, is necessary and will be helpful to Provincial Commissioners.
2. Public Works, as represented by the Regional Engineer, are responsible for the processing and approval of projects, and the supervision of the actual construction work, but are not in a position to judge which works are necessary for the essential services such as Transportation, Food Supply, and other Public Services in a Province.
3. It therefore falls to the Provincial Commissioner to consider the needs of his Province, and it is suggested that he calls the Genio Civile to attend a Conference with himself and his officers, to discuss which bridges are important and necessary to reconstruct, for the internal communications of the Province.
4. When this has been done, the Genio Civile should be instructed to prepare projects and submit them without delay through normal channels to this office.
5. It is pointed out, that all bridge projects irrespective of cost, must be approved through the Regional Engineer, this being an exception to the normal "under 200,000 Lire" rule.
6. In coming to these decisions, the following points should be kept in mind:
 - 1) Lack of materials such as cement and steel being a big handicap, the Genio Civile must be instructed to use materials available from local resources.
 - 2) The approach of winter and its floods, makes the time factor one of first importance, and there are four possibilities in planning.
 - (a) Bridges which can be properly and permanently reconstructed or repaired before the winter sets in.

- (b) Bridges to which (a) does not apply, but which can be made serviceable by temporary works.
 - (c) Bridges where neither (a) or (b) applies, and which are nevertheless essential, should be referred to the Regional Engineer for advice and assistance.
 - (d) Bridges which are not meantime essential, but have collapsed into a waterway causing obstruction to flood-waters. On these the Genio Civile should be instructed to submit projects for the removal of debris and the demolition necessary for future reconstruction.
- 3) Some Bridge works may be necessary in order to permit navigation of canals.

7. If R.C.'s would proceed on these lines without delay, every effort will be made by this office to speed up approval and have work begin quickly.
