SUBJECT: Additional Road Maintenance.

TO : Chief Commissioner, ACC, APO 394.
(Attn: Lt. Col. Thompson, Public Works and Utilities
Sub-Commission.)

1. The following roads are presently considered as military high-ways and must be maintained:

a. Route 7, from Capua to R.J. (6115240).

This is a first priority route, 2 lane asphalt pavement. Civilian crews are now working between Capua and Terracina but additional crews are needed all along the route.

b. Route 714 from Capua to Route 722, Route 722 to Route 724 and Route 724 to junction with Route 7.

This is a first priority route of water bound macadam. Additional crews needed.

c. Route 7, Maddaloni to Arienzo.

A first priority route requiring asphalt patching.

d. Route 721 from Santa Maria to Route 7B.

A water bound macadam road recently topped and oiled requiring a small maintenance crew. 2nd priority.

e. Routes 8718, 8718A, B and C.

These are water bound macadam roads of second priority requiring regular maintenance crews.

f. Route 716 from Aversa to Route 714.

A second priority route of water bound macadam, requiring one or two maintenance crews.

28 June 1944

g. Route 719 from Route 7 near Maddaloni to Route 7 East of Santa Maria.

A 3rd priority route of water bound macadam requiring regular maintenance.

h. Route 718 from Maddaloni to Route 87.

A 3rd priority route of water bound macadam recently resurfaced and oiled, requires regular maintenance.

i. Route 717 from Canello to Maddaloni.

A 3rd priority road of water bound macadam requiring constant patching, for British ambulance traffic.

2. Maintenance of the above listed routes is now the responsibility of the 98th Engineer Regiment, who are authorized to contact you or your representatives, directly, in order to expedite arrangements for the necessary maintenance, with a maximum use of civilian contractors and labor.

1. On 21 June Col.D.S. Burns, Engineer Officer P.B.S. called with reference to the above road. He stated that repairs were needed immediately to certain sections.

2. Finding that you were not immediately available, I made a personal inspection of this road. In general conditions were found to be fairly good, but I believe it advisable to instruct the contractor place a maintenance crew there immediately, with particular attention being given to the water bound macadam section near the Naples end. Our records reflect that V.Savarese has a maintenance contract but no activities were observed at the time of my visit.

Subject: Repair and Maintenance of Military Highways
by Civil Organisation (AASS)

To : Regional Engineer Region III CONFIDENTIAL

1. After a brief experience as a field Engineer concerned with the repair and maintenance of important Military Highways within Salerno Province, I am forced to certain conclusions regarding the Civil Organisation responsible for this work which I wish to bring to your notice.

(a) That the existing AASS personnel are incompetent, or deliberately non-cooperative.

(b) That certain Contractors employed by AASS - notably ALFREDO SENIA and MARIO DEL RESE- are on their present showing incapable of good and expeditious work.

2. In support of the opinions expressed in 1 (a), and 1 (b) above many specific cases could be given, but in general terms the contractors completely ignore instructions given to them on the methods of working to be employed and on the number of men it is considered necessary for the economic performance of the work. Repeated requests, and indeed latterly, instructions given to AASS Ing. Scalera and his assistants have despite their assurances that immediate remedial measures would be taken, proved completely negative. In this connection it is of note that AASS personnel do not supervise the work being so ill-performed by certain of their contractors, but remain in the office at Salerno.

3. The situation which has been briefly described above caused me to have a frank discussion on the entire matter with Sig. Grauso, Ispettore Generale, Genio Civile, and it is noteworthy that he too strongly deplures the existing conditions and agrees entirely with the opinions I have expressed in para 1(a) and (b), and also with the recommendations I shall make in para 4 of this letter. In fact Sig. Grauso expressed keen satisfaction when I announced my intention of reporting the state of affairs to a higher level of ACC authority.

- 4 . In view of the foregoing it is strongly urged that:
- (a) AASS Ing. Scalera and his assistants be transferred to some sphere of duty more suitable to their exhibited standard of competence.
 - (b) That the present contracts held by Contractors SENIA and DEL MESE for Road repair work be terminated and new contracts let to suitable contractors.

At 1700 hrs on 5th June 1944, reports were received that heavy rain had caused damage to the above mentioned route. Investigation revealed that Culvert No 251 at CONSILINA was completely blocked and 30 yards of road covered to a depth of 15" by earth and stones swept down the mountainside by the rain.

The local Cantonieri (LONGO SALVATORE, Centre No 19) was contacted at the Cantone office at SALA CONSILINA and he was asked to provide assistance in clearing the road. He stated however, that he was not interested and would not assist in any way.

The necessary work was accordingly carried out entirely by WD labour.

It will be appreciated if this matter can be taken up through ACC channels and instructions issued to AASS representatives to assist the WD in emergency road repairs at all times.

SUBJECT: Report on Autostada Curbing

TO : Lt. Col. V.S. THOMPSON R.C.E.

1. Accompanied by Ing. Reggiani of Genio Civile, this writer today made a survey of the damaged and missing curbing along the Autostrada with a view to determine the extent of existing damage.

2. The portion of the Autostrada surveyed begins at the turn-off near the end of the elevated portion in the vicinity of the city line on the East side of Naples, and continues to the Castellammare turn-off on the Western edge of Pompei.

3. The speedometer reading and the extent of missing or irreparably damaged curbing, expressed in feet, follow. Measurements for the South curb begin at the Western end of the examined portion. Those for the North curb begin at the Pompei or Eastern end and continue toward Naples.





B. This contract will run for 90 days from date of signing same. As of this date, £ 150,000 has been expended towards the fulfillment of this contract. The maintenance situation is up to requirements except additional work on drainage remains uncompleted but in progress.

2. A 90 day completion contract was awarded 16 Feb 44 to Carola Vincenzo, Via Fiorelli 5, Naples in the amount of £ 4,000,000 by Genio Civile, covering the Naples end of the Autostrada. Some work has been accomplished and is progressing. However, this stretch is not now being used by the Military and need not be included in our summaries for the present.

The stretch of road (State Highway No 7Bis) between Naples and Avellino, is subjected to very intensive and heavy Military traffic, and deteriorates day by day for lack of adequate Maintenance. The concrete paved stretches with single or double layer, present more than one spot deep holes that slow and make traffic dangerous. For the patching of such holes is necessary that at least 100 Qli. of high grade cement be provided to be consigned to Cantoniere Monti Gerardo, resident at Marigliano.

As you know the durability of these pavements depends from the perfect preservation of the expansion joints, that should be filled with hot bituminous mastic. For the execution of such work are required at least 30 bbls of bitumen having a high penetration at 25° from 120 to 150 The bitumens of lower penetration are not satisfactory for this type of work.

The bituminous materials should also be consigned to the above named Cantoniere.

It is also necessary to provide for the patching along the RR crossings at Km. 35+780, Km. 36+140, Km. 46+575 and Km. 50+765 by spreading a layer of crushed stone from the quarries of Schiava.

For each of said crossings are needed 5 to 8 cu. meters of crushed stone. The last stretch, there is between Cemitle and Avellino lacks completely of small stone and bitumen. Actually the maintenance of this stretch is done by skillful workers employed by the 105 CCRE using dry materials, of lowest grade, from the quarries of Schiava.
