1. We have received several complaints from District 3 that they have been unable to contact you on several occasions. They feel that this is entirely unsatisfactory.

2. Will you please arrange to have someone at your office at all times who can take telephone messages and pass them on to you or other officers as required, so that you may contact people calling in when you are absent.

3. We had considerable difficulty ourselves in getting you when needed on the telephone when we were at Naples and I can readily understand the above complaint. However, everything possible must be done to prevent a recurrence, even if you have to engage an Italian civilian who speaks English for the purpose of answering telephone calls when you are absent.
