SUBJECT: Receiving Reports, I.C.E.

TO : Col. H. C. Quartier, GMC
Supply and Property Officer

1. Reference your visit to Finance Sub-Commission relative to procedure in issuance of receiving reports to I.C.E. for action of the Finance Sub-Commission.
2. In the past and in accordance with instructions received from the Finance Sub-Commission, the following procedure has been in effect:
 - a. Materials received in transports and warehouses were receipted for by a representative of the Public Works & Utilities Sub-Commission. In some instances these receipts were I.C.E. receiving reports.
 - b. The equipment or materials issued were receipted from memorandum receipts and receiving reports which were to be submitted to I.C.E.
 - c. I.C.E. in turn issued a receiving report to the Highway Equipment Section indicating they had accepted the responsibility for the monetary transaction; copies were sent to Finance Sub-Commission.
3. At the time this policy was clarified numerous requests had been received from I.C.E. for signature to receiving reports which their Rome office had issued for materials and equipment received by this office. In conversations with the Finance Sub-Commission, it was brought out that should receiving reports be a second time receipted that there was a possibility that I.C.E. would take credit for items two times and, therefore, payment would not be made for the same to twice the amount actually involved.
4. An example of such possibilities is indicated in the attached letter and receiving report from I.C.E. This transaction covers the matter of 150 batteries which were received at the port of Livorno by this Headquarters. Receiving report for this material was given at that time by the Transportation Liaison Officer at Livorno and we took possession by signing standard invoice and release. Since I.C.E. in Livorno had already been given one receiving report covering this consignment of batteries, the object in asking for a second receipt for the same shipment

was questioned. It will be noted that a receiving report does not identify the shipment in any way and that it would be possible for I.C.E. to show that Public Works and Utilities had received 300 batteries instead of 150 batteries, as actually was the case. In this transaction the batteries were received by this Headquarters, disposed of to contractors and Genio Civile, the prices indicated by Commerce Sub-Commission, and the funds so collected turned over to the Purchases and Contracts Section of the Finance Sub-Commission; therefore, since the batteries were sold and the money credited to the agency authorized to collect, the transaction should end with I.C.E. having a port receipt for 150 batteries, the Commerce Sub-Commission clearing their records by issuing orders, and this Office clear their obligation by having receipted invoiced and accounts.

5. This has occurred in a number of cases and so far, on the advice of the Finance Sub-Commission, we have ignored such requests after notifying I.C.E. of the indicated procedure. Should we issue receiving reports covering materials and equipment as indicated by your verbal instructions of last week, we shall be issuing receiving reports for many of these items twice. It is requested that the matter be clarified in all respects and this Office be given written instructions of the proper procedure.

2. During the coming winter, certain of the roads listed in Appendix 'A' to the above-cited letter will be liable to blocking by snow.
3. Formations, Districts and Base Sections will take appropriate action to establish, where necessary, snow clearance arrangements for all those roads which it is laid down will be maintained to the standard "All Weather".

That the Requisition No. 180-ENG for machinery and transport be filled in its entirety and a supplementary requisition prepared and filled to take care of the added territory and changed conditions since the time of the original requisition. The urgent necessity of more transport was agreed to by all. The original 170 dump trucks is entirely inadequate even if they are all made available. So far we have received none.

(c). That an adequate stock of spare parts be made available for all equipment and transport.

1. Please be advised that PWS is removing its Busp Truck Company and all other military personnel off Route 1 south of Livorno on or about 15 June 1945.
2. The responsibility for the maintenance of Route 1 from Livorno to Km. 41.5 will be entirely in the hands of the civilians. This is broken down as follows: Special Genio Civile, Firenze has from Livorno to Km. 121.5 and Genio Civile, Rome (Sign. Rota) from Km. 121.5 to Km. 41.5.
3. The operation of all rock quarries necessary to the maintenance of this road will be operated by the above mentioned Genio Civile. The rock quarry at Grosseto (Giuncarico) is a matter of controversy but will probably be turned over at the same time.

1. Request is made to have a unit of Italian troops attached to the Public Works and Utilities Sub-Commission. This unit should number approximately 300 officers and men who will be trained to service, maintain, and operate the heavy road and construction equipment now being received from the United States.
2. About 4000 tons of road equipment valued at several million dollars was requisitioned originally about a year ago but revision and cancellations reduced this somewhat. The equipment includes rock crushing plants primary and secondary, air compressors with rock drill and other attachments, asphalt mixing plants, concrete mixers, motorized road graders, scrapers, tractors, trailers, trucks, and other accessory equipment. Some of this equipment is now here and more arriving. 4. It is believed that by the assignment of an Italian military construction or mechanical service unit to this duty, these difficulties will be eliminated. They would not be used as ordinary labor; such laborers can be recruited in the locality in which the equipment operates. 1. At your request Requisition No. AC-ENG-95-45 covering import requirements of construction has been referred to the Ministry of Public Works for review and further justification. Engineer Regiani has today reported the results of review which information is outlined below :

2. The Ministry of Public Works in making their initial estimate of import requirements included extensive quantities of all types of heavy construction equipment as well as smaller items as covered by subject requisition. When this estimate was submitted to the Italian Government reviewing committee on imports it was soon realized that available credits would not permit the inclusion of items of such magnitude. It was then decided that the list be reduced to small power units (electrical and gasoline) and the compressors with the long-term plan being based on the use these items in both construction and in connection with the rehabilitation of all available heavy equipment. Considerable quantities of such items as stone crushers, concrete mixers, cranes, hoists, etc. remain in Italy at present but cannot be put to use due to the critical electrical situation. Electrogenrating sets will reactivate this equipment gasoline motors are critically short with small prospects of any new manufacture in the near future. These motors will be used in repair shops, carpenter shops, building and bridge reconstruction, quarry operation etc. The most critical need for air compressors is in connection with bridge and building demolition and quarry operation. The estimate of the above items is based on (a) known destruction figures (b) number of active construction Companies (c) number of workmen estimated as necessary in reconstruction (d) quantities of similar equipment available before the war, (e) miles of State provincial and communal roads to be maintained.

3. In our opinion the estimated requirements are not excessive.
